We would like to thank you for your cooperation in the re-examination of your crochet animal hats last week by the Advisory Committee of Street Artists and Crafts Examiners. We appreciate your taking time away from your work to participate in this rescreening.

At the screening meeting on September 26, 2013, Advisory Committee members examined your inventory of raw materials, unfinished and finished hats and timed and observed you making 2 crochet hats (pink animal hat and white skeleton). The Advisory Committee determined that the style and quality of the hats you created did not match the style and quality of the hats you had been selling as shown in photographs taken of your display on the street. An excerpt from the minutes taken by the Advisory Committee state that "Artist is cautioned to remove all hats depicted in the photographs... Overall hat depth, size of stitch, eye style, eyebrow depth, web overlays and yarn colors differ between samples and photos."

We would like to remind you that you are approved to sell crochet animal hats that you make yourself. Please remember that you cannot sell your wife's crochet animal hats.

The Advisory Committee will be monitoring closely. If you are found selling crochet animal hats that do not match the style of the hats that you have shown, you will be notified for a hearing to consider suspending your certificate.

We have included photos from your screening of what you showed the Advisory Committee for your records.





any such appeal must be filed within fifteen (15) days from the date of the Program Director's decision.
