## MEETING MINUTES - WEDNESDAY, MARCH 23, 2022

## REMOTE MEETING VIA ZOOM

#### (1) SPECIAL ITEM

Consideration and possible adoption of a resolution which makes findings to allow teleconferenced meetings under California Government Code Section 54953(e).

ACTION: Upon motion by Commissioner Honda, the Board voted 3-0-2 (Commissioner Lopez Commissioner Chang absent) to adopt the resolution.

#### SPEAKERS:

Charles Rathbone stated that taxi medallions are valuable assets, and he advised the Board to be mindful of that fact when being asked to take these medallions away from the elderly and disabled medallion holders.

Marcelo Fonseca stated that social justice requires that the medallion holders be allowed to keep their permits. He further stated that it was unfair what the City had done to the taxi industry for the past ten years.

Carl Macmurdo discussed the 9<sup>th</sup> Circuit *Sloan* appeal and SFMTA Resolution No. 09-138 and how the Resolution impacts Prop. K medallion holders. He further talked about Transportation Code Section 1118 which he believes enables the SFMTA to take back medallions in violation of the ADA.

Robert Cesana spoke about the medallion sales program that was implemented by the SFMTA for disabled drivers and drivers over 60 years of age.

Evelyn Poquez, President and Owner of Alliance Cab, spoke about the revocation of taxi medallions belonging to elderly and disabled taxi drivers.
