Whereas in the past, mother cats and kittens less than two months old were captured from the wild, brought to the shelter, then returned to the wild (mother cats) or adopted (kittens). The new policy is to allow mothers and kittens to stay in the wild, until the kittens are weaned. Virginia Donohue, Director Animal Care and Control, will present.
