SUBJECT: Summary of Appealed Future Employment Restrictions Placed by SFMTA

Attached for your review is the bi-annual summary report of future employment restrictions placed by the San Francisco Municipal Transportation Agency (SFMTA) for July 1, 2012 through December 31, 2012.

The total number of employees dismissed in July 1, 2012 through December 31, 2012 is 16. Of those, the number of SFMTA future employment restrictions that were appealed to the Commission was 1 (pending). The number of appeals where restrictions were reduced or rescinded by the SFMTA was 0. And, the number of appeals, where after restrictions were amended or the restrictions removed, were withdrawn or closed as administratively resolved was 0.
