2. Update and Discussion Regarding the Introduced Revisions to Chapter 14B and the Legislative Process

- a. Jennifer Johnston provided the committee an update.
 - i. The legislation will be formally assigned to the Rules Committee on Tuesday, September 7th.
 - ii. Legislation is currently the same as it was since it was proposed.
- b. Public Comment
 - i. Ali Altaha asked why the construction management LBE certification does not need a construction management state license required and if the proposed Chapter 14B legislation will address this.
 1. Chair Galarza clarified this isn't related to this action item and will need to be discussed in a future, more focused conversation.
