In San Francisco, Mayor London Breed has issued a Shelter in Place order, directing residents to stay home except to get food, care for a relative or friend, get necessary healthcare, or go to an essential job. ## Supporting Our Community

The Coronavirus pandemic has had a huge impact on workers and businesses in our neighborhoods. We have now been given the opportunity to rethink where and how we are investing into our community. Take this opportunity to build up local small businesses and women-owned business that create our community. Mayor London Breed has announced

San Francisco Women Against Rape (SF WAR) provides resources, support, advocacy and education to strengthen the work of all individuals, and communities in San Francisco that are responding to, healing from, and struggling to end sexual violence. SFWAR is a women of color led, volunteer-based organization that has provided rape crisis services to survivors of sexual assault for over 30 years. SFWAR is one of our Gender-Based Violence Grantees and we are proud to support them in the work they do. The Office of Sexual Harassment and Assault Response and Prevention (SHARP Office) at the San Francisco Human Rights Commission works to ensure that city government agencies are responsive to the needs of survivors. They collaborate with City Departments, law enforcement agencies, and community organizations. Website: <https://sf-hrc.org/sharp> .

The Department on the Status of Women has been working in conjunction with the Alliance for Girls, the Women's Building, and the SHARP Office to end sexual harassment and violence against women on public transit. A regional campaign was set to launch in April, however has now been put on hold. The collaborative is currently focused on maintaining relationships with transit agencies around the Bay Area to continue this work when possible.



## Child Abuse Awareness Month

April is also Child Abuse Prevention Month. While the rates of child abuse in San Francisco have decreased in recent years, even one child being abused is one too many. We want to highlight a few collaborations we are part of on this topic below:

works to prevent and address child abuse through our Family Violence Council (FVC), a public body consisting of governmental and non-governmental agencies. The FVC works to address domestic violence, elder abuse, and child abuse and is chaired by three community-based organizations: the Domestic Violence Consortium, the Institute on Aging, and Safe & Sound. Safe & Sound is a child abuse prevention organization that provides direct services to children and families, advocates around policies and programs, and collaborates with government and nonprofit agencies. Many people do not know that child sexual exploitation can be considered both a form of human trafficking as well as a form of child abuse. At the Department on the Status of Women, one of the ways we work to address the exploitation of youth and children in the commercial sex industries is through the SF SOL Project. The SF SOL Project was created by a \$9.3 million grant from the California Department of Social Services and is a collaboration of San Francisco government and nonprofit agencies led by the Department on the Status of Women. The project is a new pilot that provides housing options and other services to youth who have been exploited. If the pilot goes well, it could be replicated statewide. [More information here.](#)
