

Family Violence Council Report



The Family Violence Council released its 9th report on Family Violence in San Francisco in June, which includes data about the prevalence of abuse, response from City agencies, demographics of victims and survivors, and access to community-based services. Based on the report's findings, the Family Violence Council developed a set of 20 recommendations aimed at ending family violence in San Francisco. Three of these recommendations address the significant challenges associated with the COVID-19 health emergency: 1) request emergency funding for agencies engaged in prevention of and response to family violence; 2) increase awareness around family violence during COVID-19; and 3) ensure that all City departments that are members of the Family Violence Council create a response plan to address and prevent family violence in disaster planning.

Last month, the Commission honored five inspiring women. Four of these women were youth activists, who have recently organized protests for Black Lives Matter and against police violence. Tiana Day, Simone Jaccques, Sabrina McFarland, and Zoe Yzabella Taylor, high school and college students, are speakers, organizers, and leaders. During the meeting, Ms. Day, shared that she is working to disrupt our one-sided teaching of history by working to change school curriculum in her district, that “we shouldn’t always be hearing white-Americans narrative --- we should be learning from all aspects.” Ms. McFarland explained that “the goal is to have liberation for all people and not just a few.” Ms. Taylor shared that when she felt helpless and unsure, she found hope through connections with other strong women. Additionally, Aria Sa’id was honored for LGBTQ+ Pride Month. Ms. Sa’id is a co-founder and the Executive Director of [Compton’s Transgender Cultural District](#), the world’s first transgender district. She also founded [Kween Culture Initiative](#), a project to promote the social and cultural empowerment of Black and Brown transgender women. Ms. Sa’id promotes community development through leadership, advocacy, and legislation.
