ANNUAL PLANNING RETREAT

- 5. Adopt principles related to girls' rights.
 - a) Ensure that girls are included in the development of these rights.
 - b) Explore the idea of establishing a "Junior Women's Commission".
- 6. Explore women of color issues.
- 7. Strengthen relationship and increase support of the Friends of the COSW.
 - a) Set up meeting with the Friends Board of Directors and designated Commissioners.
- 8. Expand promotion of COSW through various avenues such as:
 - a) Expand outreach to the press in regards to COSW meeting notices.
 - b) Further develop and improve existing media/press contact list.
 - c) Develop web page with all pertinent COSW information and maintain updated data.
 - d) Display Commissioners' photos in office and on web site.
 - e) Use e-mail as means for distributing information to a wider audience.

OTHER RECOMMENDATIONS:

- 1. Increase Commissioners' participation.
 - a) Provide developmental training to Commissioners.
 - b) Set up training session by Amy Ackerman on resolutions. (January 2000 meeting)
 - c) Executive Director to include upcoming events list with monthly Staff Report.
 - d) Invite Commissioners when international visitors are scheduled to meet with COSW.
- 2. Take a broad look at the Violence Against Women (VAW) issue.
- 3. Consider revising agenda format and have Public Comment come before Old Business rather than after. This change is intended to encourage the public to come and speak at Commission meetings and not have to wait until the end of the meeting.
