I. INTRODUCTION

Enclosed is the Office of Citizen Complaint's statistical report for the 2010 first quarter. The OCC received 239 complaints of police misconduct or failure to take action and closed 223 complaints this first quarter. It sustained 16 complaints against San Francisco Police officers.

II. ORGANIZATIONAL AND BUDGET MATTERS

The OCC experienced a period of organizational contraction during the first quarter of 2010. One journey level investigator (8124) retired and another announced his resignation, effective April 9, 2010, reducing the number of filled 8124 positions to 15. Additionally, one 8124 investigator began an extended three month leave through May and another 8124 investigator began an indefinite unplanned leave. This left the OCC facing a second quarter with 13 journey level investigators to each handle an average of six new cases a month.

Finally on February 22, 2010, in compliance with City budget directives, the OCC submitted its proposed budget to the Mayor and Controller with a total of 30% in budget reductions including three journey 8124 investigator positions (one of which is filled), five filled clerical positions and a filled attorney position. The OCC reported that should all nine of these positions be taken, one quarter of the OCC's staff would be eliminated and eight employees would lose their jobs. The OCC stressed that the reduction of the investigator positions would cause increased caseloads, which could lead to lower productivity and more delays. The OCC also stressed that the reduction of an attorney position would necessitate the elimination of the mediation program, and leave the outreach work without a coordinator. The OCC indicated that the

reduction of the clerical staff by 60% would greatly hamper the office's ability to comply with legal mandates of document production and timely process complaints and investigations. Finally, during this first quarter, the OCC felt the impact of a mandated \$40,000 mid-cycle reduction in its operations budget. The OCC was unable to make long needed improvements to enable it to electronically access Department of Motor Vehicle records. The reduction was part of a citywide effort to balance the 2009/2010 budget.

III. INVESTIGATION OF CASES

As of the end of the 2010 first quarter, the OCC opened 239 new cases, and closed 223 cases. During this quarter, the OCC closed 16 fewer cases than it opened. The OCC closed the quarter with 397 pending cases which is 17 more pending cases than the close of the first quarter in 2009. By the end of the 2010 first quarter there were 208 pending cases from 2009 and 189 pending cases from 2010.

While the investigative staff saw its ranks diminishing toward the end of the first quarter, it demonstrated its commitment to the OCC's mission of investigating civilian complaints of police misconduct or neglect of duty promptly, fairly and in an unbiased manner, with a determined effort. Of the 223 cases closed, 79% of them were closed within nine months and less than 1% of them (1 case) took more than a year to close. The case that took more than one year to close had no sustainable allegations. While in the first quarter of 2009, 87% of the 258 cases were closed within nine months, in the first quarter of 2010, the investigators sustained 45% more cases, requiring additional time on those cases.

The rate of sustained cases increased in the first quarter of 2010. During this quarter of 2010, seven percent of cases were sustained; still lower than the OCC's historical average of nine percent, yet higher than the four percent of cases sustained at the end of the first quarter of 2009. In the first quarter of 2010 the OCC sustained 16 cases compared to 11 cases in the first quarter of 2009. The number of days to close sustained cases significantly increased for the first quarter of 2010 compared to the first quarter of 2009. In the first quarter of 2010 only 6% of sustained cases were completed within nine months but no sustained cases were completed more than 365 days after receipt, while during the same period in 2009, 54% of the sustained cases were completed within nine months. This decrease in prompt completion of sustained cases is attributable to three factors: 1) increased number of sustained cases, 2) decreasing number of investigators and 3) active trial calendars for the two prosecuting attorneys who also serve as advice attorneys on sustained cases and sustainability reviews.

There were sustained allegations of neglect of duty in 15 of the 16 sustained complaints. Four complaints, or 25% of them, were sustained for failure to issue a certificate of release after handcuffing. Three complaints were sustained for failure to properly process property. Two complaints were sustained for failure to make entries in the use of force log. Another complaint contained several allegations including misrepresentation of the truth, unnecessary force and discourtesy.

IV. STATUS OF CURRENT OCC CASES – THE ‘KEANE’ REPORT

By the end of the 2010 first quarter, staff had completed intake on all 2009 cases, and had, closed 80% of the 2009 cases, leaving 20% of the 2009 cases pending. In comparison, by the end of the 2009 first quarter, staff had also completed intake on all 2008 cases, and had closed 82% of the 2008 cases, leaving 18% of the 2008 cases pending. While during the first quarter of 2009 there was some slippage in the number of pending cases from the previous year, it is understandable in light of the increased number of sustained cases and the time devoted to complete them.

V. CASE MANAGEMENT

The investigator caseload as of March 31, 2010 shows significant increase over the same period in 2009. This increase is attributable to greater time needed by investigators and attorneys to process sustained cases. The average caseload as of March 31, 2010 was 24 cases per investigator. As of March 31, 2009, the average caseload was 20 cases. As with previous quarters, the Chief Investigator and the Senior Investigators continued to take a very active role in monthly case reviews, monitoring caseloads and assuming investigative responsibility in selected cases.

VI. MEDIATION

At the beginning of 2010, the OCC Mediation Coordinator, Donna Salazar, was on an unexpected leave for seven weeks. During her absence, the OCC was unable to conduct mediations because the remaining three attorneys on the OCC legal unit had a heavy caseload, an increased number of sustainability reviews and sustained reports and 22 pending policy recommendations to address. The Mediation Coordinator returned to work in late February and she facilitated five mediations in March. In comparison, the OCC mediated sixteen cases in the first quarter of 2009.

In early March the Mediation and Outreach Coordinator attended the Alternative Dispute Resolution of Northern California conference as well as two Mediation Week events. In February, the Mediation Coordinator addressed a class at

Community Boards mediation training. The Mediation Program continues to provide a forum for officers and civilians to have a frank discussion regarding the complaint, as well as serves as an educational experience for all participants.

VII. OUTREACH

During the first quarter of 2010, the OCC participated in several outreach activities. OCC staff gave “Know Your Rights” presentations to two groups at the Excelsior Family Center, as well as to the staff of the Community Assessment and Referral Center. In addition, the OCC Director made a presentations about its services during Police Commission meetings in January, February and March held at the African American Art and Cultural Complex in the Western Addition, Eureka Valley Recreation Center in the Mission and Grace Lutheran Church in the Portola neighborhood of the Bayview District.

During this quarter, the OCC also gave informational presentations to a Guggenheim Fellow from Harvard who was interested in the agency’s policies and procedures, and Mediation Program. Additionally, the OCC staffed informational tables at an Operation Homeless Connect event and the Family Summer Resource Fair hosted by the City’s Department of Children, Youth and Families. OCC staff also met with an Indonesian delegation to describe the OCC’s policies and procedures.

OCC staff also addressed a class of students from San Francisco State University regarding the services provided by the agency and the City of Richmond, California, Police Commission regarding the OCC Mediation Program.

VIII. POLICY ANALYSIS

During the first quarter of 2010 policy analyst Samara Marion worked to advance the implementation of the agency’s twenty-two outstanding recommendations made during the 4th quarter 2009 related to officer-involved shootings, juvenile policing practices and language access services.

Ms. Marion met weekly with representatives from several juvenile justice advocacy groups and the Department to complete a Department Bulletin that summarizes the key revisions to Department General Order 7.01, the juvenile policing DGO. The OCC and juvenile justice advocacy groups have been steadfast in advancing an informative “Know Your Rights Guide for Youth in San Francisco” that the Department has agreed to issue. The Department Bulletin and Youth Guide will be released in the upcoming month. Ms. Marion and juvenile justice advocacy groups

will continue to meet with the Department to develop academy and roll call training on police interactions with youth.

During the past three months, the OCC held discussions with the Police Department to facilitate the reorganization of language assess services under the Community Relations Unit of the Office of the Chief of Staff. The OCC is optimistic that this reorganization will lead to the timely review and implementation of our agency's outstanding language access recommendations.

Ms. Marion has continued her discussions with the Police Department concerning its officer-involved shooting recommendations and anticipates more rapid progress once the Department's personnel and organizational changes are more fully implemented.

Additionally, Ms. Marion worked with SFPD to revise Department General Order 3.01 to ensure consistency between Department General Orders adopted by the Police Commission and Department Bulletins, Bureau and Unit orders issued by the Police Department. These revisions were before the Police Commission for discussion on April 14, 2010 and will return for action in 30 days.

Lastly, to facilitate better record keeping and timely document requests concerning equipment usage, the OCC recommended and obtained the Police Commission's adoption of a modification to the OCC-SFPD Document Protocol.

IX. CONCLUSION

The OCC faces severe budget and staffing constraints in the upcoming year which could result in case resolution delays, however, the OCC will remain committed to its mission promptly, fairly and impartially investigating citizen complaints of police misconduct or failure to perform a duty.






Days to Close - Cases Closed First Quarter 2010




Days to Close - Cases Closed First Quarter 2009




Status of OCC Cases - Year 2009




Status of OCC Cases - Year 2010





OCC Caseloads by Investigator as of 03/31/2010





OCC Caseloads by Investigator as of 03/31/2009





OCC Case Closures - First Quarter 2010 by Investigator






OCC Weighted Closures - First Quarter 2010 by Investigator

CASE COMPLEXITY WEIGHTED ON A 1 TO 5 SCALE


OCC Weighted Closures - First Quarter 2009 by Investigator



Average Case Closure by Weight: 36


