I. INTRODUCTION

Enclosed is the Office of Citizen Complaints' statistical report for the 2011 first quarter. The OCC received 188 complaints of police misconduct or failure to take action and closed 218 complaints this first quarter. It sustained allegations of misconduct or failure to take action in 16 complaints against San Francisco Police officers which is a 7% sustained rate. The OCC mediated 18 cases which is an 8% mediation rate.

II. ORGANIZATIONAL AND BUDGET MATTERS

The OCC experienced a period of organizational contraction during the first quarter of 2011. One journey level investigator (8124) resigned effective February 1, 2011 reducing the number of filled 8124 positions to 14, one less than is required by City Charter based on San Francisco Police Department staffing levels. Additionally, during the first quarter, two 8124 investigators began extended three month leaves through May and June, respectively. This left the OCC with 12 journey level investigators to each handle an average of five new cases a month.

Finally on February 22, 2011, in compliance with City budget directives, the OCC submitted its proposed budget to the Mayor and Controller with a total of 20% in budget reductions including two vacant journey 8124 investigator positions, two filled clerical positions and one filled attorney position. The OCC reported that should all five of these positions be taken, nearly 15% of the OCC's staff would be eliminated and three employees would lose their jobs. The OCC stressed that the reduction of the investigator positions would cause increased caseloads, which could lead to lower productivity and more delays. The OCC also stressed that the reduction of an attorney

position would necessitate the elimination of the mediation program, and leave the outreach work without a coordinator. The elimination of the mediation program would prevent the OCC from facilitating meaningful conversations between complainants and police officers in 8% of the cases the OCC closes. Moreover, without the mediation program, those cases would go back to the investigators' inventory and increase the investigators' caseloads. Finally, the OCC indicated that the reduction of the clerical staff by one third would greatly hamper the office's ability to comply with legal mandates of document production and timely processing complaints and investigations.

III. INVESTIGATION OF CASES

As of the end of the 2011 first quarter, the OCC opened 188 new cases, and closed 218 cases. During this quarter, the OCC closed 30 more cases than it opened. The OCC closed the quarter with 396 pending cases which is one less pending case than the close of the first quarter in 2010. By the end of the 2011 first quarter there were 247 pending cases from 2010 and 149 pending cases from 2011.

While the investigative staff saw its ranks diminishing once again toward the end of the first quarter, it demonstrated its commitment to the OCC's mission of investigating civilian complaints of police misconduct or neglect of duty promptly, fairly and impartially, with a determined effort. Of the 218 cases closed, 61% of them were closed within nine months and 5% of them (10 cases) took more than a year to close. The nine of the ten cases that took more than one year to close had no sustainable allegations. The statute of limitations is tolled on the one sustainable case that took more than one year to close because of an ongoing criminal investigation. The continuing impact of four experienced investigators on extended leaves of absence, two in 2010 and two in 2011, and the resignation of two investigators in December and January had an impact on timeliness of investigations.

In spite of the challenge of understaffing, the rate of sustained cases remained constant in the first quarter of 2011, with the first quarter 2010 7% sustained rate. In the first quarter of 2011 the OCC sustained allegations in 16 cases which are equal to the 16 cases with sustained allegations in the first quarter of 2010. The number of days to close sustained cases decreased for the first quarter of 2011 compared to the first quarter of 2010. In the first quarter of 2011, 12% of sustained cases were completed within nine months and one sustained case was completed more than 365 days after receipt, while during the same period in 2010, only 6% of the sustained cases were completed within nine months. The one-year statute of limitations for the one sustained case which was completed after 365 days in the first quarter of 2011 has been tolled while a criminal investigation is pending pursuant to Government Code section 3304, section (d), subsection (1).

The impediments to prompt completion of sustained cases are attributable to at least four factors: 1) increased number of sustained cases in 2010 and 2011, 2) decreasing number of investigators (12 at the close of the first quarter in 2011 compared to 17 at the close of the first quarter in 2010), 3) active trial calendars for the two prosecuting attorneys who also serve as advice attorneys on sustained cases and sustainability reviews and 4) increased policy work for policy analyst attorney who also serves as an advice attorney on sustained cases and sustainability reviews.

There were sustained allegations of neglect of duty in 10 of the 16 sustained complaints. Five of these complaints with sustained neglect of duty allegations, or 31% of them, were for failure to collect traffic stop data. The neglect of duty sustained allegations in these five complaints are as troubling as they were in previous quarters because the allegations were sustained because an officer either failed to complete the worksheet for traffic stop data or to enter the information into the MDT in the patrol vehicle or at the station computer in the case of motorcycle officers. Dr. Lorie Fridell in her 2007 study on Fair and Impartial Policing in San Francisco discusses the importance of accurate data collection should a department determine that it will collect traffic stop data.¹

Additional categories for which allegations were sustained include:

- 1. Unnecessary force.
- 2. Conduct reflecting discredit for:
 - a. Misrepresentation in an incident report,
 - b. Smashing a bottle in the street, and
 - c. Harsh, demeaning and profane language.
- 3. Unwarranted action for:
 - a. Pat searching,
 - b. Confiscating a driver's license and
 - c. Interfering with the rights of onlookers.
- 4. Neglect of duty for:
 - a. Violation of the juvenile protocols (Department General Order 7.10),
 - b. Violation of the language access policy for limited English, proficient individuals (Department General Order 5.20),
 - c. Failing to prepare an incident report in an incident involving injuries,
 - d. Failing to remain in radio contact and
 - e. Leaving a magazine with live ammunition at a residence which was the scene of a police operation.

IV. STATUS OF CURRENT OCC CASES - THE 'KEANE' REPORT

By the end of the 2011 first quarter, staff had completed intake in all but one 2010 case and had closed 71% of the 2010 cases, leaving 29% of the 2010 cases pending. Intake on the one 2010 case will be completed during the second quarter. Intake was delayed while jurisdictional questions were resolved. In comparison to 2010, by the end of the 2010 first quarter, staff had completed intake on all 2009 cases, and had closed 80% of the 2009 cases, leaving 20% of the 2009 cases pending. While during the first quarter of 2011 there was some slippage in the number of pending cases from the previous year, it is understandable in light of the number of sustained cases, the time devoted to complete them and the number of investigators, 12 in 2011 compared to 17 in 2010, by the end of the first quarter.

V. CASE MANAGEMENT

The investigator caseload as of March 31, 2011 shows significant increase over the same period in 2010. This increase is attributable to a significant decrease in the number of journey level investigators, 12 at the close of the first quarter in 2011 and 17 at the close of the first quarter in 2010. The average caseload as of March 31, 2011 was 27 cases per investigator. As of March 31, 2010, the average caseload was 24 cases. In its 2007 audit of the OCC's operations, the City Controller concluded that an average of 16 cases was a best practices caseload for investigators of police misconduct or neglect of duty. As with previous quarters, the Chief Investigator and the Senior Investigators continued to take a very active role in monthly case reviews, monitoring caseloads and assuming investigative responsibility in selected cases.

VI. MEDIATION

During the first quarter of 2011, the OCC mediated eighteen cases compared to five cases in 2010 when Donna Salazar, the Mediation Coordinator was on an unexpected leave for seven weeks. In the first quarter of 2009 the OCC Mediated sixteen cases. A mediation rate of 8% of all closed cases represents the work of one full time investigator.

In February, the Mediation Coordinator addressed a class at Community Boards mediation training. In early March, the Mediation and Outreach Coordinator attended the Alternative Dispute Resolution of Northern California conference.

The Mediation Program continues to provide a forum for officers and civilians to have a frank discussion regarding the complaint, as well as serves as an educational experience for all participants.

VII. OUTREACH

During the first quarter of 2011, the OCC conducted most of its outreach work through the work of its Mediation and Outreach Coordinator, Donna Salazar, and its Policy Analyst, Samara Marion, whose projects are more particularly described in sections VI and VIII of this report, respectively. As mentioned in Section VI, the Mediation and Outreach Coordinator attended the Alternative Dispute Resolution of Northern California conference and Community Boards training. Ms. Salazar's connections with the mediation community provide a wealth of volunteer mediators, for OCC mediations. These mediators provide pro bono services to the OCC, when in other jurisdictions, such as Washington DC, the mediators are paid for their services.

The Policy Analyst's outreach work included the Crisis Intervention Team project – establishment of SFPD crisis intervention teams through a collaborative process with mental health professionals and other stakeholders and the Juvenile Protocols project -- implementation of Department General Order 7.01.

Additionally, the OCC Director made a presentation about the OCC's services during the Police Commission meeting held in the Northern District at Claire Lilienthal Elementary School in January.

Also, the OCC staffed informational tables at one Operation Homeless Connect event and the Family Summer Resource Fair hosted by the City's Department of Children, Youth and Families.

When the OCC has a full complement of investigators, the OCC will dedicate more investigators to its outreach efforts.

VIII. POLICY ANALYSIS

The OCC's policy work is an essential aspect of its mission. The San Francisco City Charter requires the OCC to present quarterly recommendations concerning SFPD's policies or practices that enhance police-community relations while ensuring effective police services. Attorney and policy analyst Samara Marion leads the OCC's policy work. During the first quarter 2011, the OCC advanced its policy work in three areas: police response to mental health crisis calls, restrictions on shooting at vehicles, and police procedures for interactions with juveniles

The OCC began 2011 by vigorously working to implement a Crisis Intervention Team (CIT) program for police response to mental health crisis calls. Developed by the Memphis Police Department in 1988, CIT is a community and law enforcement partnership in which specially trained crisis intervention police officers who maintain their regular patrol duties are dispatched as first responders to mental health crisis calls. As a participant in SFPD's 2009 Officer-Involved Shooting (OIS) Study, the OCC recommended that the Police Department implement the CIT program because one-third of the OIS shootings had involved mentally ill individuals.² In January 2011, Interim Police Chief Jeffrey Godown sent three officers and the OCC policy analyst to Memphis to meet with CIT founders Major Sam Cochran and Dr. Randolph Dupont. This trip provided an opportunity to observe firsthand the partnership between the Memphis Police Department's CIT officers, the 911 dispatchers, mental health providers, mental health consumers, and community advocates. It also enabled the OCC to learn more about the success of the Memphis CIT program including the reduction of officer injuries, improved continuity of care for mentally ill persons, and a lower rate of re-arrest among those diverted from the iail to Psychiatric Emergency Services.³

During the weeks following this trip, the OCC worked with the Police Commission and the Police Department to bring together a team of mental health professionals, community advocates, and city agencies to spearhead the CIT program. On February 9, 2011, after several hours of testimony from the OCC, mental health professionals, and community advocates, including presentations from CIT Memphis founder Major Cochran and Dr. Dupont, the Police Commission unanimously voted to implement the CIT program. Shortly thereafter, Police Commissioner Angela Chan and the OCC organized a team of fifteen representatives including mental health providers, mental health advocates and law enforcement for a two-day CIT strategy session with Major Cochran and Dr. Dupont in Memphis. As a member of the CIT working group, the OCC is assisting in the development of the 40-hour CIT training, tackling the challenges of 911 coordination, and networking with CIT experts and resources on the West Coast.

The OCC successfully concluded one of its policy projects with the recent adoption of Department General Order 5.02 revisions that restrict shooting at vehicles. As a participant in SFPD's Officer-Involved Shooting study, in 2009 the OCC recommended that the Police Department restrict its shooting at vehicles policy in the same manner that police departments in major cities such as New York, Los Angeles,

Chicago and Boston had.⁴ The OCC also recommended that the new policy explain the inherent dangers and ineffectiveness of shooting at a moving vehicle. During the first quarter, the OCC and the Department reached consensus on restrictions shooting at vehicles that are consistent with best practices. The Police Commission adopted these restrictions on March 16, 2011. The Police Department has agreed to provide training that emphasizes that officers shall not intentionally place themselves in harm's way by standing or moving in front of a moving vehicle, standing directly behind a moving vehicle, or reaching inside an operating vehicle. This training will also explain that the prohibitions exist because moving to cover, repositioning, and/or waiting for backup to gain and maintain a superior tactical advantage maximizes officer and public safety and minimizes the necessity for using deadly force.

The OCC continues to hold frequent meetings with the Police Department and juvenile justice advocates to finish implementing Department General Order 7.01, the new juvenile-policing protocols. In March the Department began roll call training on these new juvenile-policing procedures that the OCC had co-authored during the fall 2010. The OCC continues to urge the Department to prioritize the completion of the police interview room at the Community Referral and Assessment Center to ensure that officers have the necessary resources to comply with their obligation to avoid bringing juveniles to district stations.

IX. CONCLUSION

As in the past four years, the OCC faces severe budget and staffing constraints in the upcoming year which could result in additional case resolution delays, however, the OCC will remain committed to its mission to promptly, fairly and impartially investigate civilian complaints of police misconduct or failure to perform a duty.






Days to Close - Cases Closed First Quarter 2011




Days to Close - Cases Closed First Quarter 2010

Days to Close - Cases Sustained First Quarter 2010










OCC Caseloads by Investigator as of 03/31/2011




OCC Caseloads by Investigator as of 03/31/2010




OCC Case Closures - First Quarter 2011 by Investigator






Average Case Closures by Number: 14 or 5 cases per month per investigator


OCC Case Closures - First Quarter 2010 by Investigator







Average Case Closures by Number: 11 or 4 cases per month per investigator


OCC Weighted Closures - First Quarter 2011 by Investigator







OCC Weighted Closures - First Quarter 2010 by Investigator
