## I. INTRODUCTION

### A. Statistics

The Department of Police Accountability (DPA) 2018 second quarter statistical report is attached. The DPA received an adjusted total of 186 complaints of police misconduct or failure to take action and closed 139 complaints. The DPA sustained allegations against San Francisco police officers in seven (7) complaints, which is a 5% sustained rate. The DPA mediated three (3) cases during the second quarter.

## II. ORGANIZATIONAL AND BUDGET MATTERS

### A. Budget

The Department of Police Accountability's approved budget for FY 2017-18 is \$7,200,138 and \$7,508,817 for FY 2018-19.

### B. Staffing

The DPA's approved budget for fiscal year 2017-18 is \$7,200,138 with 44.78 budgeted positions. Of the budgeted positions, the following positions remained vacant at the end of the second quarter: one (1) 1053 IS Business Analyst - Senior, one (1) 1822 Administrative Analyst, two (2) 8177 Attorney positions, one (1) senior investigator, and four (4) 8124 Investigator positions.

### **C. Technology**

During the second quarter, Senior Investigator Sara Maunder and Information Systems (IS) Analyst Assistant Eric Ho applied for the Civic Bridge program fall cohort through the Mayor's Office of Civic Innovation and continued conversations with Digital Services in preparation for building DPA's new website. They continued working closely with DataSF to connect DPA's database with PowerBI to create real-time dynamic data dashboards. They also assessed equipment needs to achieve compatibility with several new systems and an anticipated case management system migration. In addition, Ms. Maunder and Mr. Ho attended a Microsoft SharePoint training workshop offered by the Department of Technology, where they learned basic site architecture and use in preparation for the migration of DPA's Intranet onto SharePoint. They also worked together to improve the current case management database by identifying and adding necessary fields while removing obsolete ones. With the help of summer interns, DPA's Twitter account launched and was configured to publish live updates on our website.

### **D. Training**

During the second quarter, DPA staff attended a variety of trainings. Investigators and the management team attended a Comprehensive Crisis Service training taught by Director Stephanie Felder of the Department of Public Health. Investigators and attorneys attended a Use of Force training hosted by the AELE Law Enforcement Legal Center. Several DPA staff also attended the Juvenile Jeopardy Training provided by Lisa Thureau at the Scottish Rite Masonic Center. Our newest investigators attended Internal Affairs training at the Alameda County Sheriff's Office Regional Training Center. The clerical team attended the Customer Focused Communications training provided by Denise Van Alstine of the Department of Human Resources Learning and Development team. The information services analyst attended an SQL Scripting Training at Academy X. Finally, all DPA staff completed a one-hour Web Training on the San Francisco Sunshine Ordinance.

## **III. INVESTIGATION OF CASES**

### **A. Case Inventory**

The DPA opened 189 new cases, with an adjusted total of 186 new cases.<sup>1</sup> The DPA closed 139 cases, leaving 303 cases pending at quarter end, 60 fewer than were pending at the close of the second quarter of 2017. Of the 303 pending cases, 230 were opened in 2018, 67 were opened in 2017, four (4) were opened in 2016, and two (2) were opened in 2015.

### **B. Caseloads and Case Dispositions**

The average caseload per investigator was 16 cases, compared with 24 cases during the second quarter of 2017. Of the 139 total closed cases, DPA investigators closed 106 cases (76% of cases) within 270 days. The DPA's goal is to conclude investigations within 270 days. The DPA took more than a year to close two (2) cases (2% of cases).

One or more allegations of misconduct were sustained in seven (7) of the 139 closed cases, resulting in a 5% sustained rate. Of the 316 allegations investigated, 111 allegations resulted in “Proper Conduct” findings; 13 allegations resulted in “Sustained” findings; 73 allegations resulted in “Unfounded” findings; 35 allegations resulted in “No Finding” findings; 13 allegations resulted in “No Finding/Withdrawn” findings; and 71 allegations resulted in “Not Sustained” findings.

### **C. Chief of Police’s Adjudication of DPA Sustained Cases**

When a sustained case warrants a suspension of ten days or more, the DPA can recommend that the Chief of Police file charges with the Police Commission. If the Chief of Police declines to file charges with the Police Commission after meeting and conferring with the DPA, the DPA can file charges on its own with the Police Commission. Alternately, the DPA can determine that a case warrants a suspension of ten days or fewer.

When the DPA determines that sustained misconduct warrants no more than ten days of suspension, the Chief of Police determines whether or not to sustain the DPA’s findings and what level of discipline to impose. Although the DPA recommends specific levels of discipline for each case, the Chief of Police determines if, in his opinion, the sustained allegations are merited and what level of discipline or corrective action to impose. The Chief of Police also adjudicates challenges. While police officers may appeal the Chief’s discipline to the Police Commission, neither Charter section 4.136 nor the Administrative Code provide for the DPA Director to appeal the Chief’s decision. During the second quarter, the Chief of Police imposed discipline in eight (8) DPA sustained cases as follows:

In April 2018, Chief William Scott imposed discipline in four (4) cases investigated and determined by the DPA to have sustainable allegations. The DPA’s findings and recommended discipline and the Chief’s proposed discipline are as follows:

1. Neglect of Duty – An officer failed to write an incident report.

**The DPA Director recommended a written reprimand.**

**In concurrence with the DPA Director, the Chief of Police imposed a written reprimand and retraining.**

**According to the Police Commission Disciplinary Penalty and Referral Guidelines, the penalty for a violation of paragraph 27 under Class “D” misconduct is a written reprimand for a first offense.**

2. Discourtesy – An officer used profanity.

**The DPA Director recommended a written reprimand.**

**The Chief of Police imposed an admonishment and retraining.**

**According to the Police Commission Disciplinary Penalty and Referral Guidelines, the penalty for a violation of paragraph 27 under Class “D” misconduct is a written reprimand for a first offense.**

3. Unwarranted Action – An officer issued a citation without cause.

**The DPA Director recommended a written reprimand.**

**The Chief of Police imposed an admonishment and retraining.**

**According to the Police Commission Disciplinary Penalty and Referral Guidelines, the penalty for a violation of paragraph 27 under Class “D” misconduct is a written reprimand for a first offense.**

4. Neglect of Duty – An officer wrote an inaccurate police report.

**The DPA Director recommended a written reprimand.**

**The Chief of Police imposed an admonishment and retraining.**

**According to the Police Commission Disciplinary Penalty and Referral Guidelines, the penalty for a violation of paragraph 27 under Class “D” misconduct is a written reprimand for a first offense.**

In May 2018, Chief William Scott imposed discipline in two (2) cases investigated and determined by the DPA to have sustainable allegations. The DPA’s findings and recommended discipline and the Chief’s proposed discipline are as follows:

5. The following allegations against an officer were sustained:

Unwarranted Action – for threatening someone.

Neglect of Duty – for failure to comply with Department General Order 5.15, Enforcement of Immigration Laws.

Neglect of Duty – for failure to comply with Department General Order 5.17, Policy Prohibiting Biased Policing.

Conduct Reflecting Discredit – for engaging in biased policing based on race or national identity.

Conduct Reflecting Discredit – for making inappropriate comments and engaging in inappropriate behavior.

Discourtesy – for using profanity.

**The DPA Director recommended a five-day suspension.**

**The Chief of Police imposed a two-day suspension. The officer is no longer with the Department.**

6. Neglect of Duty – An officer failed to take required action per DGO 10.11, Body Worn Cameras.

**The DPA Director recommended a written reprimand.**

**In concurrence with the DPA Director, the Chief of Police imposed a written reprimand and retraining.**

**According to the Police Commission Disciplinary Penalty and Referral Guidelines, the penalty for a violation of paragraph 27 under Class “D” misconduct is a written reprimand for a first offense.**

In June 2018, Chief William Scott imposed discipline in two (2) cases involving five (5) investigated officers and determined by the DPA to have sustainable allegations. The DPA’s findings and recommended discipline and the Chief’s proposed discipline are as follows:

7. Neglect of Duty – Two officers failed to properly investigate and failed to properly process property.

Neglect of Duty – The officers’ supervisor failed to properly supervise.

**The DPA Director recommended an admonishment for each officer.**

**The Chief of Police concurred with the DPA Director’s sustained findings for the two officers. The Chief of Police imposed written reprimands and retraining for the two officers. The Chief of Police found insufficient evidence to sustain the officers’ supervisor and did not impose discipline.**

**According to the Police Commission Disciplinary Penalty and Referral Guidelines, the penalty for a violation of paragraph 27 under Class “D” misconduct is a written reprimand for a first offense.**

8. Conduct Reflecting Discredit – An officer behaved inappropriately.

Conduct Reflecting Discredit and Unwarranted Action – Another officer behaved inappropriately and placed a complainant in handcuffs without justification.

**The DPA Director recommended a written reprimand for both officers.**

**The Chief of Police imposed a written reprimand and retraining for the first officer and an admonishment and retraining for the second officer.**

**According to the Police Commission Disciplinary Penalty and Referral Guidelines, the penalty for a violation of paragraph 27 under Class “D” misconduct is a written reprimand for a first offense.**

#### **IV. SECOND QUARTER COMPLAINTS OF NOTE**

##### **A. Officer-Involved Shootings**

In the second quarter, the DPA initiated an investigation into an officer-involved shooting that occurred on the 1500 block of O’Farrell Street on May 11, 2018. In addition, the DPA initiated an investigation into the shooting of Oliver Barcenas. At the end of the second quarter, the DPA concluded its investigations of the shootings of Nicholas McWherter and Amilcar Perez-Lopez. Twelve (12) officer-involved shooting complaints remained open at the end of the second quarter 2018.

##### **B. Skateboard Incident**

At the end of the second quarter, the DPA continued to investigate a complaint regarding a skateboarder who collided with an SFPD patrol car.

##### **C. Racist and Homophobic Text Messages by Members of the San Francisco Police Department**

At the end of the second quarter, the DPA continued to investigate a complaint regarding racist and homophobic text messages by members of the San Francisco Police Department.

#### **V. STATUS OF CURRENT DPA CASES – THE ‘KEANE’ REPORT**

At the end of the second quarter, the investigative staff had completed intake on 501 of 504 2017 cases and had closed 437 cases or 87% of its 2017 cases, leaving 67 or 14% of the 2017 cases pending.

#### **VI. LEGAL UNIT**

The DPA’s attorneys conduct sustainability reviews, review reports of sustained misconduct for legality, prepare legal opinions, and manage records requests, including subpoenas, *Pitches* motions, Sunshine Ordinance requests, and Public Records Act requests. Additionally, the attorneys defend

DPA's misconduct findings. They present cases to the Chief of Police when officers object to proposed discipline of up to ten days of suspension. They present cases before the Police Commission when the proposed discipline is greater than 10 days of suspension, up through termination. Attorney Samara Marion conducts the bulk of DPA's policy work, conducts sustainability reviews, reviews sustained report legality, prepares legal opinions, and conducts investigator trainings. The DPA's policy work is outlined in section VII.

## VII. POLICY ANALYSIS

Policy work is an essential aspect of the Department of Police Accountability's mission. While discipline of individual officers is an essential component of law enforcement management, DPA's policy work directly impacts the entire police force and the community it serves. The San Francisco City Charter requires the DPA to present quarterly recommendations concerning SFPD's policies or practices that enhance police-community relations while ensuring effective police services.

During the second quarter, Attorney Samara Marion led the agency's policy work. The DPA participated in SFPD's Executive Sponsor Working Groups that addressed policies and practices concerning the use of force and accountability within the complaint and disciplinary processes. The DPA also continued its partnership with community-based organizations and SFPD to enhance language access services, create a Deaf and Hard of Hearing Department General Order and advance the work of the Crisis Intervention Team Working Group.

On April 11, 2018, the DPA presented to the Police Commission its recommended revisions to Department General Order 2.04 (Complaints Against Officers). The DPA initiated DGO 2.04 revisions because the Department General Order had not been updated since 1994, it did not accurately reflect DPA's charter mandated investigative authority, and it was silent about DPA procedures for referring complaints involving criminal allegations. Unanimously adopted by the Police Commission, DGO 2.04 revisions define DPA investigative duties and authority in the following ways:

- **DPA Investigative Duties.** Incorporated the DPA's charter mandated duties to investigate SFPD shootings resulting in a physical injury or death and all complaints of use of force, misconduct or failure to perform a duty except complaints deemed proper on their face or lodged by a SFPD officer. See DGO 2.04 (III)(A).
- **DPA Investigative Authority Includes Off-Duty Officers Placing Themselves On Duty.** Explicitly states that the DPA has investigative authority concerning complaints where officers place themselves on duty by "verbally identify themselves, displaying a department issued star or ...ID card or taking enforcement action." (DGO 2.04 was previously silent on this topic.) See DGO 2.04 (II)(A)(8).
- **DPA Investigative Authority Includes Government Agency Complaints.** Explicitly states that the DPA has authority to investigate all government agency complaints except for those lodged by law enforcement agencies. (DGO 2.04 previously implied that complaints from government and law enforcement agencies were investigated exclusively by SFPD). See DGO 2.04 (II)(A)(6).

- **DPA to Refer Criminal Allegations to SFPD and DA.** Provides a procedure for notifying the District Attorney and SFPD when the DPA receives a complaint that includes allegations of criminal conduct. (DGO 2.04 was previously silent on this topic.) See DGO 2.04 (III)(B).
- **Quarterly Disciplinary Board.** Requires that each quarter the DPA and SFPD review the previous quarter's sustained, training and policy failure cases and disciplinary trends to recommend any changes to procedures, policy and training. See DGO 2.04 (VII). This provision implements the Department of Justice's October 2016 Collaborative Reform Recommendation to immediately implement the DPA's 2015 recommendation that SFPD & DPA have quarterly meetings to discuss discipline, policy and training issues. (See DOJ Recommendation 64.2<sup>2</sup>)

During the second quarter, the DPA continued its work on enhancing police protocols for Deaf and Hard of hearing individuals. In November 2017, the DPA brought together a group of community stakeholders including deaf individuals to draft a Department General Order (DGO). The DPA initiated this project because of DPA complaint investigations involving deaf complainants, in addition to concerns raised within the Language Access Working Group about deaf domestic violence survivors receiving inadequate services.

Meeting monthly, the Working Group researched best practices, drafted a proposed DGO and created an officer reference guide for use during traffic stops. The Working Group also identified different technologies to assist SFPD officers at the station and in the field to communicate with Deaf and hard of hearing individuals. Representatives from SFPD have also attended the Working Group and contributed to the proposed DGO and officer reference guide.

In May, the DPA and Commander David Lazar met with Chief William Scott to brief him on the progress of the Deaf and Hard of Hearing Working Group, to request authorization for funding for videoconferencing through officers' cell phones for America Sign Language interpreters and an officer training video to accompany the roll-out of the Department General Order. In light of September being National Deaf Awareness month, the DPA has requested that the Deaf and Hard of Hearing DGO be presented to the Police Commission then.

In November 2015, DPA proposed the following recommendation that was included in DPA's 1<sup>st</sup> Quarter 2016 Sparks' Report, " To address training, policy, and procedure issues discovered during the investigation and disciplinary process of police misconduct cases, the OCC recommends a quarterly meeting with the Chief, the Deputy Chief of Staff, Officer-in-Charge of Risk Management, the Police Academy Captain, the OCC Director and the OCC policy attorney to discuss the OCC's police misconduct cases of the previous quarter that resulted in a sustained, policy or training failure finding. The goal of this meeting is to evaluate whether any training, policy or procedure of the Department need to be revised, added or re-issued and if so, to make written recommendations that include the manner in which the recommendations can be implemented, and a timeline for completion.



During this quarter, the DPA also successfully advanced its recommendations for officer training on youth. Throughout its years of policy work with youth, the DPA urged the Police Department to provide training designed to address police interactions with youth, including information about the juvenile brain, the impact of trauma on children and youth, and de-escalation tactics tailored to youth-police interactions.<sup>3</sup> The DPA recommended the Police Department provide training that would assist officers in understanding the experiences and challenges of youth—particularly youth of color. DPA also suggested that a core component of this curriculum involve scenario-based training in which recruits, patrol officers, sergeants, and field training officers would learn and practice de-escalation tactics to address common interactions between youth and law enforcement.

Through the DPA's efforts in partnership with the Youth Commission and SFPD, nationally recognized Strategies for Youth director and law enforcement trainer Lisa Thureau provided SFPD officers a four day Policing the Teen Brain train-the-trainer session.<sup>4</sup> This curriculum is designed to improve police-youth interactions, give officers a better understanding of the teen brain and thought processes and provide tactics for deescalating interactions and avoiding the use of force on teenagers. In upcoming months, SFPD intends for all officers to obtain the Policing the Juvenile Brain training. DPA will continue to monitor the implementation of this important training.

Additionally, Ms. Thureau provided training to SFPD and the DPA staff on Juvenile Jeopardy, a digital outreach tool to teach youth how to navigate interactions with police and peers, understand the legal consequences of their actions, and be aware of the short and long-term consequences of an arrest and court record on their future options. The DPA intends to use the Juvenile Jeopardy game in combination with the DPA's Know Your Rights for Youth brochure, which is being updated as part of our outreach strategy for youth.

## VIII. MEDIATION

At the end of the second quarter, the Department of Police Accountability mediated a total of seven (7) cases. The DPA's Mediation Program continued to strive for participation in mediation and worked on plans to expand the program using restorative justice principles throughout the complaint process.


## IX. OUTREACH

The DPA remained committed to its mission to investigate civilian complaints of police misconduct or failure to perform duties promptly, fairly, and impartially. The DPA continued to focus its community outreach efforts and policy work on addressing the concerns of the public for greater transparency.

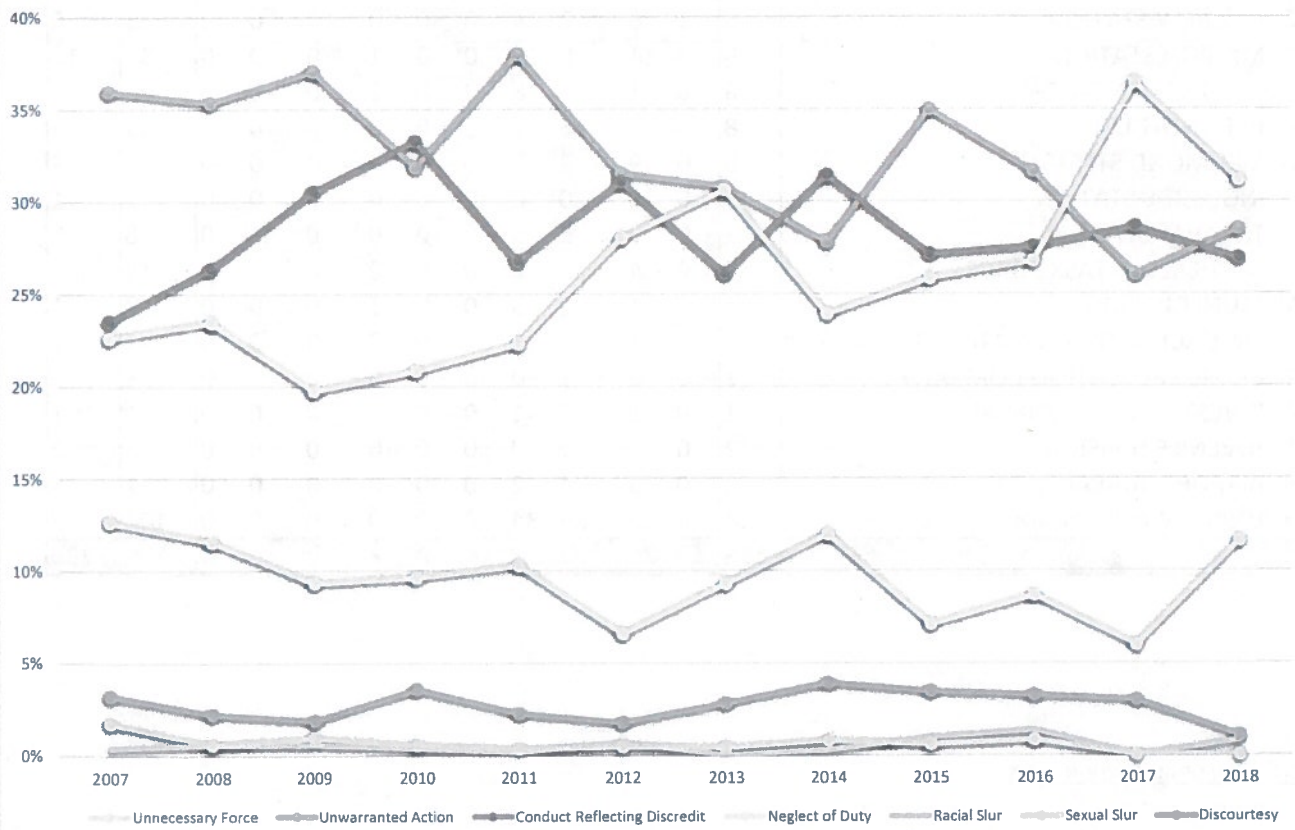

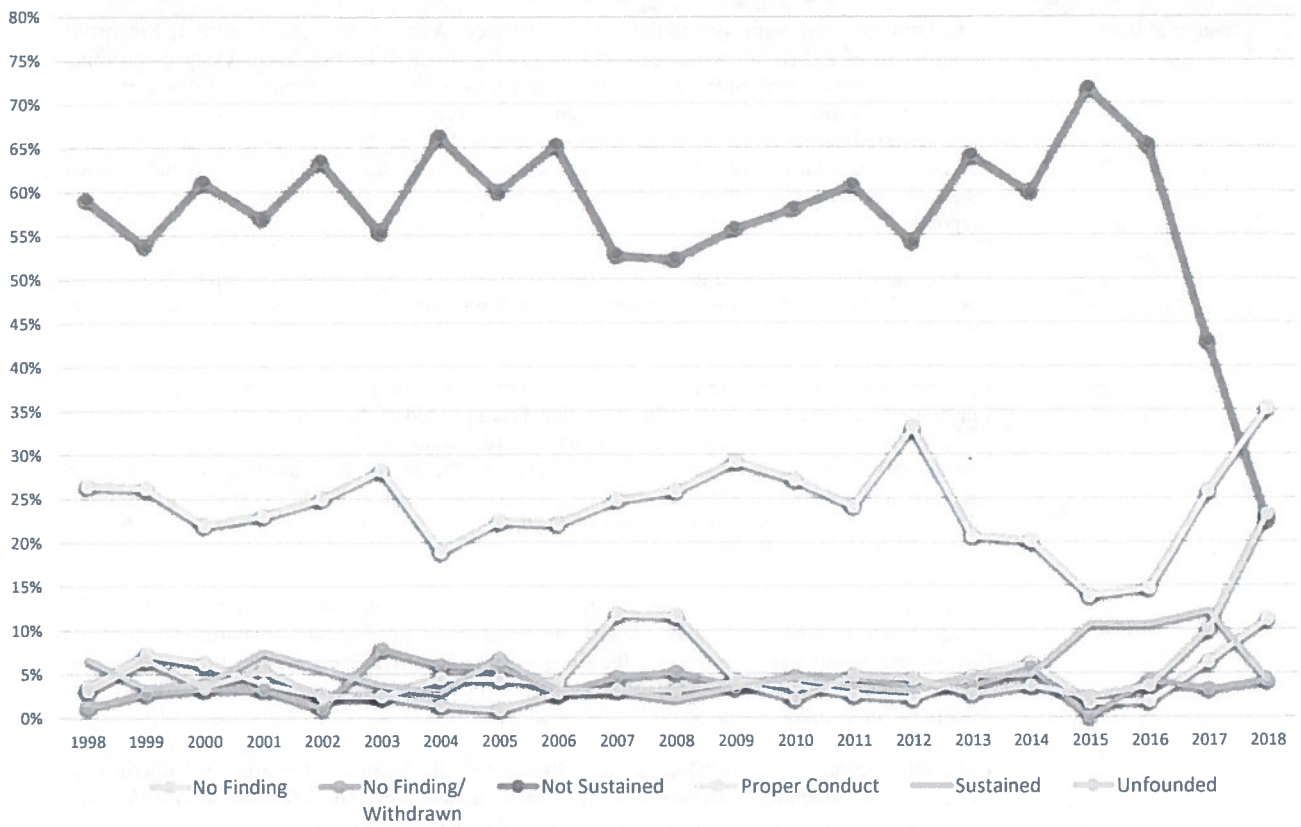

	Neglect of Duty	<p>The DPA investigation revealed that a Police Services Aide (PSA) prepared an initial report of a violation of a domestic violence (DV) restraining order. The PSA acknowledged receiving Academy training that SFPD policy prohibits PSAs from writing domestic violence reports. The PSA acknowledged receiving a written list that precluded PSAs from writing DV reports and admitted not receiving training on how to take a DV report. The PSA stated that violations of court orders in domestic violence cases are considered “secondary offenses,” and claimed that with authorization a PSA could write a report. The PSA could not recall who authorized the report.</p> <p>The sergeant who reviewed the PSA’s report believed that PSAs could write reports such as the one in this case, with approval. He could not recall who authorized the PSA to take the report in this case either.</p> <p>The report is inaccurate and incomplete. The crime was improperly coded, resulting in it being improperly assigned to a Station Investigation Team instead of the Special Victims Unit (SVU). The proper searches to ascertain whether the restraining order was enforceable were not completed. The supplemental checklist attached to the report indicated the order had been served on the restrained party, despite there being no evidence in the SFPD system of the proof of service. No data regarding the long domestic violence history that resulted in a permanent restraining order was noted.</p> <p>The Department’s subject matter expert on domestic violence investigation stated that he frequently sees domestic violence reports prepared by PSAs. The subject matter expert stated the written policy issued to PSAs at the Academy should be enforced. He stated the only reason given that he is aware of is that officers are too busy. This case exemplifies a practice that warrants intervention.</p> <p>The DPA recommends SFPD create and disseminate an A-priority Department Bulletin with clear and unambiguous language prohibiting the assignment of and authorization to PSAs, who possess no DV training, to prepare any DV related incident report.</p>

## 2nd Quarter 2018 Policy Work

Policy work is an essential aspect of the Department of Police Accountability's mission. While discipline of individual officers is an essential component of law enforcement management, DPA's policy work directly impact the entire police force and the community it serves. The San Francisco City Charter requires the DPA to present quarterly recommendations concerning SFPD's policies or practices that enhance police-community relations while ensuring effective police services.

During the 2<sup>nd</sup> Quarter 2018, Attorney Samara Marion lead the agency's policy work. The DPA participated in SFPD's Executive Sponsor Working Groups that addressed policies and practices concerning the use of force and accountability within the complaint and disciplinary processes. The DPA also continued its partnership with community-based organizations and SFPD to enhance language access services, create a Deaf and Hard of Hearing Department General Order and advance the work of the Crisis Intervention Team Working Group.

On April 11, 2018 the DPA presented to the Police Commission its recommended revisions to Department General Order 2.04 (Complaints Against Officers). The DPA initiated DGO 2.04 revisions because the Department General Order had not been updated since 1994, it did not accurately reflect DPA's charter mandated investigative authority, and it was silent about DPA procedures for referring complaints involving criminal allegations. Unanimously adopted by the Police Commission, DGO 2.04 revisions define DPA investigative duties and authority in the following ways:

- **DPA Investigative Duties.** Incorporated the DPA's charter mandated duties to "investigate SFPD shootings resulting in a physical injury or death and all complaints of use of force, misconduct or failure to perform a duty except complaints proper on their face or lodged by a SFPD officer." See DGO 2.04 (III)(A).
- **DPA Investigative Authority Includes Off-Duty Officers Placing Themselves On Duty.** Explicitly states that the DPA has investigative authority concerning complaints where officers place themselves on duty by "verbally identify themselves, displaying a department issued star or ...ID card or taking enforcement action." (DGO 2.04 was previously silent on this topic.) See DGO 2.04 (II)(A)(8).
- **DPA Investigative Authority Includes Government Agency Complaints.** Explicitly states that the DPA has authority to investigate all government agency complaints except for those lodged by law enforcement agencies. (DGO 2.04 previously stated that complaints from government and law enforcement agencies were investigated exclusively by SFPD). See DGO 2.04 (II)(A)(6).
- **DPA To Refer Criminal Allegations To SFPD And DA.** Provides a procedure for notifying the District Attorney and SFPD when the DPA receives a complaint that includes allegations of criminal conduct. (DGO 2.04 was previously silent on this topic.) See DGO 2.04 (III)(B).

- **Quarterly Disciplinary Board.** Requires that each quarter the DPA and SFPD review the previous quarter's sustained, training & policy failure cases & disciplinary trends to recommend any changes to procedures, policy & training. See DGO 2.04 (VII). This provision implements the Department of Justice's October 2016 Collaborative Reform Recommendation to immediately implement the DPA's 2015 recommendation that SFPD & DPA have quarterly meetings to discuss discipline, policy and training issues. (See DOJ Recommendation 64.2<sup>1</sup>)

During the 2<sup>nd</sup> Quarter 2018, the DPA continued its work on enhancing police protocols for Deaf and Hard of hearing individuals. In November 2017, the DPA brought together a group of community stakeholders including deaf individuals to draft a Department General Order (DGO). The DPA initiated this project because of DPA complaint investigations involving deaf complainants in addition to concerns about raised within the Language Access Working Group about deaf domestic violence survivors receiving inadequate services.

Meeting monthly, the Working Group researched best practices, drafted a proposed DGO and created an officer reference guide to use during traffic stops. The Working Group also identified different technologies to assist SFPD officers at the station and in the field to communicate with Deaf and hard of hearing individuals. Representatives from SFPD have also attended the Working Group and contributed to the proposed DGO and officer reference guide.

In May, the DPA and Commander David Lazar met with Chief William Scott to brief him on the progress of the Deaf and Hard of Hearing Working Group, to request authorization for funding for videoconferencing through officers' cell phones for America Sign Language interpreters and an officer training video to accompany the roll-out of the Department General Order. In light of September being National Deaf Awareness month, the DPA has requested that the Deaf and Hard of Hearing DGO be presented to the Police Commission then.

During this quarter, the DPA also successfully advanced its recommendations for officer training on youth. Throughout its years of policy work with youth, the DPA urged the Police Department to provide training designed to address police interactions with youth, including information about the juvenile brain, the impact of trauma on children and youth, and de-

escalation tactics tailored to youth-police interactions.<sup>2</sup> The DPA recommended the Police Department provide training that would assist officers to understand the experiences and challenges of youth—particularly youth of color. DPA also suggested that a core component of this curriculum involve scenario-based training in which recruits, patrol officers, sergeants, and field training officers would learn and practice de-escalation tactics to address common interactions between youth and law enforcement.

Through the DPA’s efforts in partnership with the Youth Commission and SFPD, nationally recognized Strategies for Youth director and law enforcement trainer Lisa Thureau provided SFPD officers a four day Policing the Teen Brain train-the-trainer session.<sup>3</sup> This curriculum is designed to improve police-youth interactions, give officers a better understanding of the teen brain and thought processes and provide tactics for deescalating interactions and avoiding the use of force on teenagers. In the upcoming months SFPD intends for all officers to obtain the Policing the Juvenile Brain training. DPA will continue to monitor the implementation of this important training.

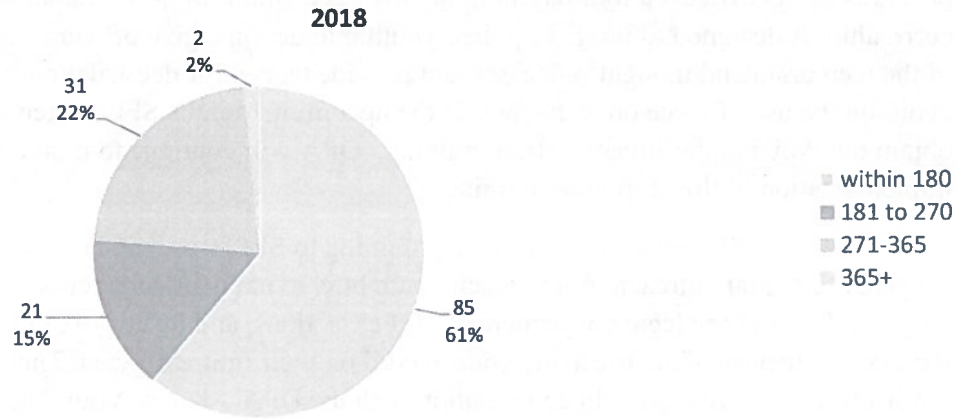
Additionally, Ms. Thureau provided training to SFPD and the DPA staff on Juvenile Jeopardy, a digital outreach tool to teach youth how to navigate interactions with police and peers, understand the legal consequences of their actions, and be aware of the short and long-term consequences of an arrest and court record on their future options. The DPA intends to use the Juvenile Jeopardy game in combination with the DPA’s Know Your Rights for Youth brochure which is being updated as part of its outreach strategy for youth.

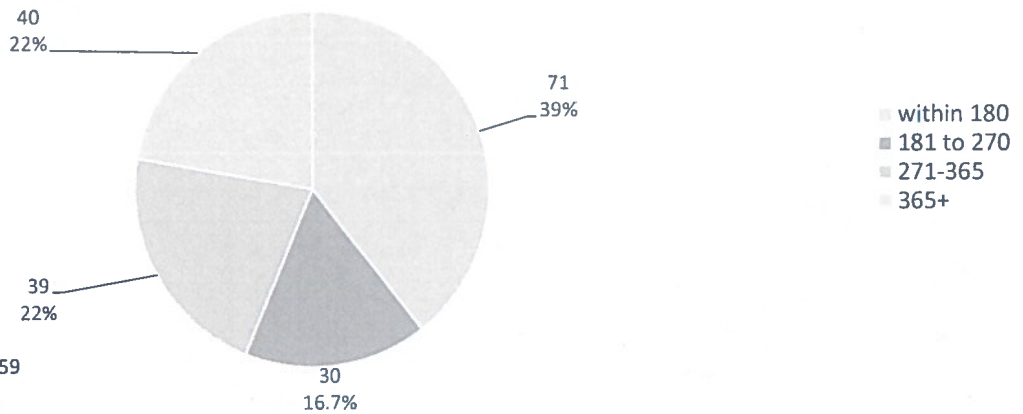

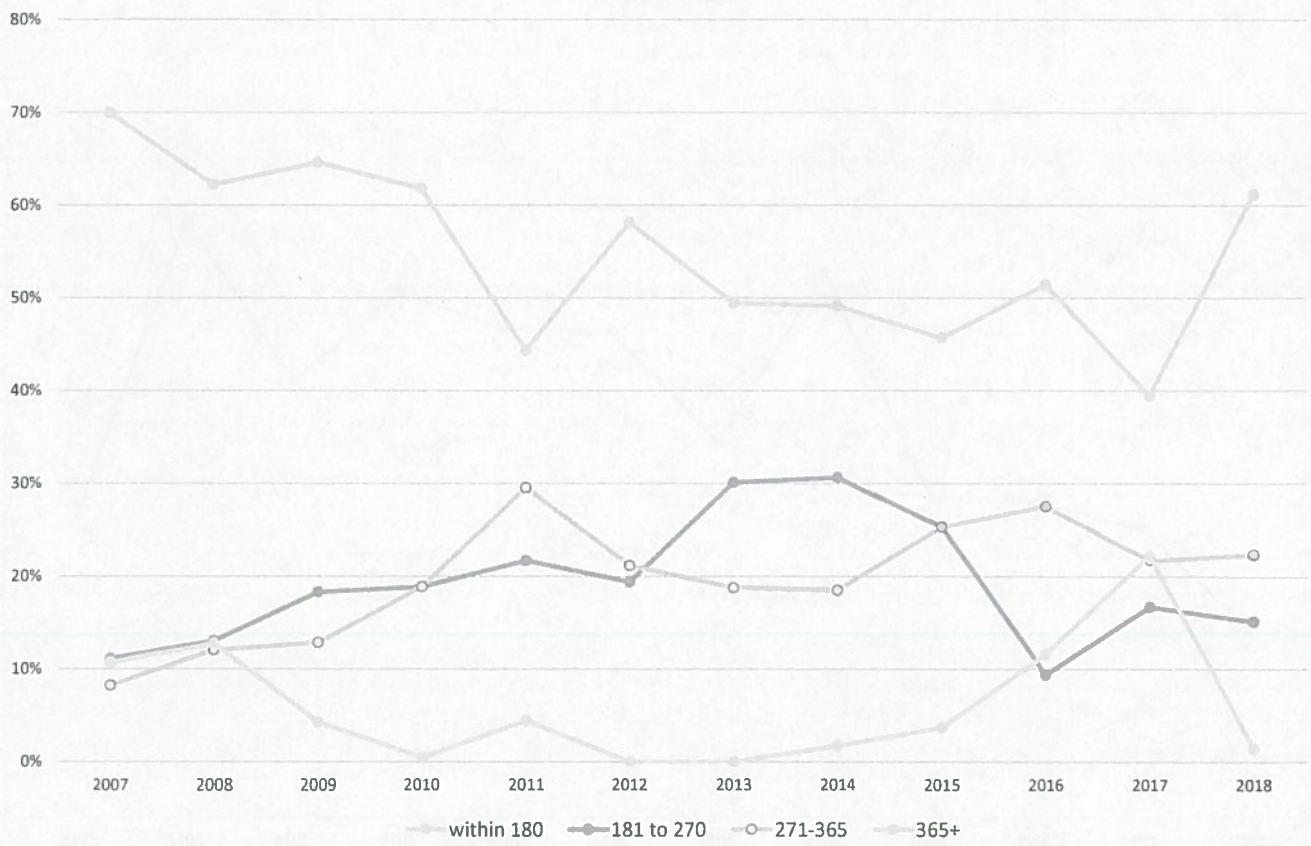

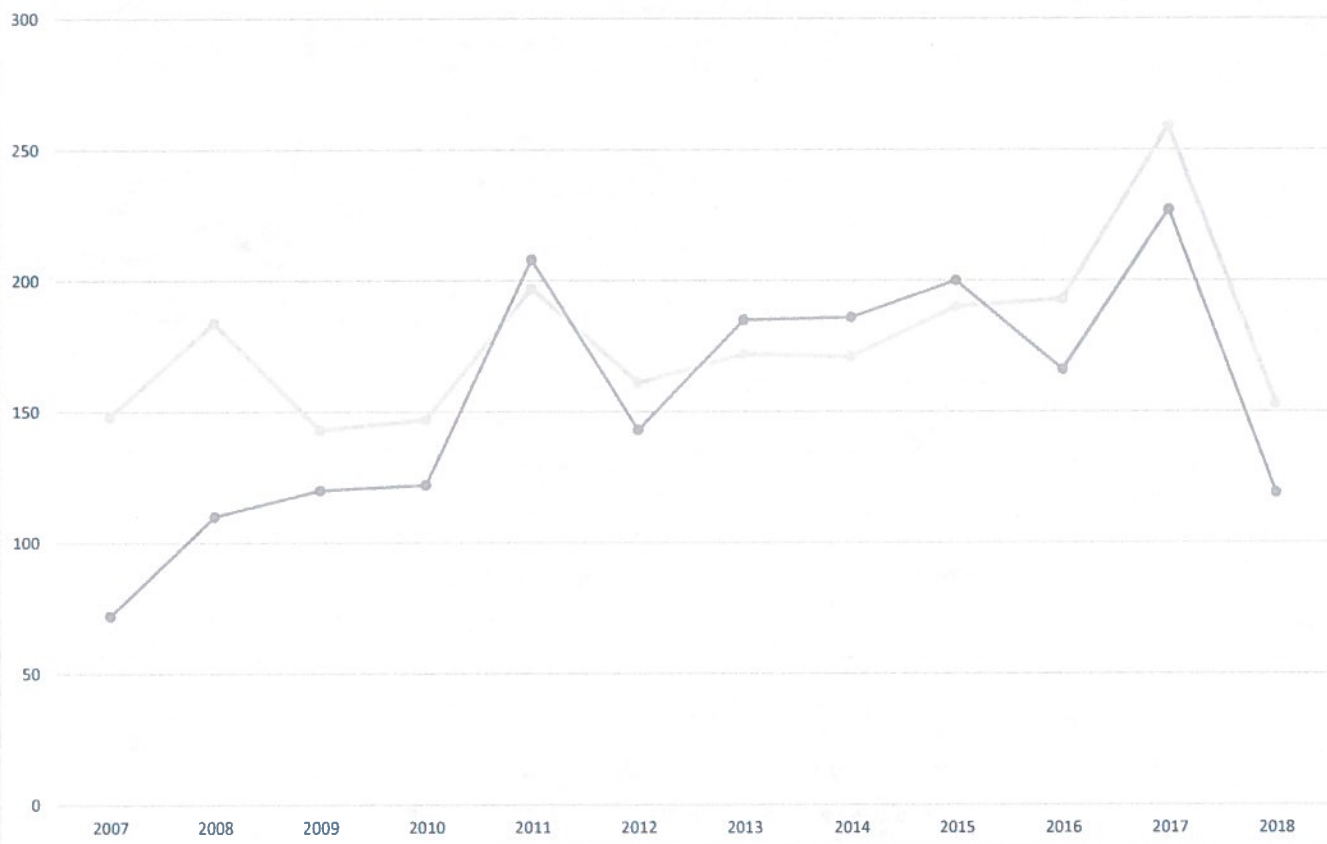




**Days to Close - Cases Closed**

**2007-2018**

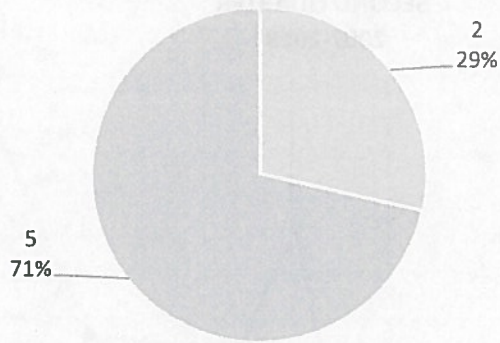


**Cases Closed - Average Days to Close**

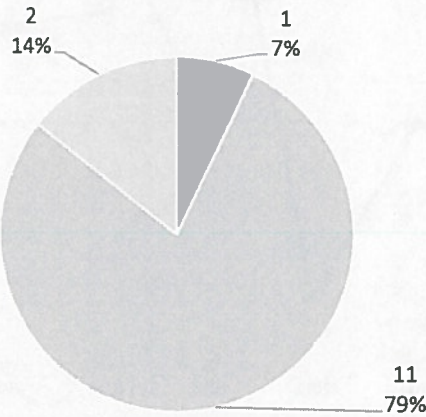

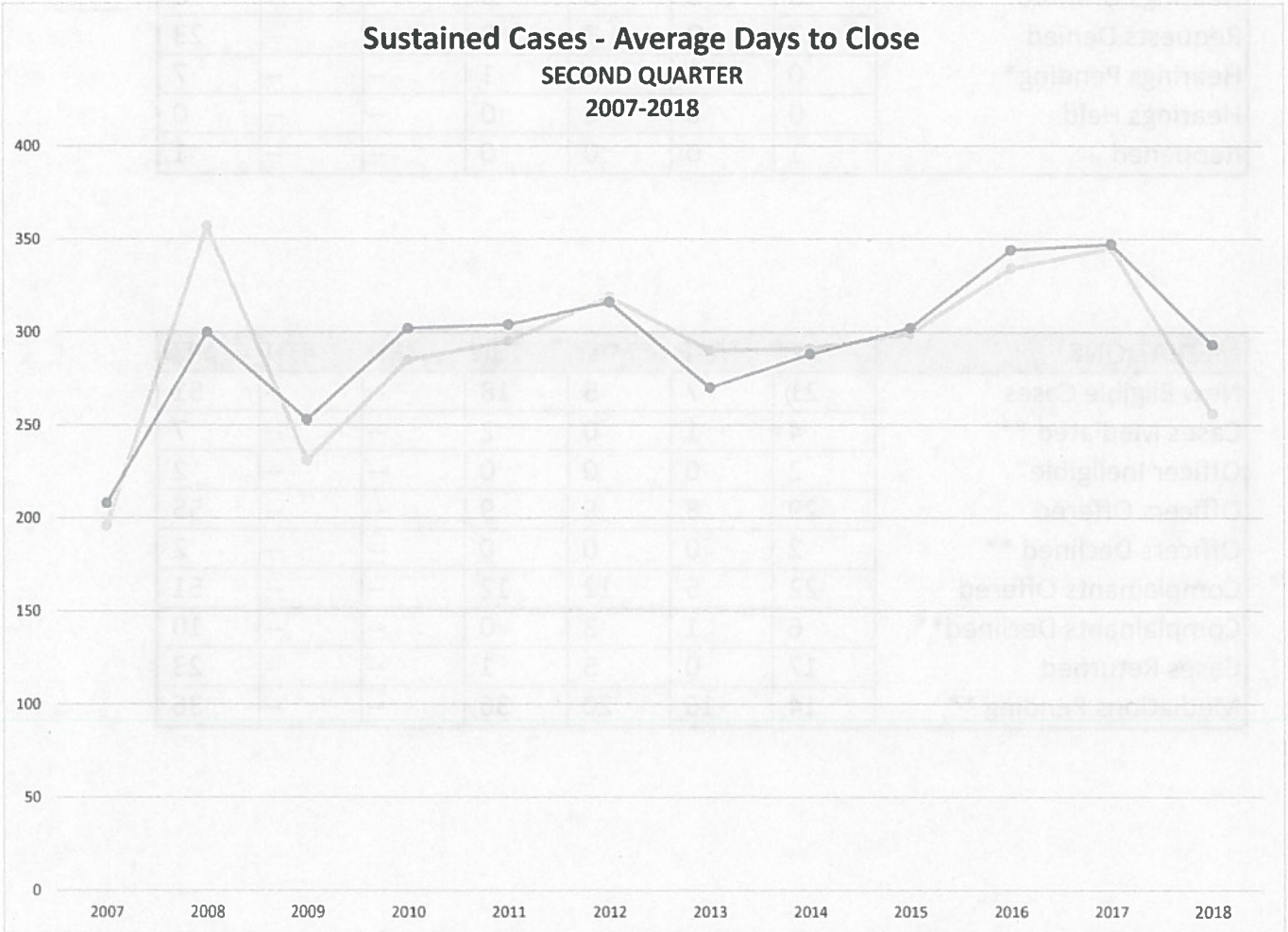

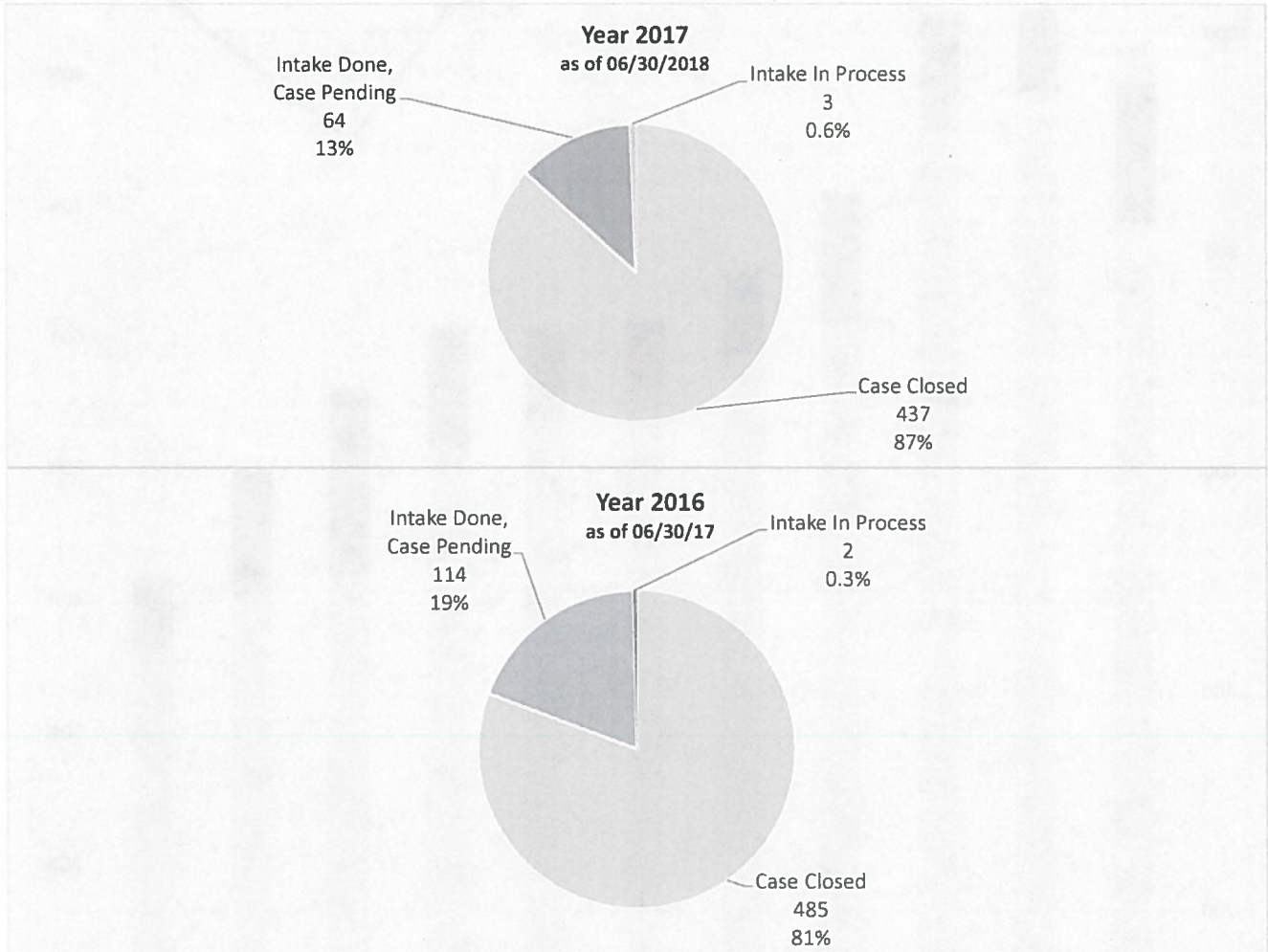

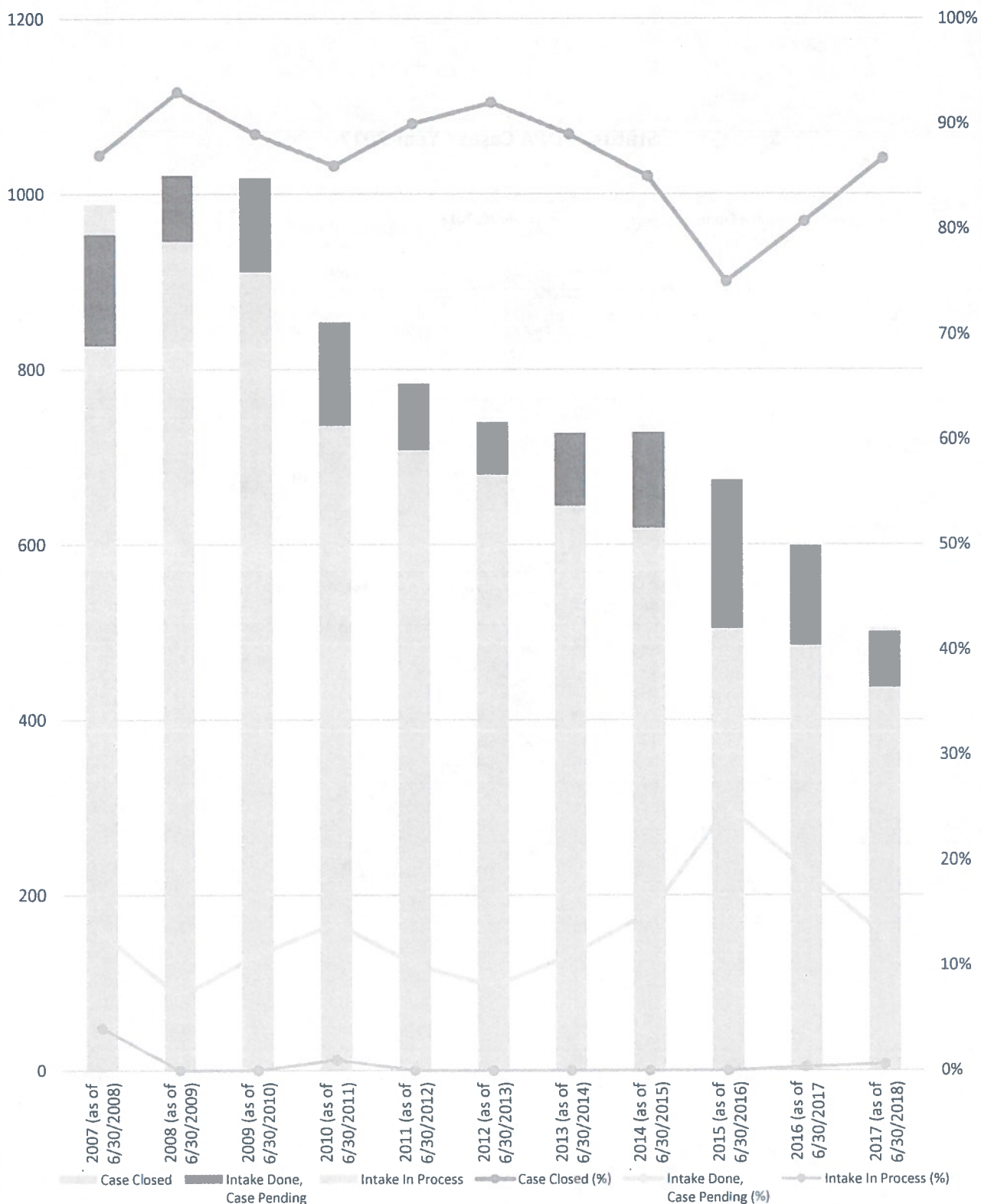

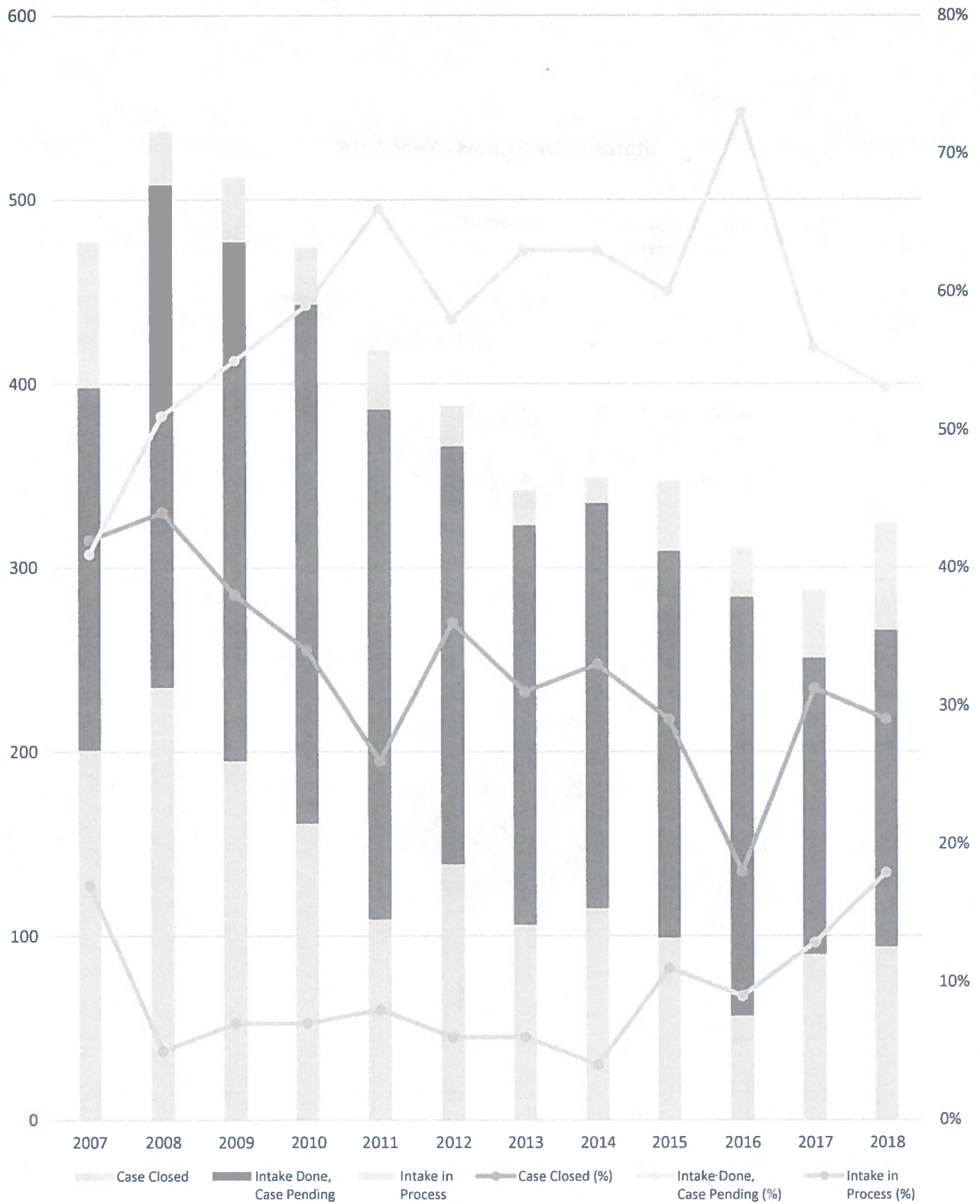

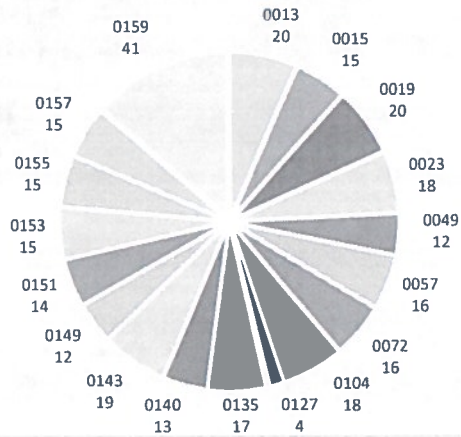

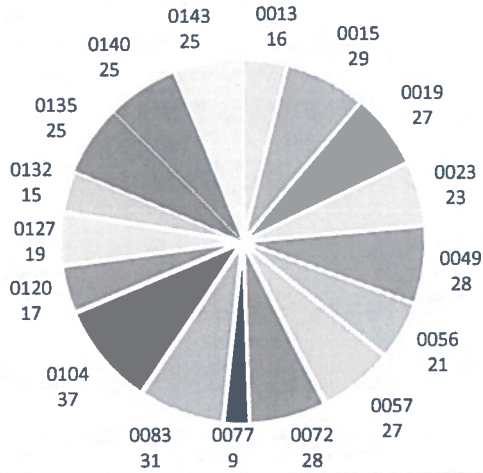

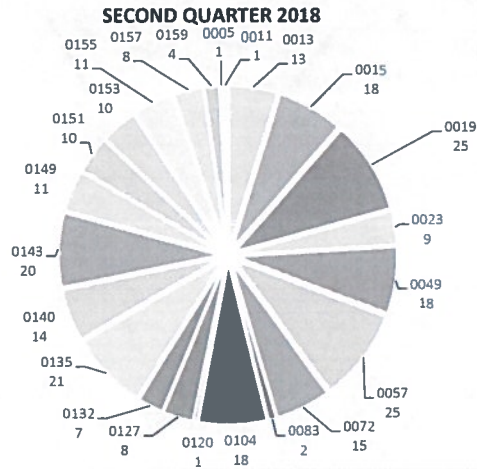

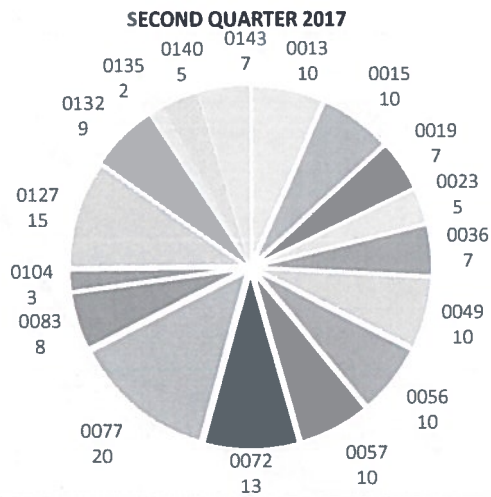




**DPA Case Closures by Investigator  
as of 6/30/2018**



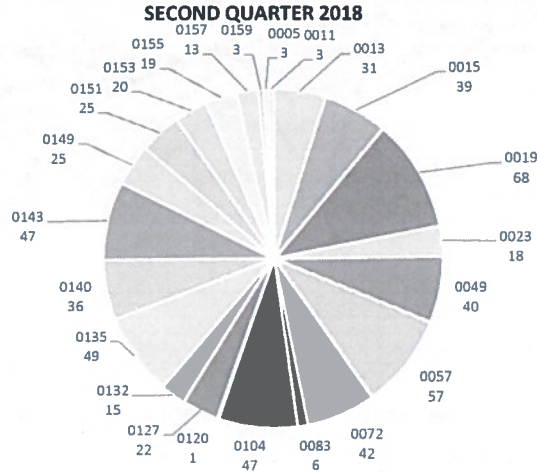

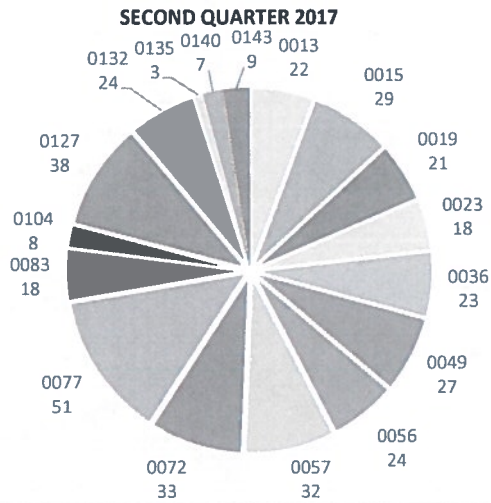

by Investigator**



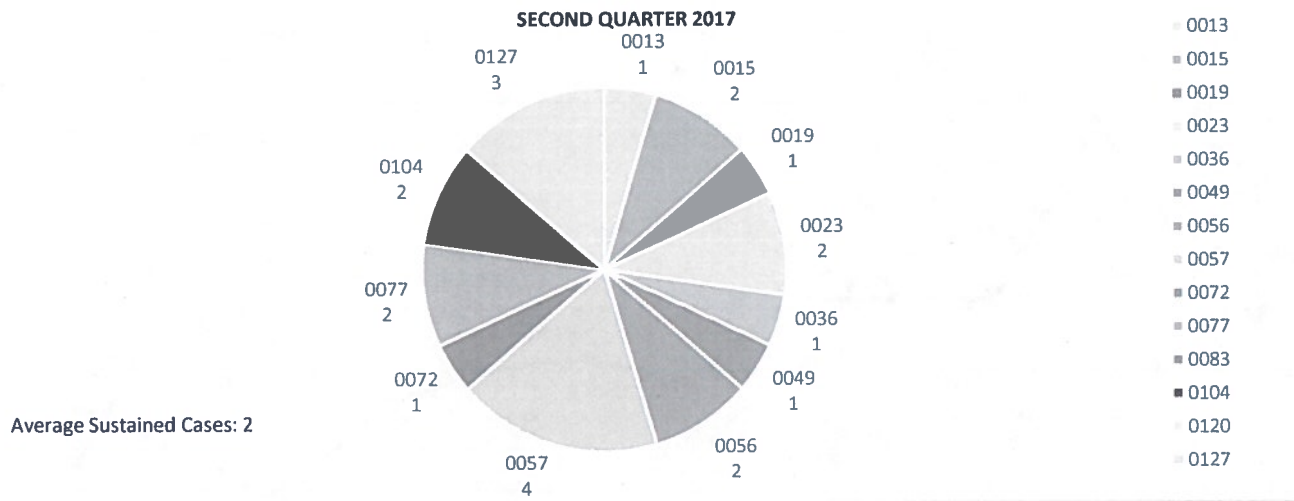
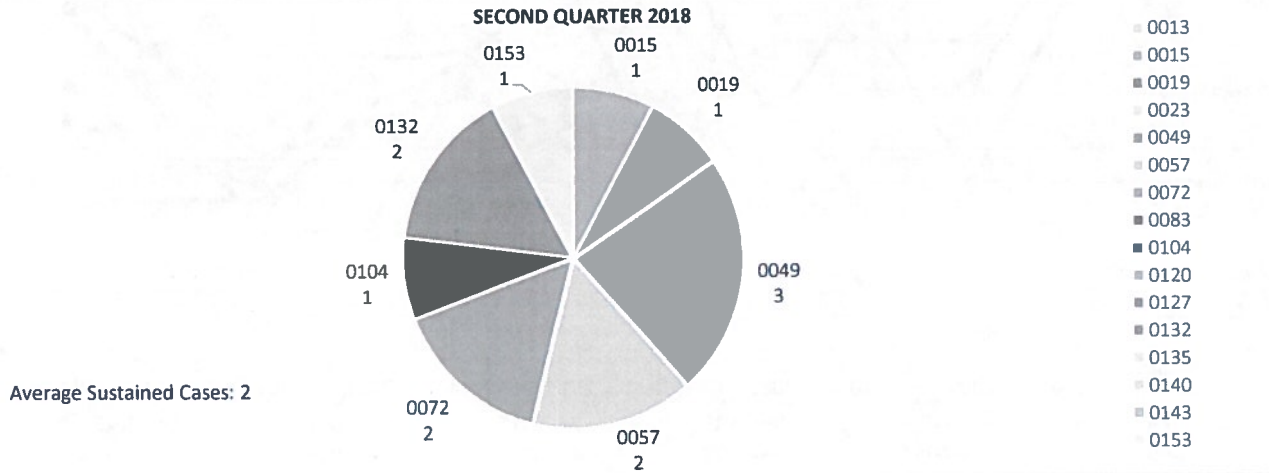
