#### I. INTRODUCTION

Enclosed is the Office of Citizen Complaints' statistical report for the 2014 first quarter. The OCC received an adjusted total of 186 complaints of police misconduct or failure to take action and closed 168 complaints this first quarter. It sustained allegations of misconduct or failure to take action in eight complaints against San Francisco Police officers, which is a 5% sustained rate. The OCC mediated 17 cases, which is a 10% mediation rate.

#### II. ORGANIZATIONAL AND BUDGET MATTERS

#### A. Staffing

The OCC began training one new temporary 8124 line investigator during the first quarter. During this period, 14 permanent line investigators staffed the OCC. There were three line investigator vacancies. One of the line investigators acted as a Senior Investigator continuing to fill the vacancy created when Senior Investigator Erick Baltazar was promoted to the Deputy Director/Chief of Investigations position in August 2013. During the first quarter there was a total of four investigator vacancies, three line investigators (8124) and one Senior Investigator (8126). The OCC's budget provides for 17 line investigators and three Senior Investigators. There are currently 19 employees (17 permanent and 2 temporary) staffing the 21 investigator positions.

San Francisco City Charter section 4.127 provides a floor for investigators of one line investigator for every 150 police officers. With 2116 sworn SFPD members during the first quarter, the floor was 14 line investigators.

During the first quarter, the OCC worked with the Department of Human Resources to develop an 8124 Investigator job announcement. The OCC and DHR anticipate posting the 8124 job announcement during the second quarter. When that recruitment is concluded, the OCC will work with DHR to recruit for the 8126 Senior Investigator position.

#### B. <u>Technology</u>

The OCC's Information Systems Business Analyst, Chris Wisniewski, continued to work with the online complaint form developer through revision and resolution of outstanding obstacles to its deployment. By the end of the third quarter, the form was near completion and its June 30 release appears realistic.

In 2013, the IS Business Systems Analyst developed and completed the OCC's tickler system for investigators, "Auto Prompt". "Auto-Prompt" is a complex system that leverages static data in the OCC's database and file systems to automatically deliver prompts to investigators and supervisors as cases near milestones. During the third quarter, it was fully operational.

#### C. Training

The OCC continued implementing its strategic plan for training its employees. In February, Shannon Martin, a Manager from Superior Court, provided training to the investigators on citations. In March, the OCC staff watched a movie about the Oscar Grant shooting, Fruitvale Station. During the first quarter, six OCC investigators and clerical staff attended training on nonviolent crisis intervention. Additional staff were scheduled to attend the training during the second and third quarters.

#### D. Budget

After consideration by the San Francisco Police Commission, the OCC submitted its proposed budget to the Mayor's Office on February 21, 2014. The Mayor's Office's 2014/2015 and 2015/2016 budget instructions directed City departments to prepare a two year budget for 2014/2015 and 2015/2016 with a 1.5% reduction of general fund support the first budget year and a 1% reduction of general fund support the second budget year. For these reductions, the OCC's targets were \$49,803 for 2014/2015 and \$32,722 for 2015/2016.

The OCC's fiscal year 2014/2015 baseline budget of \$4,994,423.00 includes \$4,512,274.00 in personnel costs. Personnel costs comprise 90% of the OCC's budget. The personnel costs fund 34.75 positions. The remainder of the OCC's budget, \$482,149, is for operations. Of this operations amount, the OCC pays \$307,132 or 64% to the City to rent the OCC's office at 25 Van Ness Avenue.

To meet the 1.5% budget reduction target of \$49, 083 for FY 14/15 and the 1% reduction target of \$32,722 for FY 2015/2016, for a total of \$81,805, the OCC would eliminate an investigator (8124) position. This would reduce journey level investigator positions to 16. The salary plus fringe benefits of an 8124 journey level investigator position is \$130,350. The OCC would use the savings to purchase two hybrid vehicles as one of its two cars was retired in February when its CNG tanks expired and the other's tanks will expire in 2015.

The Mayor's proposed budget is scheduled for release to the Board of Supervisors on June 2, 2014 for consideration and final adoption by July 31, 2014.

#### III. INVESTIGATION OF CASES

#### A. Case Inventory

As of the end of the 2014 first quarter, the OCC opened 188 new cases, and closed 168 cases. During this period, the OCC opened 20 more cases than it closed. The OCC closed the quarter with 333 pending cases, which are 49 more pending cases than the close of the first quarter in 2013. By the end of the 2014 first quarter, there were 147 pending cases from 2014, 180 cases from 2013, four from 2012, and two cases from 2011.

#### B. Caseloads and Disposition of Cases

A 25% increase in complaints filed the first quarter of 2014 versus the first quarter of 2013 resulted in a higher average caseload, 24 cases per investigator versus 20 cases per investigator, both above best practices caseloads for civilian oversight investigators. The average number of days to close cases was decreased by 12% from 162 to 142. The OCC's goal is to conclude its investigations within 270 days. During the first quarter of 2014, OCC investigators closed 168 cases with 83% of them closing within 270 days and only three of them, which had no sustainable allegations, took more than a year to close. This is similar to 2013 where of the 174 cases closed, 85% of them were closed within nine months. While the average number of days to close cases decreased during the first quarter, the average number of days to close sustained cases increased.

#### C. Sustained Cases

The percentage of sustained cases increased in the first quarter of 2014, compared to the first quarter of 2013; a 5% sustained rate in 2014 and a 4% sustained rate in 2013. In the first quarter of 2014, the OCC sustained allegations in eight cases. The average number of days to close sustained cases increased by 55 days or by 22%

for the first quarter of 2014 compared to the first quarter of 2013. In the first quarter of 2014, only one case or 13% of sustained cases was completed within nine months but no sustained cases were completed more than 365 days after its receipt. In the first quarter of 2013, 57% of sustained cases were completed within nine months and no sustained cases were completed more than 365 days after receipt.

The ongoing impediments to prompt completion of sustained cases are attributable to at least four factors: 1) Larger than best practices caseloads for investigators resulting in longer times to complete investigations, 2) Several high profile and complex investigations, 3) active trial calendars for the two prosecuting attorneys who also serve as advice attorneys on sustained cases and sustainability reviews and 4) increased policy work for the policy analyst attorney who also serves as an advice attorney on sustained cases and sustainability reviews.

During the first quarter of 2014, there were sustained allegations of neglect of duty in three of the eight sustained complaints, or 38% of them. Two of these three complaints with sustained neglect of duty allegations, or two thirds of them, were for failure to collect traffic stop data. Sustained complaints for failure to collect traffic stop data comprised 25% of all sustained complaints the first quarter.

Dr. Lorie Fridell in her 2007 study on Fair and Impartial Policing in San Francisco discusses the importance of accurate data collection should a department determine that it will collect traffic stop data.<sup>2</sup> The Chief of Police is imposing progressive discipline for officers who repeatedly fail to collect traffic stop data. The discipline generally begins with an admonishment for the first offense, but for repeated offenses, the Chief of Police has recommended that the OCC prepare charges for him to file with the Police Commission.

Additional allegations sustained include:

- 1. Unwarranted action
  - a. Detaining and searching a complainant and removing his cell phone from his pocket without cause.
  - b. Seizing complainant's guns on two occasions, entering and searching his house, detaining and handcuffing complainant's roommate, and detaining and handcuffing complainant's roommate's girlfriend, all without cause.
  - c. Issuing a citation without cause.
- 2. Conduct reflecting discredit:
  - a. Making rude comments to a taxi fare who didn't want to pay a tip by saying, "I don't play. I have 25 years on the job. I'm not going to mess with a drunk. I'm going to drag your ass to jail. You're

going to sit down at the County Jail and you're going to be cited for defrauding an innkeeper. That means taxi, hotel, gas station, any of that. Do you understand that? You'll be sitting down at the County in orange pajamas going, 'Man, I should've just paid this. I just blew...' How much money did you spend on drinking tonight? And you wouldn't give the guy a dollar? Seriously? Wow! "Is that your word?"

- b. Calling the complainant a coward because the complainant didn't intervene with a violent man who was harassing pedestrians and instead the complainant questioned the lieutenant's physical contact with the violent individual.
- c. In response to the complainant who was cursing the officer, the officer said, "Why don't you come over here and say it to my face?"
- d. Wrongfully ordering a DMV priority reexamination of the complainant's driver's license in apparent retaliation for the complainant's attitude and not because the complainant showed signs of incapacity while committing a traffic violation. Also failing to notify the complainant that if he did not contact the DMV in five days, his license would automatically be suspended causing the DMV to suspend the complainant's license.

#### 3. Neglect of duty for:

- a. Writing an inaccurate incident report.
- b. Failure to comply with DGOs 5.08 by wrongfully conducting a traffic stop while in plainclothes and in an unmarked vehicle.

#### D. Chief of Police's Adjudication of OCC Sustained Cases

When the OCC Director forwards a sustained case to the Chief of Police, she can either recommend that the Chief of Police file charges with the Police Commission and after meeting and conferring with the Police Chief the OCC Director can file charges on her own with the Police Commission if the Police Chief declines her request. Alternatively, the OCC Director can determine that a case warrants ten days or less of suspension. Sustained cases that the OCC Director determines would warrant no more than ten days of suspension are adjudicated by the Chief of Police. The Chief of Police determines whether or not to sustain the OCC's findings and what discipline to impose. During the first quarter, the Chief of Police adjudicated eight OCC sustained cases as follows:<sup>3</sup>

• **Neglect of Duty** – An officer violated Department General Order 1.03 when responding to an incident involving the complainant whose car was

damaged in a traffic accident. The officer failed to notify the Communications Division about the incident. **The officer was admonished.** 

- Neglect of Duty An officer failed to collect traffic stop data. The officer was admonished.
- **Neglect of Duty** An officer violated Department General Order 7.01 when he failed to transmit beginning and ending mileage when transporting a juvenile. **The officer was admonished.**
- Neglect of Duty An officer failed to collect traffic stop data. The officer was admonished.

- Unwarranted Action An officer violated Department General Order 5.03 while looking for a stolen iPhone, when without reasonable suspicion, he detained the complainant and without probable cause, he seized the complainant's cell phone from his shirt pocket. The complainant did not match the description of the suspect and the complainant's phone was not an iPhone. The officer was admonished and retrained.
- Unwarranted Action A sergeant violated the Fourth Amendment to the United States Constitution, Department General Order 5.16, Obtaining Search Warrants and Department General Order 5.03, Investigative Detentions when without a warrant he went to complainant's residence, ordered officers to handcuff complainant's roommate and roommate's guest, searched the complainant's residence and seized two handguns because the landlord observed grow lights and a rifle in the garage. The sergeant received a written reprimand.
- Neglect of Duty An officer failed to issue a certificate of release after detaining, handcuffing, placing the complainant in a patrol vehicle and transporting the complainant to another location, then releasing the complainant from custody. The officer was admonished.

#### IV. COMPLAINTS OF NOTE

#### A. Officer-Involved Shootings

In the first quarter of 2014, the OCC received one complaint regarding the officer-involved shooting of Alejandro Nieto. Four officer involved shootings were under investigation during this first quarter. Of the four officer-involved shooting complaints under investigation, three resulted in the death of the suspects. The four investigations are pending.

#### B. Single Room Occupancy Hotels

During the first quarter of 2014, the OCC continued to investigate two complaints filed in 2011 involving multiple officers regarding unlawful entries and searches of single room occupancy (SRO) hotel rooms. Other allegations in these complaints include unlawful search of persons, unlawful detentions and arrests, failure to properly process property including laptops and cameras, failure to investigate, failure to supervise and inappropriate behavior.

#### C. SFPD Investigation of the Death of a Bicyclist Involved in a Vehicle Collision

In 2013, a complainant alleged SFPD inadequately investigated the death of a bicyclist involved in a vehicle collision. The complainant also alleged a sergeant behaved inappropriately during a rally in the wake of the cyclist's death. The investigation is pending.

#### D. SFPD Investigation of a Missing Person

In 2013, a complainant alleged SFPD inadequately investigated the disappearance of Lynne Spalding, a patient at San Francisco General Hospital who was later found deceased in a stairwell. The investigation is pending.

## E. Officers' Response to Bystander Videotaping Police Officers Contacting an Individual

In 2013, the OCC received several complaints regarding a video taken by a bystander and posted on an Internet site. The video showed the bystander videotaping a contact between an individual and SFPD officers, when the bystander was taken into custody. Allegations in the complaint include the unlawful detention and arrest of the bystander, failure to comply with Department General Order 5.04 (Rights of Onlookers), failure to promptly provide name and star number, use of profanity and inappropriate behavior. The investigation remains pending.

#### F. Valencia Gardens Incident

In 2013, the OCC received two complaints regarding an incident that involved several SFPD officers and residents of the Valencia Gardens housing complex. The complaints allege excessive use of force, unlawful detentions and arrests, unlawful entry and inappropriate behavior. The investigation is pending.

#### G. Complaint Regarding SFPD's Crime Lab

During the first quarter of 2014, the OCC received a complaint from a sexual assault victim who complained about SFPD's failure to promptly process evidence. The investigation is pending.

#### H. City College Incident

During the first quarter of 2014, the OCC received one complaint alleging excessive use of force during a demonstration at San Francisco City College. The investigation is pending.

#### V. STATUS OF CURRENT OCC CASES – THE 'KEANE' REPORT

By the end of the 2014 first quarter, staff had completed intake on all its 2013 cases and had closed 75% of them, leaving 25% of the 2013 cases pending. These statistics are identical to the end of the 2013 first quarter, when staff also completed intake on all its 2013 cases, and had closed 75% of them, leaving 25% of the 2012 cases pending.

#### VI. LEGAL UNIT

Four attorneys staff the OCC's Legal Unit under the leadership of Inés Vargas Fraenkel. Attorney Donna Salazar staffs the OCC's mediation and outreach programs and her work is outlined in sections VII and VIII of this report. Attorney Samara Marion conducts the OCC's policy work and also conducts sustainability reviews and reviews sustained reports for form and legality. Her policy work is outlined in section IX. Ms. Vargas Fraenkel and R. Manuel Fortes are the OCC's two trial attorneys but they also conduct sustainability reviews and review sustained reports for form and legality.

The OCC's trial attorneys prosecute police misconduct cases in matters investigated and determined by the OCC to be misconduct or failure to perform a required action. They present cases to the Police Chief when officers object to proposed discipline of up to ten days suspension. They present cases before the Police Commission when the proposed discipline is greater than ten days suspension up through termination.

During this first quarter, the Legal Unit presented two cases on appeal by officers at the Chief's Hearing level, one with sustained allegations against an officer for profanity, excessive force and failure to identify himself, and the other with a sustained allegation for use of force.

During the first quarter, the Police Commission handled an appeal by an officer from a Chief's level hearing imposition of three days suspension for an illegal detention and use of force. A Police Commissioner conducted a settlement conference that resulted in a settlement that retained the three days suspension and the findings.

As part of their duties, the Legal Unit's two trial attorneys also review and edit sustained reports after a matter has been investigated and one or more allegations are deemed sustainable. During the first quarter, the Legal Unit reviewed, revised, and submitted eight sustained reports, each of which involved one or more allegations against one or more officers.

#### VII. MEDIATION

During the first quarter of 2014, the OCC mediated 17 cases compared to 12 cases in 2013, a 42% increase. The number of cases mediated during the first quarter --17, exceeds the average number of cases closed per investigator -- 10, during the same period by 70%

In January, Donna Salazar, the Mediation Coordinator spoke with a representative of the Dayton, Ohio Police Department regarding a proposed mediation program in that jurisdiction.

In early March, the Mediation and Outreach Coordinator traveled to Los Angeles where she met with officers of the LAPD Internal Affairs Department and the LA City Attorney's office. The Mediation Coordinator addressed an audience of employees from both departments and the volunteer mediators chosen to participate in their new program. The Los Angeles Police Department has consulted with the OCC over the past few years in preparation for the roll out of their Biased Policing Mediation Program.

The Mediation Program continues to provide a forum for officers and civilians to have a frank discussion regarding the complaint, as well as serves as an educational experience for all participants.

#### VIII. OUTREACH

During the first quarter of 2013, the OCC engaged in the following outreach activities:

Director Hicks, who sits on the Board of Directors of the National Association of Civilian Oversight of Law Enforcement (NACOLE), attended a mid-winter meeting to finalize scheduling for the 2014 Conference. She also made a presentation about the OCC's services during the Police Commission meeting held in the Park District neighborhood in February. She participated in a panel discussion on civil oversight of law enforcement at Santa Rosa Community College sponsored by the ACLU in response to the officer involved shooting death of Andy Lopez by a Sonoma County Deputy Sheriff. Director Hicks, Deputy Director Baltazar, and Senior Investigator McMahon attended a community meeting in Bernal Heights on March 25<sup>th</sup> in response to the officer involved shooting death of Alejandro Nieto. The Director also represented the OCC at an event sponsored by the Boalt Hall Women of Color Attorneys where she hosted two Boalt Hall Masters of Laws degree (LLM) candidates, one from China and the other from Nigeria.

Deputy Director Erick Baltazar and Acting Senior Investigator Sherry Fletcher attended a joint session of the Public Safety Committee of the Board of Supervisors and the San Francisco Police Commission where they participated in a conversation about pedestrian deaths.

The OCC Policy Analyst, Samara Marion, participated in activities involving the Youth Commission, SF Women Against Rape, the Domestic Violence Coalition, and the Family Violence Council.

In February, Mediation Coordinator Donna Salazar attended a community function for Black History Month at the Sojourner Truth Family Service Agency in the Sunnydale neighborhood. Lead Attorney Ines Vargas Frankel attended a Police Commission Community Meeting in the Tenderloin in March and gave a presentation about the functions of the OCC.

The Deputy Director and a Senior Investigator offered a presentation to three groups of new officers at the Police Academy in February and March.

During this quarter, the OCC staffed informational tables at one Operation Homeless Connect event and the Family Summer Resource Fair hosted by the City's Department of Children, Youth and Families.

#### IX. POLICY ANALYSIS

Policy work is an essential aspect of the Office of Citizen Complaints' mission. The San Francisco City Charter requires the OCC to present quarterly recommendations concerning SFPD's policies or practices that enhance police-community relations while ensuring effective police services. Attorney and policy analyst Samara Marion leads the OCC's policy work. During the first quarter 2014, the OCC continued its policy work on language access and police protocols for children of arrested parents. The OCC also made recommendations to establish written procedures and training regarding officer-initiated incapacity proceedings against a driver.

Since the adoption of Department General Order 5.20 in 2007, the OCC has worked to enhance the Police Department's language services. The OCC meets monthly with domestic violence and sexual assault service providers, language access advocates, city agencies, and the Police Department, a practice the OCC initiated in 2012 to address on-going language access concerns. During the first quarter 2014, the OCC worked with SFPD and community advocates to complete the officer training video entitled "Investigative Techniques for Overcoming Language Barriers." Using a domestic violence incident involving a Spanish-speaking victim and an elder-abuse incident involving a Cantonese-speaker, this training video identifies the common signs that language assistance is needed. It also addresses how evidence of a dominant aggressor and elder abuse can be overlooked because of a language barrier. Following the Department's posting of the training video on the Internet, the OCC has received inquiries from other agencies about the Department's language access procedures. During the first quarter, the OCC also worked with the Department to finalize Department General Order 7.04 (Children of Arrested Parents). This proposed DGO requires officers to inquire whether the arrested adult has a child for whom the adult is responsible and if so, to follow procedures to ensure the safety and care of the child. The OCC also drafted the script for a video roll call training that the Department and the OCC commenced filming in April. The proposed DGO was heard before the Police Commission on May 7, 2014.

Last, the OCC recommended that the Department adopt written procedures and provide training on officer-initiated driver incapacity proceedings. Vehicle Code § 21061 permits an officer to issue a notice of Department of Motor Vehicle reexamination to a driver who shows signs of mental or physical incapacity while committing a traffic violation. Because officers have to comply with evidentiary and notice requirements to initiate the DMV priority re-examination proceeding and OCC investigations have determined that some officers have initiated these proceeding without cause, the OCC made the following recommendations:

- 1. Require a supervisor's authorization to initiate DMV re-examination of a driver (for both priority re-examination and non-priority re-examination);
- 2. Require the officer initiating the DMV re-examination proceeding to book into evidence a copy of the officer's completed and signed DMV re-examination form;
- 3. Require the officer initiating the DMV re-examination proceeding to document in an incident report the following information:
  - a. the factual basis for the re-examination;
  - b. the time, date, and manner in which the officer provided the driver a written copy of the DMV re-examination form;
  - c. the supervisor who authorized the DMV re-examination; and
  - d. that the officer booked into evidence a copy of the DMV reexamination form.
- 4. Issue a priority "A" Department Bulletin immediately that states the legal standard and notice requirements to initiate a DMV priority re-examination of a driver and includes the three procedures described above.
- 5. Provide training to all officers and recruits consistent with the above-mentioned procedures as soon as the Department Bulletin is issued.

#### X. CONCLUSION

As in the past six years, the OCC faces budget and staffing constraints in the upcoming year that could result in additional case resolution delays; however, the OCC will remain committed to its mission to investigate civilian complaints of police misconduct or failure to perform a duty promptly, fairly, and impartially.



Neglect of Duty	The complainant alleged that the Department failed to disclose a \$100,000 gift from a venture capitalist and sixty (60) laptop computers donated by a computer manufacturing corporation in violation of the disclosure requirements established by the California Fair Political Practices Commission (FPPC).  The OCC investigation determined the Department did not receive the \$100,000 cash gift from the venture capitalist. Instead, the money went from the venture capitalist to a mobile application developer to develop technology in mobile devices that would be used by police officers. Development of the technological application would allow officers to build investigative case files in the field rather than returning to the station in order to prepare them. The company developed a prototype, but as of the closure of this complaint, the Department had not received the prototype. Thus, the Department's reporting obligations have not yet been triggered.  Concerning a gift of sixty laptops, the SFPD notified the Police Commission of the gift of the sixty laptop computers at the July 11, 2012 Police Commission meeting. The Police Commission approved a recommendation to the Board of Supervisors to accept the gift. The gift of the sixty laptop computers has subsequently been listed (around August 2013) on the SFPD website, although the Department did not initially post the gift to its website. The SFPD has now included on its website a section entitled Department Gifts and Donations list and has included donations from 2010-2013.  The investigation also determined that DGO 2.01, titled "General Rules of Conduct," Section 27 (Gifts, Compensation, Rewards) did not adequately address the Department's obligations concerning gifts. On January 23, 2014 the SFPD issued Department Bulletin 14-026 (Protocol and Form for accepting Gifts, Compensation, Rewards). This Department Bulletin updated the Department's procedures by setting forth the San Francisco Administrative Code's requirements for accepting a gift. Pursuant to this Depart



None	None	The OCC recommended that the Department adopt written procedures and provide training on officer-initiated driver incapacity proceedings. Vehicle Code § 21061 permits an officer to issue a notice of Department of Motor Vehicle reexamination to a driver who shows signs of mental or physical incapacity while committing a traffic violation.  Because officers must comply with evidentiary and notice requirements to initiate the DMV priority re-examination proceeding and OCC investigations have determined that some officers have initiated these proceedings without cause, the OCC made the following recommendations:  1. Require a supervisor's authorization to initiate DMV re-examination of a driver (for both priority re-examination and non-priority re-examination).  2. Require the officer initiating the DMV re-examination proceeding to book into evidence a copy of officer's completed and signed DMV re-examination form.  3. Require the officer initiating the DMV re-examination proceeding to document in an incident report the following information:  a. the factual basis for the re-examination,  b. the time, date, and manner in which the officer provided the driver a written copy of the DMV re-examination form,  c. the supervisor who authorized the DMV re-examination; and  d. that the officer booked into evidence a copy of the DMV re-examination form.  4. Issue a priority A Department Bulletin immediately that states the legal standard and notice requirements to initiate a DMV priority re-examination of a driver and includes the three procedures described above.  Provide training to all officers and recruits consistent with the above-mentioned procedures.


# Days to Close - Cases Closed First Quarter 2014




# Days to Close - Cases Closed First Quarter 2013

# Days to Close - Cases Sustained First Quarter 2013










### OCC Caseloads by Investigator as of 03/31/2014







### OCC Caseloads by Investigator as of 03/31/2013






## OCC Case Closures - First Quarter 2014 by Investigator






Average Case Closures by Number: 10 or 3 cases per month per investigator











# OCC Weighted Closures - First Quarter 2014 by Investigator







# OCC Weighted Closures - First Quarter 2013 by Investigator
