Re: Office of Citizen Complaints 2013 Second Quarter Statistical Report

I. INTRODUCTION

Enclosed is the Office of Citizen Complaints' statistical report for the 2013 second quarter. The OCC received an adjusted total of 186 complaints of police misconduct or failure to take action and closed 176 complaints in the second quarter. Between January 1, and June 20, 2013, the OCC opened an adjusted total of 332 complaints and closed 350 complaints. In the second quarter it sustained allegations of misconduct or failure to take action in seven complaints against San Francisco Police officers, which is a 4% sustained rate. The OCC mediated 12 cases, which is a 7% mediation rate.

II. ORGANIZATIONAL AND BUDGET MATTERS

A. Staffing

During this period, 13 journey level investigators staffed the OCC because two investigators were on extended leaves of absence and one new investigator was in training.

B. Training

The OCC continued implementing its strategic plan for training its employees. In May, the OCC staff watched the movie, *Heroes Behind the Badge*, to develop an understanding of officers' risks in critical incidents.

C. Budget

The Mayor released the 2013/2014 budget to the Board of Supervisors on May 31, 2013 for consideration and final adoption by July 31, 2013. The Mayor's proposed

budget enhanced the OCC's 2012/2013 baseline budget of \$4,602,850.00 to provide for increased overhead cost and it also provided funding to replace the OCC's two 14-year old cars. The Board of Supervisors Budget and Finance Committee held budget hearings for the Public Safety Departments on June 19 and June 26. The Committee recommended that the OCC's cars be neither replaced nor retired because in spite of their old age, the mileage was low. Additionally, the Committee recommended budget reduction equal to a three months attrition savings for the vacant Deputy Director/Chief Investigator position because the Director did not anticipate filling it until August.

D. Technology

The OCC Information Systems Business Analyst, Chris Wisniewski, continues to work on two significant technology projects, the first will enhance the OCC's customer service for complainants, online complaint filing, and the second, an auto-prompt system that will enhance investigator case management by leveraging static data in OCC databases to automatically deliver reminder prompts to investigators as cases near deadlines. While with the assistance of an outside developer, the OCC has made significant progress on the online complaint filing project, challenges have included whether the website will be hosted internally or externally with a final resolution of internal hosting through the Department of Technology for security purposes. Chris Wisniewski is developing the auto-prompt system without the assistance of a developer. The estimated time for completion on both these projects is December 2013.

III. INVESTIGATION OF CASES

A. Case Inventory

As of the end of the 2013 second quarter, the OCC opened 332 new cases, and closed 350 cases. During this six-month period, the OCC closed 18 more cases than it opened. The OCC closed the quarter with 299 pending cases, which are 26 less pending cases than the close of the second quarter in 2012. By the end of the 2013 second quarter, there were 236 pending cases from 2013, 61 pending cases from 2012 and 2 pending cases from 2011.

B. Caseloads and Disposition of Cases

A 14% decrease in available investigators the second quarter of 2013¹ versus the second quarter of 2012 resulted in a higher average caseload, 21 cases per investigator versus 19 cases per investigator. The average number of days to close cases increased 6% from 161 to 172. The OCC's goal is to conclude its investigations within 270 days. During the second quarter of 2013, OCC investigators closed 176

cases with 79% of them closing within 270 days and only three took more than a year to close.² This is similar to the second quarter of 2012 where of the 227 cases closed, 78% of them were closed within nine months.

C. Sustained Cases

The sustained rate was four percent for the second quarter of 2013 and five percent for the second quarter of 2012. In the second quarter of 2013, the OCC sustained allegations in seven cases. The number of days to close sustained cases decreased by 9% for the second quarter of 2013 compared to the second quarter of 2012. In the second quarter of 2013, the percentage of sustained cases completed within nine months increased to 71% compared to 16% in the second quarter of 2012. In the second quarter of 2013, all sustained cases were completed within 365 days compared to one sustained case completed more than 365 days after its receipt in the second quarter of 2012.³

As with previous quarters, the ongoing impediments to prompt completion of sustained cases are attributable to at least three factors: 1) Larger than best practices caseloads for investigators resulting in longer times to complete investigations⁴ 2) active trial calendars for the two prosecuting attorneys who also serve as advice attorneys on sustained cases and sustainability reviews and 3) increased policy work for the policy analyst attorney who also serves as an advice attorney on sustained cases and sustainability reviews.

During the second quarter of 2013, there were sustained allegations of neglect of duty in six of the seven sustained complaints, or 86% of them. One of these six complaints with sustained neglect of duty allegations, or 17% of them, were for failure to collect traffic stop data. Sustained complaints for failure to collect traffic stop data comprised 14% of all sustained complaints the second quarter.

Dr. Lorie Fridell in her 2007 study on Fair and Impartial Policing in San Francisco discusses the importance of accurate data collection should a department determine that it will collect traffic stop data.⁵ The Chief of Police is imposing progressive discipline for officers who repeatedly fail to collect traffic stop data. The discipline generally begins with an admonishment for the first offense, but for repeated offenses, the Chief of Police has recommended that the OCC prepare charges for him to file with the Police Commission.

Additional allegations sustained include:

1. Conduct reflecting discredit for incorrectly telling a mother that if the mother were arrested her four-year old child would be taken into custody by Child Protective Services, when SFPD's policy is to release children to the noncustodial parent. Additional inappropriate comments included telling the mother that her 8-year old son, also a suspect, could go to jail, when SFPD's policy is to refer children younger than 11 years to Child Protective Services.
2. Neglect of duty for:
 - a. Failure to advise Dispatch of the officer's location and a detention of a person resulting from an on-view theft of recyclables.
 - b. Failure to comply with Department General Order 5.20 when interacting with a limited English proficient Spanish speaker.
 - c. Providing incomplete Miranda admonitions to two juvenile suspects.
 - d. Failure to obtain a waiver from two juvenile suspects that they understood and waived their Miranda rights.
 - e. Failure to advise the juveniles' father that he could be present during the questioning.
 - f. Failure to comply with Department General Order 7.01 when arresting a juvenile by ordering that he be taken to the district station instead of contacting the probation officer at the Community Assessment and Referral Center who would have determined whether the juvenile should be booked at the Juvenile Justice Center, cited to CARC or to Juvenile Court.
 - g. Failure to supervise subordinates on the application of Department General Order 5.20 (Language Access) and by allowing a subordinate to threaten a mother in contravention of the Department's policy on the release of juveniles to noncustodial parents.
 - h. Mislacing an arrestee's identification card.
 - i. Failing to provide a court date on a citation.
 - j. On at least two occasions, parking a marked police vehicle in the bicycle lane in front of Fox Plaza when attending a nonemergency meeting.
3. Unwarranted Action
 - a. Unlawfully entering a residence
 - b. Damaging property by kicking in a door during an unlawful entry
 - c. Arrest without cause
4. Unnecessary Force

After unlawfully entering a residence, and without reasonable suspicion or probable cause, grabbing, detaining and pulling a juvenile outside his home and taking him to the ground.

D. Chief of Police's Adjudication of OCC Sustained Cases

When the OCC Director forwards a sustained case to the Chief of Police, she can either recommend that the Chief of Police file charges with the Police Commission and after meeting and conferring with the Police Chief the OCC Director can file charges on her own with the Police Commission if the Police Chief declines her request. Alternatively, the OCC Director can determine that a case warrants ten days or less of suspension. Sustained cases that the OCC Director determines would warrant no more than ten days of suspension are adjudicated by the Chief of Police. The Chief of Police determines whether or not to sustain the OCC's findings and what discipline to impose. During the second quarter, the Chief of Police adjudicated nine OCC sustained cases as follows:⁶

- **Neglect of Duty** – in violation of Department General Orders 1.03, Attention to Duty and 2.01, On-Duty Written Reports and the SFPD Report Writing Manual, an officer failed to prepare an incident report after the complainant advised the officer that the complainant had been punched on a Muni bus. The bus driver reported the alleged assault to Dispatch. The officer advised that he did not prepare an incident report because the complainant left the scene before the officer finished interviewing him. The officer was provided sufficient information to prepare a report. **The officer was admonished.**
- **Neglect of Duty** – in violation of Department General Order 5.03, an officer failed to issue a certificate of release after handcuffing the complainant. **The officer was admonished.**
- **Discourtesy and Conduct Reflection Discredit** – in violation of Department General Order number 2.01, paragraphs 9 and 14, Misconduct and Public Courtesy, sergeant used uncivil language when the complainant requested assistance. **The sergeant was suspended.**
- **Neglect of Duty** – during contact with an elderly woman whom a sergeant observed removing recyclables, the sergeant failed to remain in constant radio contact with Dispatch in violation of Department General Order 1.04, A., 4. **The sergeant was admonished**
- **Neglect of Duty** – in violation of San Francisco Police Department Bulletin 12-088 and Vehicle Code section 40500 (a) an officer failed to provide an appearance date on a citation. **The officer was admonished.**

- **Unwarranted Action and Unnecessary Force** – A sergeant and officers engaged in an unlawful warrantless residential entry, unlawful arrests, and used unnecessary force when they entered the complainant’s private residence in pursuit of an individual whom the sergeant and officers suspected of a homicide committed three weeks earlier. The entry into the complainant’s home lacked both probable cause and an exigency. The sergeant and the officers violated Department General Orders 5.03, A. Reasonable Suspicion, 2.01, Maintaining Knowledge, 5.16, Obtaining Search Warrants and the Fourth Amendment of the United States Constitution. **The sergeant was suspended and the officers were admonished.**
- **Neglect of Duty, Failure to Take Action and Conduct Unbecoming** – During a bicycle theft sting, a sergeant and officers violated Department General Orders 7.01, Interactions with Juveniles, 5.20, Language Access, Rules of Conduct, 2.01, and 1.04, Duties of Sergeants, and state and federal law. The sergeant provided incomplete Miranda admonitions to the two juvenile suspects by failing to inform them that if they could not afford an attorney one would be appointed free of charge before any questioning. The sergeant also failed to obtain a waiver that the juveniles understood and waived their Miranda rights. The sergeant failed to advise the juveniles’ father that he could be present during the police questioning. The sergeant also told the 8-year old suspect he could be taken to jail which is contrary to Department General Order 7.01 that specifically requires children under the age of eleven suspected of criminal wrongdoing be brought to Child Protective Services. The sergeant also failed to obtain an interpreter when conversing with the juveniles’ mother. Finally, the sergeant failed to follow post-arrest procedures for a juvenile. Department General Order 7.01 establishes that officers should avoid bringing juveniles to the district station. DGO 7.01, Department Bulletin 10-220, and SFPD Form 531 instruct officers that upon the arrest of a juvenile, officers shall phone the probation officer at the Community Assessment and Referral Center (CARC) who will determine whether the juvenile should be booked at the Juvenile Justice Center, cited to CARC, or cited to Juvenile Court. The sergeant instead ordered the sergeant’s subordinates to transport the juvenile to the district station. The sergeant also failed to supervise subordinates by failing to require them to comply with the Department’s language access and juvenile protocols and misrepresenting the Department’s policy concerning the arrested parent’s right to choose the placement of her child.

An officer made inappropriate comments by misstating the Department’s policy on placement of an arrested mother’s child by threatening to have

her four-year old sent to Child Protective Services instead of placing her in the custody of her father, who was neither a suspect nor present during the sting. An officer also failed to obtain an interpreter for the mother who was a Spanish speaker. An officer who was not certified to speak Spanish serviced as an interpreter in violation of Department policies and an officer failed to note in the incident report that the complainant's primary language was Spanish. **The sergeant and officers were admonished.**

- **Neglect of Duty** –In violation of Department General Order 6.15 an officer failed to process property properly by misplacing the complainant's identification card during the arrest and booking process. Once the officer received notice of the complaint, the officer located the card and returned it to the complainant. The complainant was without his identification card for almost seven weeks. **The officer was admonished.**
- **Neglect of Duty** – an officer failed to collect traffic stop data. **The officer was suspended.**⁷

IV. COMPLAINTS OF NOTE

A. Single Room Occupancy Hotels

During the second quarter, the OCC continued to investigate two complaints filed in 2011 involving multiple officers regarding unlawful entry and searches of single room occupancy (SRO) hotel rooms. Other allegations in these complaints include unlawful search of persons, unlawful detentions and arrests, failure to properly process property including laptops and cameras, failure to investigate, failure to supervise and inappropriate behavior. The investigations remain open pending action by federal authorities

B. Officer Involved Shootings

The OCC investigated five officer-involved shootings during the second quarter. Four of these shootings resulted in the death of the suspect. At the end of the second quarter, the OCC continued to investigate three officer-involved shootings. During the second quarter, the OCC closed two officer-involved shootings with no sustainable allegations but in one case made several policy recommendations.

V. STATUS OF CURRENT OCC CASES – THE ‘KEANE’ REPORT

By the end of the 2013 second quarter, staff had completed intake on all its 2012 cases and had closed 92% of them, leaving 8% of the 2012 cases pending. These statistics are similar to the end of the 2012 second quarter, when staff also completed intake on all its 2011 cases, and had closed 90% of them, leaving 10% of the 2011 cases pending. For complaints filed in 2013, by the end of the second quarter, the OCC had closed 31% of them, intake was in process for 6% of them and there were 217 pending cases or 63% of them. By the end of the second quarter 2012, the case status statistics for cases filed that year were similar to the 2013 statistics.

VI. CASE MANAGEMENT

The investigator caseload as of June 20, 2013 shows a slight increase from the same period in 2012. The number of journey level investigators, 13 at the close of the second quarter in 2013 contributed to an increased caseload in the second quarter of 2013. Unlike the first quarter of 2013, which showed a 25% decrease in case filings over the first quarter of 2012, the rate of case filings increased in the 2013 second quarter with a 12% decrease in case filings compared to the second quarter 2012. The average caseload as of June 30, 2013, was 21 cases per investigator. As of June 30, 2012, the average caseload was 19 cases. In its 2007 audit of the OCC's operations, the City Controller concluded that an average of 16 cases was a best practices caseload for investigators of police misconduct. As with previous quarters, the Deputy Director/Chief Investigator and the Senior Investigators continued to take a very active role in monthly case reviews, monitoring caseloads and assuming investigative responsibility in selected cases.

VII. LEGAL UNIT

Four attorneys staff the OCC's Legal Unit. Ines Vargas Fraenkel leads the Legal Unit. Attorney Donna Salazar staffs the OCC's mediation and outreach programs and her work is outlined in sections VIII and IX of this report. Attorney Samara Marion conducts the OCC's policy work and also conducts sustainability reviews and reviews sustained reports for form and legality. Her policy work is outlined in section X. Ms. Vargas Fraenkel and R. Manuel Fortes are the OCC's two trial attorneys but they also conduct sustainability reviews and review sustained reports for form and legality.

The OCC's trial attorneys prosecute police misconduct cases in matters investigated and determined by the OCC to be misconduct or failure to perform a required action. They present cases to the Police Chief when officers object to proposed discipline of up to ten days suspension. They present cases before the Police

Commission when the proposed discipline is greater than ten days suspension up through termination.

During this second quarter, the Legal Unit presented no hearings at the Chief's Hearing level.

The Legal Unit maintained three Police Commission cases in its inventory during the second quarter. In one case, the Legal Unit reached a tentative settlement during the previous quarter for the imposition of a 15-day suspension on the officer as well as transfer from his current assignment, pending Police Commission approval. During the second quarter, the Police Commission approved the settlement. In another case involving an officer's appeal to the Police Commission of discipline he received at the Chief's Hearing level, the officer withdrew his appeal and the Police Commission approved the withdrawal.

Three of the Legal Unit's attorneys, the two trial attorneys and the policy analyst attorney review and edit sustained reports after a matter has been investigated and one or more allegations are deemed sustainable. During the second quarter, these three attorneys reviewed, revised, and submitted seven sustained reports and drafted and submitted one policy recommendation report, each of which involved one or more allegations against one or more officers.

VIII. MEDIATION

The OCC mediated twelve cases during the second quarter of 2013, compared to twenty-three cases during the second quarter of 2012, when the program had two record months for cases mediated. At the end of the second quarter, the OCC has mediated twenty-four cases as compared to thirty-six in 2012.

Officer participation declined during the first half of 2013. By the end of the second quarter of 2013, nearly 14% of officers declined to mediate compared to 7% in 2012. An informal poll of officers who declined to meet indicated they declined due to the circumstances of the particular case rather than a reluctance to mediate.

In April, Donna Salazar, the Mediation Coordinator addressed a class of new mediators at the Community Boards Spring training.

The Mediation Program continues to provide a forum for officers and civilians to have a frank discussion regarding the complaint as well as serves as an educational experience for all participants.

IX. OUTREACH

During the second quarter of 2013, the OCC was engaged in the following outreach activities:

In April, Director Hicks spoke with a representative of the Seattle Police Department about the benefits of fair and impartial policing training. Also in April, at U.C. Berkeley, Director Hicks participated on a Cal Alumni Association panel on “Careers that Matter”. Later that month, she participated in a U.C. Berkeley School of Law, Boalt Hall, Women of Color Collective networking event where she described the OCC’s services. She has described the OCC’s services during the Police Commission’s May meeting in the Ingleside District neighborhood.

OCC staff made a presentation regarding the services it offers to a group at the Center for Juvenile and Criminal Justice. In June, staff members staffed informational tables at the Bayview Connect as well as a Career Day for Youth sponsored by the Chief.

The Mediation Coordinator made presentation to mediation classes at Community Boards and UC Berkeley. She also attended the Community Boards Peacemaker Awards Luncheon as well as an event sponsored by Peninsula Conflict Resolution Services.

Additionally, OCC staff provided brochures and complaint forms to La Raza Central Legal, the La Raza Community Center, Community United Against Violence, two offices of the Mission Resource Center, the Instituto Laboral de la Raza, Arriba Juntos, the SF Public Defender’s office, the Mayor’s Office of Neighborhood Services, the ACCESS Center, the Jewish Vocational Center, Asian Pacific Islander Outreach, the Asian Law Caucus, Chinese for Affirmative Action, and the Southern, Mission, Central District Police Stations.

X. POLICY ANALYSIS

Policy work is an essential aspect of the Office of Citizen Complaint’s mission. The San Francisco City Charter requires the OCC to present quarterly recommendations concerning SFPD’s policies or practices that enhance police-community relations while ensuring effective police services. Attorney and policy analyst Samara Marion leads the OCC’s policy work. During the second quarter 2013, the OCC continued its policy work in the areas of use of force, language access, and vehicle pursuits.

Since the adoption of Department General Order 5.20 in 2007, the OCC has worked with the Police Department to enhance its language services. For many years the OCC has advocated for a communications system that would enable 911

dispatchers to immediately identify the location and availability of bilingual officers to respond to LEP calls for service. The OCC researched communication systems and met with numerous staff from SFPD and the Department of Emergency Management (DEM) to explore how to incorporate this capability. Beginning in February 2012, the OCC held monthly meetings with representatives from SFPD, DEM, the District Attorney's Office, and domestic violence and language advocates to collaborate on language access projects, including an enhanced communications system. During the first quarter of 2013, SFPD provided the Department of Emergency Management the necessary data to identify officers with specialized skills such as bilingual abilities, Crisis Intervention Team training, and Hostage and Negotiation Team certification. In April 2013, following the training of all 911 dispatchers, this new feature became operational. With this new capability, now when an LEP reportee or SFPD officer needs language assistance, dispatchers can identify immediately whether a bilingual officer is available or whether language assistance should be requested through a telephone interpreter.

During the second quarter, the OCC's policy work also focused on enhancing the Department's use of force protocols, particularly concerning incidents involving mentally ill individuals in crisis. In an officer-involved shooting that resulted in the death of a mentally ill individual, the OCC made the following policy and training recommendations:

1. Amend Department General Order 3.10 to require that the Department's Training Division provide a written analysis in each officer-involved shooting and discharge that is included in the Department's administrative investigative report for consideration by the Firearm Discharge Review Board. This training analysis shall evaluate the incident from the moment of the officer's deployment to the conclusion of the incident and address the topics of tactics/decision-making, drawing or exhibiting a firearm, and use of force. It will explain how officers are trained with respect to the tactical issues that are presented in the incident, evaluate whether the officer(s) performed consistent with training, and make recommendations concerning the training needs of the involved officers and/or the Department in general. The analysis will evaluate the officer's actions preceding the use of force and address whether the officer took unnecessary, overly aggressive, or improper actions that contributed to the need to use deadly force. The training analysis shall also address topics such as planning, supervision, communication and choice of weapons.
2. Amend Department General Order 3.10 to include the officer-in-charge of the Department's Training Division as an advisory member of the Firearm Discharge Review Board.

3. Amend Department General Order 3.10 to include more specific use of force finding categories including training failure, policy failure, supervision failure, tactical debrief and administrative disapproval.
4. Require a sergeant or officer of higher rank to respond to any call involving an armed subject. Develop a protocol with the Department of Emergency Management so that dispatchers immediately notify a sergeant or officer of higher rank when the dispatch receives a call concerning an armed subject.
5. Immediately implement scenario-based training that addresses de-escalation and decision-making tactics for encounters with emotionally disturbed individuals with bladed weapons. A significant number of the Department's officer-involved shootings have involved emotionally disturbed individuals with bladed weapons. As police leaders recently acknowledged, these cases are particularly challenging because of the difficulty in assessing the level of danger. Individuals in crisis may appear threatening or uncooperative when in fact they are unable to understand an officer's questions or orders. Confrontational tactics such as boxing a suspect in or making direct eye contact can actually escalate the situation and pose a greater safety risk to the officer.⁸

Since 2010, the OCC has recommended that the Department's subject matter experts in patrol procedures, tactics, and behavioral health review the Department's officer-involved shooting incidents involving mentally ill individuals to develop training that addresses these high risks calls. This scenario-based training should require officers to make split second decisions about best tactics, including whether it is tactically prudent to apprehend or contain an emotionally disturbed individual with a bladed weapon. Issues of de-escalation tactics, tactical planning, communication, coordination, assessment of threat, officer-safety, and use of force options should be integrated throughout this training.

6. Develop with the Department of Emergency Management (DEM) a list of questions dispatchers will ask to determine whether the call involves an individual with a mental illness and to obtain key information about the individual's mental illness.
7. Revise Department General Orders 6.14, 8.02, 8.01 to establish written protocols for the Department's Crisis Intervention Team (CIT) program, including its procedures for training and dispatching CIT officers as first

responders to mental health crisis calls and to also include the Department's philosophy and procedures for handling encounters with mentally ill persons in crisis.

8. Implement the Department's 2011 obligation to design a data collection system to review and evaluate mental health crisis calls and SFPD's responses to such incidents.
9. Amend the Department's officer-involved shooting procedures to include the Chief's designation of an on-site commander to act as a liaison between the Department and the family of the individual injured or killed and also between the Department and the community.⁹ This commander's responsibilities shall include:
 - providing timely information to the family of the individual who was shot;
 - notifying the Department of Public Health (or other relevant Department) for immediate or follow-up crisis support services for impacted individuals such as family members of the individual who was shot, witnesses, and bystanders;
 - obtaining language assistance for involved or impacted individuals whom the Department is interviewing in relation to this event; and
 - identifying and addressing community concerns about the incident and the investigative process through community meetings, press releases, media briefing, and other relevant means.

The OCC completed two other policy projects this quarter. In April 2013, the Police Department issued Department Bulletin 13-067, "Use of Force Options: Reporting and Medical Assessment Requirements." This Department Bulletin implements the OCC's recommendation that the Department's use of force reporting and investigation procedures should include incidents when an individual complains of pain that persists beyond the officer's original physical control hold.

Last, on June 26, 2013, the Police Commission unanimously adopted revisions to Department General Order 5.05, the Department's pursuit policy. The OCC's

proposed revisions to the Department's pursuit policy placed more decision-making authority in the hands of the pursuit supervisor and are important features of the revised policy.

XI. CONCLUSION

As during the past five years, the OCC faces budget and staffing constraints in the upcoming year that could result in additional case resolution delays, however, the OCC will remain committed to its mission to investigate civilian complaints of police misconduct or failure to perform a duty promptly, fairly, and impartially.





Days to Close - Cases Closed Second Quarter 2013




Average Days to Close: 172

Days to Close - Cases Closed Second Quarter 2012




Average Days to Close: 161




Status of OCC Cases - Year 2012




Status of OCC Cases - Year 2013





OCC Case Closures - Second Quarter 2013 by Investigator






OCC Weighted Closures - Second Quarter 2013 by Investigator


OCC Weighted Closures - Second Quarter 2012 by Investigator


