Re: Office of Citizen Complaints 2009 Second Quarter Statistical Report

I. INTRODUCTION

Enclosed is the Office of Citizen Complaint's statistical report for the 2009 second quarter. The OCC had a very productive first six months of 2009, opening 512 complaints and closing the same number of complaints. In the second quarter of 2009 OCC received 266 complaints of police misconduct or failure to take action and it closed 257 complaints. The OCC had 392 pending cases as of the end of the second quarter. The number of pending cases at the end of the 2009 second quarter was lower than the number of pending cases of the second quarters of the previous two years.

II. ORGANIZATIONAL AND BUDGET MATTERS

During the second quarter of 2009, the OCC experienced a period of organizational stability similar to the first quarter of the year. However, during the second quarter, a trial attorney resigned. The statistics set forth below continue to bear out the premise that a lower caseload results in greater productivity and fewer delays.

During this second quarter, the Mayor submitted his budget to the Board of Supervisors which proposed reductions of the following three vacant OCC positions: a senior clerk typist, a line investigator and a senior investigator. These reductions were anticipated since they were deleted from OCC's budget effective February 1, 2009 in anticipation of a required 25% budget reduction for all City departments for fiscal year 2009-10. What was unanticipated and greatly appreciated was that the Mayor did not require the OCC to delete two filled positions which had been identified to satisfy the 25% budget reduction, an attorney and a line investigator position. Consequently, as submitted, the proposed 2009-2010 budget will not require any OCC layoffs and the OCC will retain 35 positions.

In the second quarter of 2009, the Information System Business Analyst, Chris Wisniewski, created a time study application in the database for use by the investigators. The investigators will participate in a time study during the third quarter to determine how their time is spent in the conduct of investigations. The Chief Investigator and the Senior Investigators will test the system prior to its rollout to the line investigators. This time study was recommended by the Controller's Audit division in its 2007 audit of OCC operations. In addition, Mr. Wisniewski began researching the process for online complaint filing and providing for the online filing of complaints in languages other than English.

During the second quarter, the investigative and legal staff worked to memorialize the OCC investigation practices and procedures in an investigation manual. While completion was projected for the end of the second quarter, the vacancy of one of the two trial attorney positions delayed completion to the third quarter. During the second quarter, investigative staff worked to formalize its training program that was implemented in 2008. This formalized program and a strategic plan for training is anticipated to be completed the third quarter of 2009.

In June, four of OCC's newest investigators attended a POST certified one week long training on interview and interrogation techniques. The training was conducted by the Behavioral Analysis and Training Institute. In May, the OCC Executive Director attended a three day seminar conducted by Dr. Lorie Fridell on Racially Biased Policing. The seminar was hosted by the Palo Alto Police Department and attended by members of that department as well as police department representatives from East Palo Alto, San Jose and San Francisco. Attending also was a representative from the Department of Justice and community members from Palo Alto and East Palo Alto.

III. INVESTIGATION OF CASES

As of the end of the 2009 second quarter, the OCC opened 512 new cases and closed 512 cases. The OCC closed the quarter with 392 pending cases which is 40 less than the close of the second quarter in 2008. By the end of the 2009 second quarter there were 75 pending cases from 2008 and 317 pending cases from 2009. The OCC is no longer plagued with a backlog of two, three and four year old cases as it was as recently as the second quarter of 2008.

Of the 257 cases the OCC closed in the 2009 second quarter, 83% were closed within nine months and only 4% (11 cases) took more than a year to close. This is an

improvement compared to the second quarter of 2008 where only 75% of the cases were closed within nine months and 13% of the cases took more than a year to close.

In the second quarter of 2009, five percent of cases were sustained; still significantly lower than the OCC's historical average of nine percent, but the same percentage of cases sustained in the second quarter of 2008. Also, the days to close sustained cases were significantly reduced for the second quarter of 2009. In the second quarter, 57% of sustained cases were completed within nine months and no sustained cases were completed more than 365 days after receipt, while during the same period in 2008, only 20% of the sustained cases were completed within nine months and 20% of them were completed more than 365 days after receipt. Of note is that for most of 2008, OCC investigators were operating with only twelve fully trained investigators. However, of greater note is that during the second quarter of 2009, two experienced investigators were out of the office on extended leave and nearly one quarter of the investigators were out of the office in POST training for a week.

The sustained allegations in five of the fourteen sustained complaints, (more than one third) continue to be troubling as they were in the first quarter because the allegations were sustained for neglect of duty when an officer either failed to complete the worksheet for traffic stop data or to enter the information into the MDT in the patrol vehicle or at the station computer in the case of motorcycle officers. Dr. Lorie Fridell in her 2007 study on Fair and Impartial Policing in San Francisco discusses the importance of accurate data collection should a department determine that it will collect traffic stop data.¹ In the first quarter, nearly one third of sustained complaints were sustained due to failure to collect stop data.

Allegations were also sustained in the second quarter for unnecessary force, untruthfulness in an incident report, use of profanity, physically aggressive behavior, failure to prepare an incident report, failure to issue a certificate of release, failure to enter a reportable use of force in the use of force log, and failure by officers in an unmarked car to call for a marked backup unit in a traffic stop.

IV. STATUS OF CURRENT OCC CASES – THE ‘KEANE’ REPORT

By the end of the 2009 second quarter, staff had closed 93% of the 2008 cases, leaving 7% of the 2008 cases pending. In comparison, by the end of the 2008 second quarter, staff had closed 87% of the 2007 cases, leaving 13% of the 2007 cases

pending. Through closer case management, staff is moving closer to its goal of completing its investigations within nine months.

V. CASE MANAGEMENT

The investigator caseload as of June 30, 2009 shows a better balance than the same period in 2008. The average caseload as of June 30, 2009 was 22 cases per investigator. Only one investigator had a caseload of 30 cases as of June 30, 2009. That same investigator had a caseload of 62 cases by the end of the second quarter in 2008. As of March 31, 2008, the average caseload was 32 cases, yet one investigator had a caseload of 62 cases and another, 45. During the second quarter of 2009, the Chief Investigator and the Senior Investigators continued to take a very active role in monthly case reviews, monitoring caseloads and assuming investigative responsibility in selected cases.

VI. CASE PROSECUTION

The OCC's two trial attorneys prosecute police misconduct cases in matters investigated and determined by the OCC to be misconduct or failure to perform a required action. They present cases to the Police Chief when officers object to proposed discipline of up to ten days suspension. They present cases before the Police Commission when the proposed discipline is greater than ten days suspension up through termination.

During the 2nd Quarter, the Legal Unit lost one of its Trial Attorneys who voluntarily resigned. Nevertheless, during this period, the OCC presented two of its backlogged cases to the Police Commission, as follows:

1. A case against one police captain was adjudicated by presenting a full hearing in Open Session before the Police Commission. While discipline hearings are held in Closed Session, at the option of the subject officer, a case may be presented in sessions open to the public. Pre-hearing matters and motions were presented in two sessions, and the hearing on the merits was completed in two additional sessions. The Commission did not uphold the specific charges but Commission members individually expressed disapproval of the captain's behavior.
2. Cases against six officers were also presented during this time. The OCC requested that the Commission dismiss one charge and return the

remaining charges to the OCC for referral to the Police Chief for discipline. The OCC's recommendations were the result of a series of negotiations and Stipulated Dispositions with the subject officers and their legal representatives. The Commission approved the proposed terms as to five of the cases, and one case was referred to mediation.

During the second quarter, the OCC initiated the process to fill the Trial Attorney vacancy. It is expected that the position will be filled during the third quarter and that the Legal Unit will be functioning with its full complement of attorneys by August 2009.

VII. MEDIATION

During this quarter, the OCC continued to make significant progress in mediating a significant number of cases. Through the dedicated efforts of Mediation Coordinator Donna Salazar, as well as those of a committed panel of pro bono legal and lay mediators, the OCC mediation program continues to thrive. The OCC mediated 23 cases in the second quarter of 2009, which represents a 30% increase from the same period in 2008, when the OCC mediated 16 cases. From the beginning of the 2009 calendar year through the end of the second quarter, the OCC had mediated 39 cases, as compared to 33, nearly 20 % more than the first two quarters of 2008. The mediation program continues to provide a forum for officers and civilians to have a frank discussion regarding the complaint and serves as an educational experience for all participants.

VIII. OUTREACH

The OCC's Community Outreach Program seeks to improve public and police understanding of OCC's services, goals and accomplishments. By using a community based approach, the OCC works with leaders, advocates and organizations to educate the public about its services. Through presentations, widely distributed written materials and the OCC website, the OCC aims to increase the public's understanding of civilian oversight and the active role the public can play in making the OCC and community policing successful. Through its outreach efforts, the OCC seeks to strengthen its relationships with communities historically and statistically likely to have encounters with the police.

During the 2nd Quarter of 2009, the OCC performed the following outreach activities:

- Investigators made presentations to:
 - The Community Assessment and Referral Center (Chief Investigator Charles Gallman and Senior Investigator Edward McMahon),
 - Padres Unidos (Investigators Helen Calderon and Mary Ivas),
 - John O'Connell High School (Senior Investigator Erick Baltazar and Investigator Candace Miles-Threatt), and
 - Northern California Girl Scouts (Investigators Helen Calderon and Mary Ivas).
- Senior Investigator Edward McMahon gave a presentation about OCC services to a community meeting in District 8.
- Executive Director Joyce Hicks gave an informational presentation to the Oakland City Council Public Safety Committee regarding police oversight.
- Chief Investigator Charles Gallman gave an informational presentation at a BART community meeting regarding police oversight.
- OCC staffed informational tables at two Operation Homeless Connect events (Attorney Donna Salazar and Investigator Karol Heppe).
- OCC staffed an informational table at an Operation Family Connect event (Attorney Donna Salazar and Investigators Karol Heppe and Ellen Dolese)
- Executive Director Joyce Hicks, Chief Investigator Charles Gallman and Investigator Candace Miles-Threatt gave a presentation on ethics in civilian oversight of law enforcement to San Francisco State University Professor Michael Musheno's "Ethics in Criminal Justice Class".
- Chief Investigator Gallman and Investigator Candace Miles-Threatt addressed two classes at San Francisco State University regarding the policies and procedures of OCC.
- Executive Director Hicks offered information regarding the OCC at the Alumni Reception sponsored by the UC Berkeley Law Students of African Descent, and gave an overview of the OCC while moderating a panel at UC Berkeley Law School.

IX. POLICY ANALYSIS

Pursuant to San Francisco City Charter section 4.127, the OCC is charged with “making recommendations concerning policies or practices of the [Police] [D]epartment which could be changed or amended to avoid unnecessary tension with the public or a definable segment of the public while insuring effective police services.” During the second quarter of 2009 the OCC policy work was focused primarily on four areas.

First, the OCC finalized its 2009 Community Outreach Strategic Plan. The Strategic Plan reported and highlighted the OCC’s activities and implementation of the 2008 Community Outreach Strategic Plan and outlined its plan and goals for the 2009 calendar year. The 2009 Community Outreach Strategic Plan was presented to the Police Commission on June 17, 2009.

Second, as part of its policy work to develop police training and public education materials regarding Department General Order 5.20 (Language Access Services for Limited English Proficient [LEP] Persons), the OCC, in conjunction with representatives from several community organizations, continued its work to ensure full implementation of the DGO. The work included distribution of the Guide to Language Access and completion of the filming of an SFPD training video for police officers.

Third, in collaboration with juvenile justice advocacy groups, city agencies, commissions and the Police Department, the OCC continued its work on revision and implementation efforts related to Department General Order 7.01, a protocol for police interactions with juveniles. Along with community representatives and the Police Department, the OCC continued to meet to discuss possible revisions to the DGO. The OCC expects to receive the Department’s proposed revisions soon. The OCC will then promptly review the proposal and offer its input.

Lastly, this quarter, the OCC and the Police Department presented a revised Department General Order 11.07 (Discrimination and Harassment) to the Police Commission. Importantly, this revised DGO adds a prohibition against discrimination of SFPD members on the basis of gender identity. Since 1999, the OCC and community organizations have been working with the Department to increase cultural competency regarding transgender issues. Through years of hard work and collaboration with the OCC and other organizations, the Department has provided numerous trainings and implemented many changes to its policies. The current addition of gender identity protections to DGO 11.07 further clarifies that gender identity discrimination in employment, like the other forms of employment

discrimination already prohibited under DGO 11.07, will not be tolerated by the Department.

X. CONCLUSION

The OCC is committed to its mission of timely, fairly and in an unbiased manner investigating citizen complaints of police misconduct or failure to perform a duty. The second quarter data reflects the OCC's capabilities when it is more fully staffed. The OCC will continue to engage in strategic case management during the third quarter and continue its work on finalizing an investigators' manual on OCC practices and procedures and finalizing a formal training program and strategic plan.

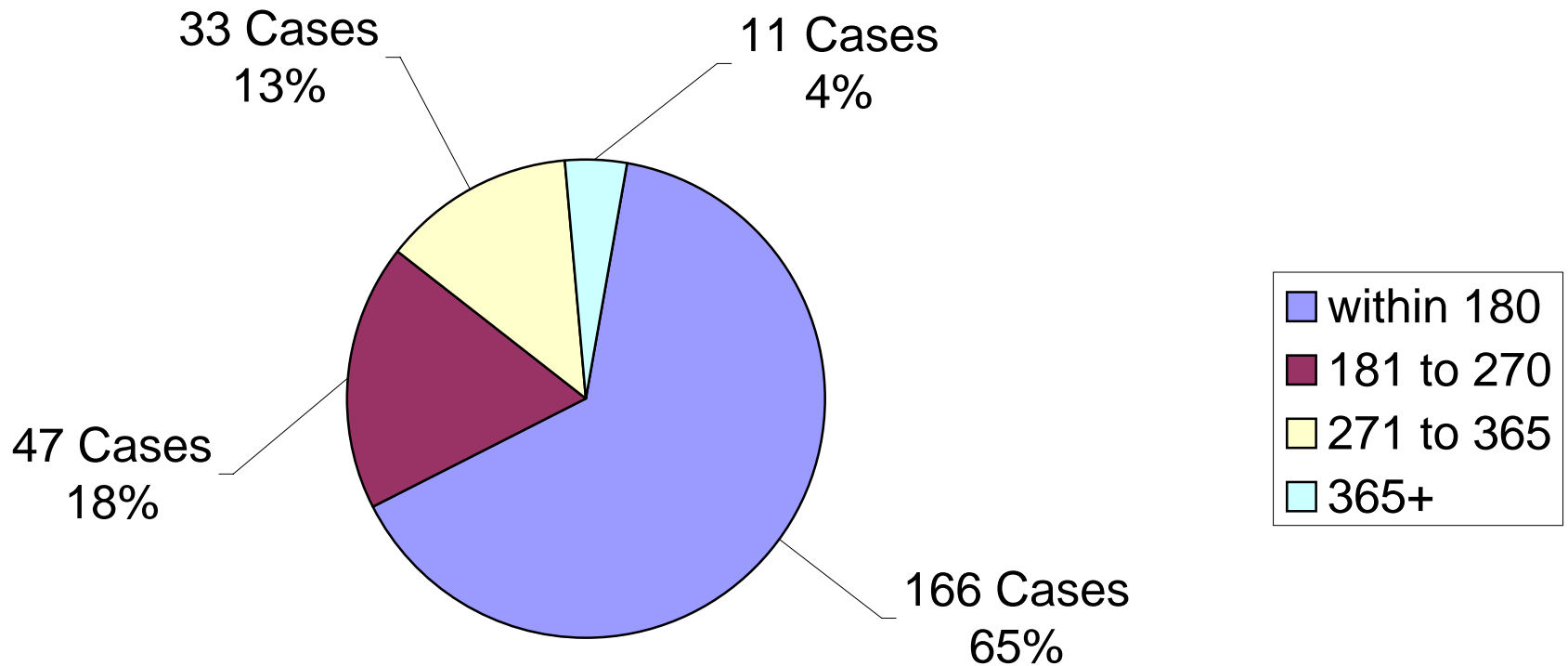

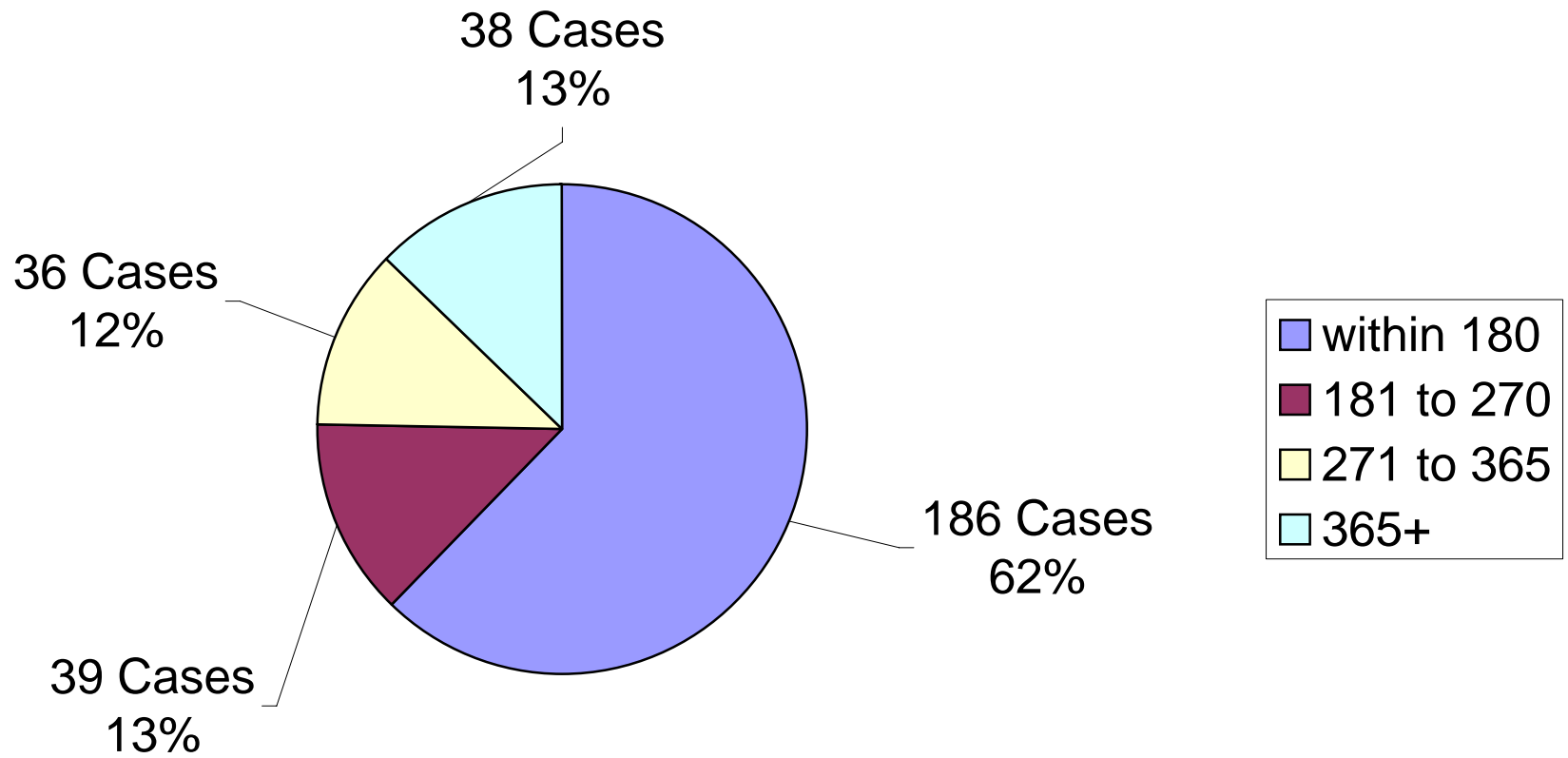

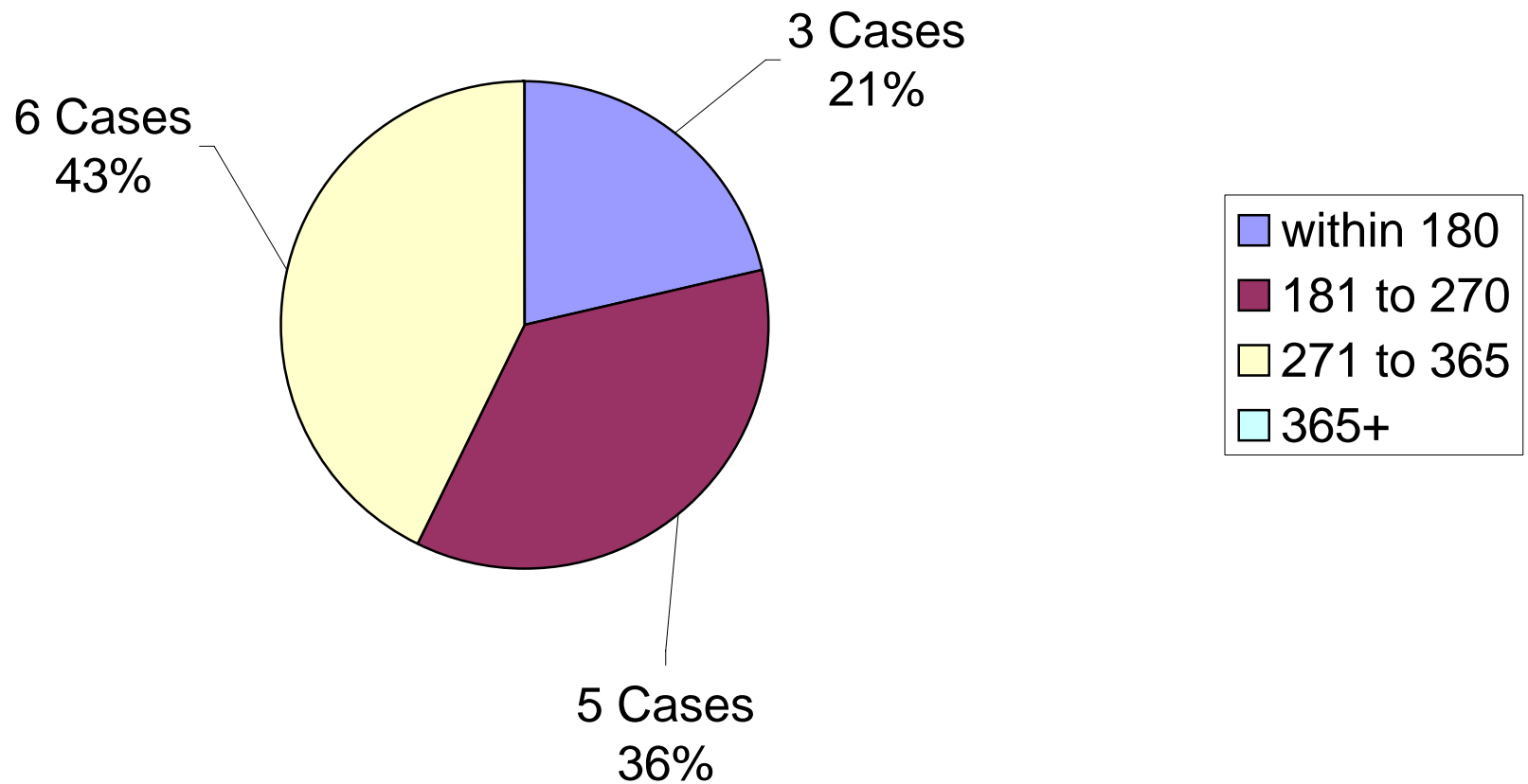
Days to Close - Cases Closed Second Quarter 2009



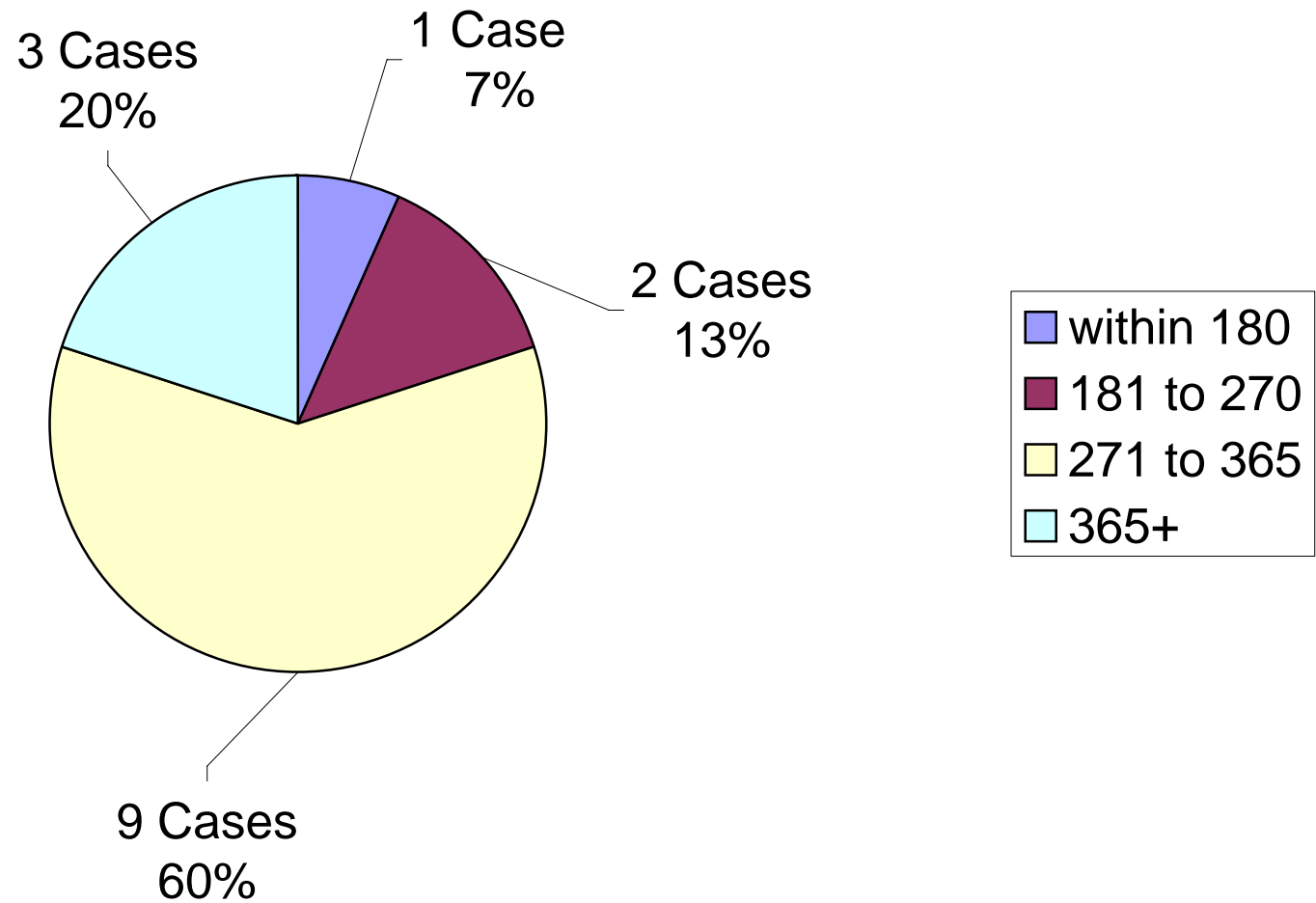
Days to Close - Cases Closed Second Quarter 2008

Days to Close - Cases Sustained Second Quarter 2008



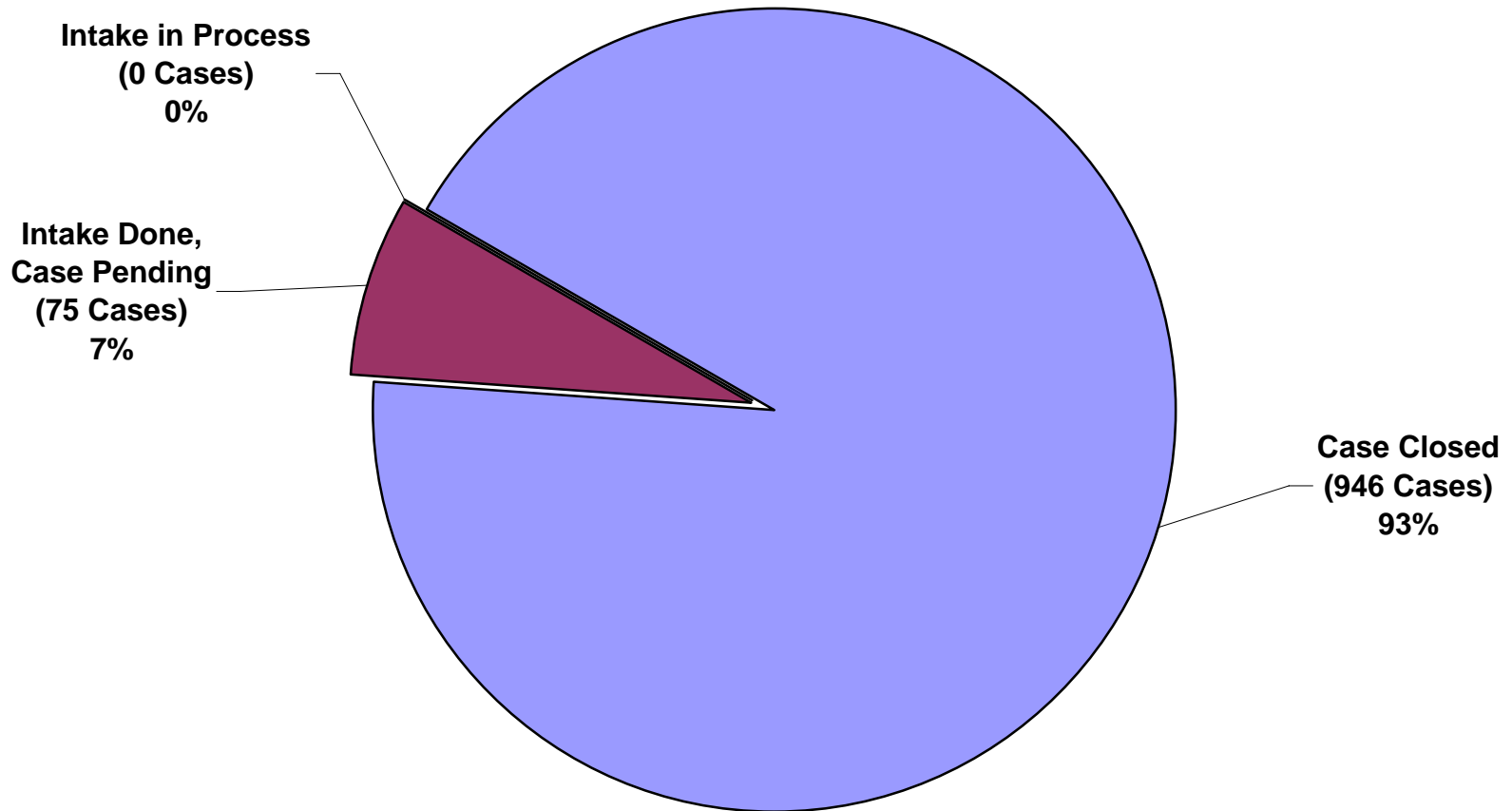

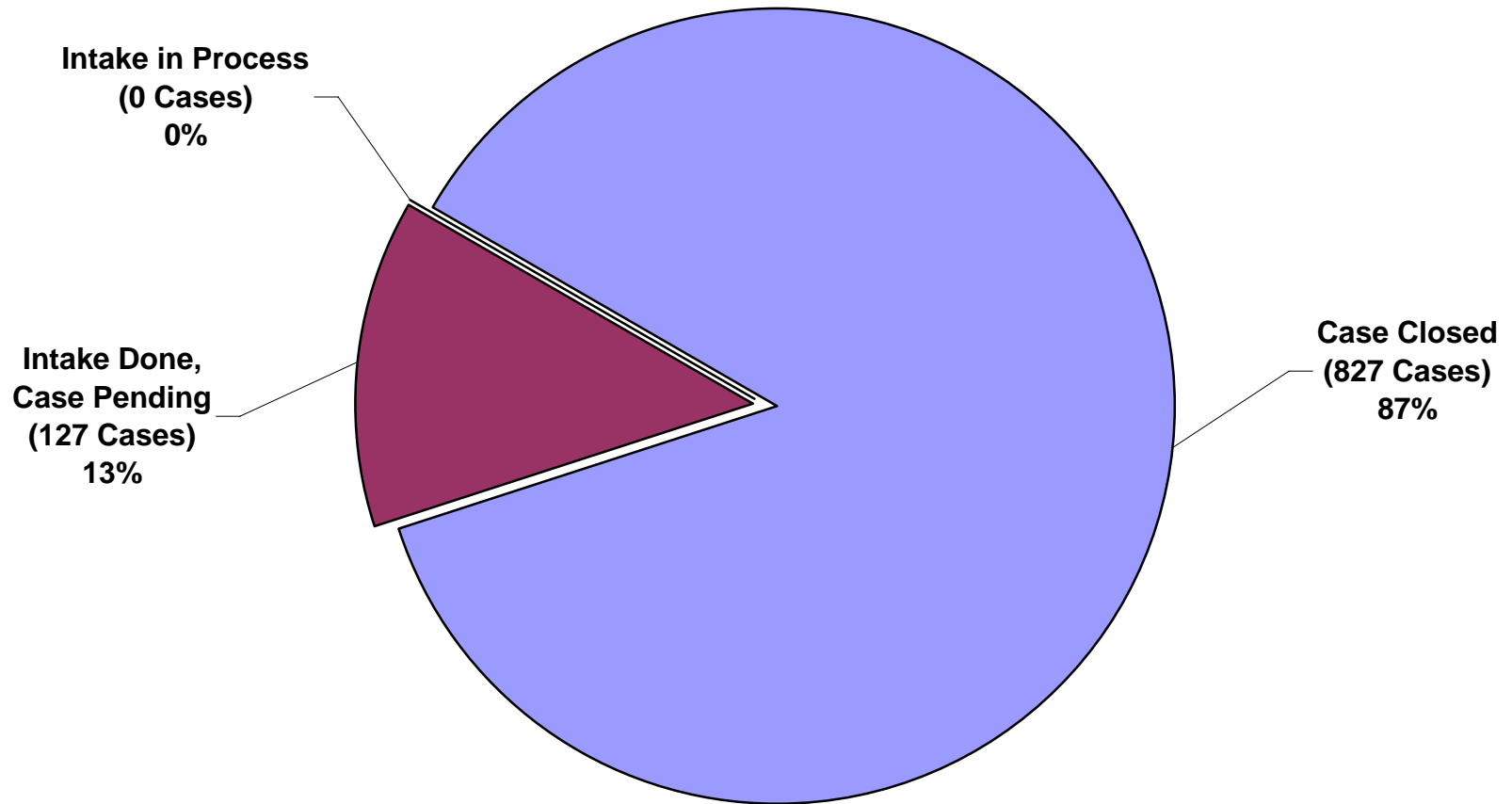

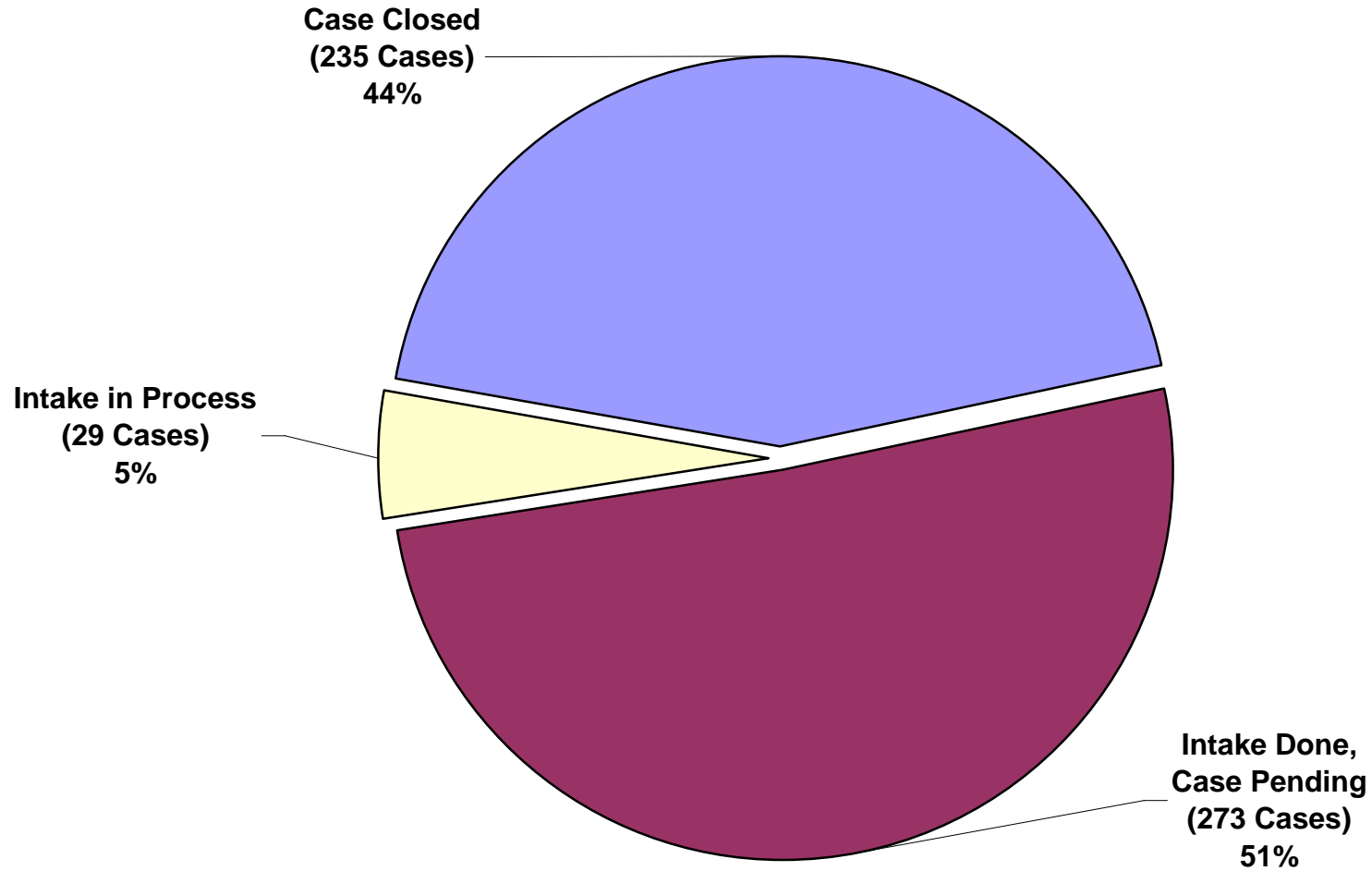

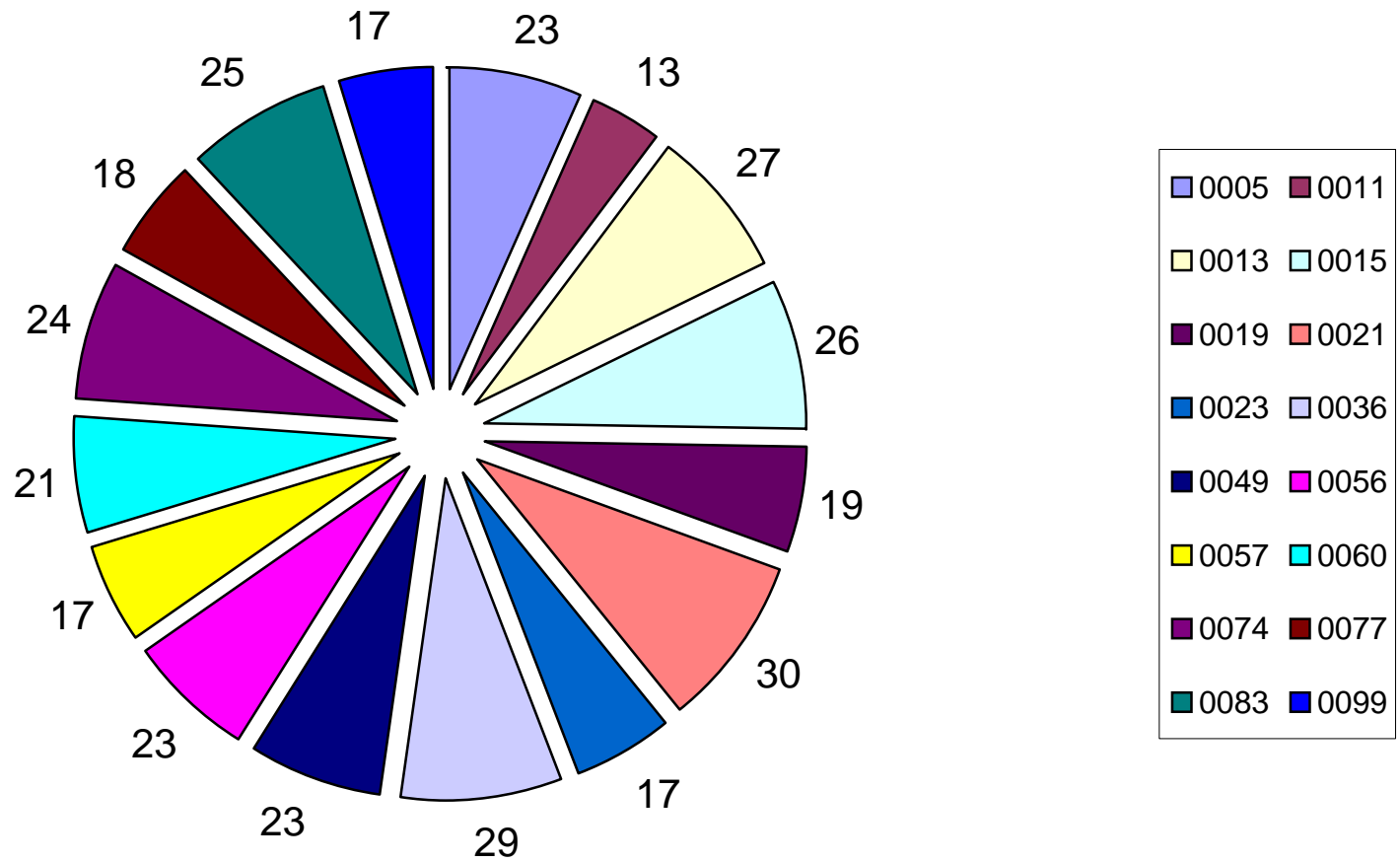

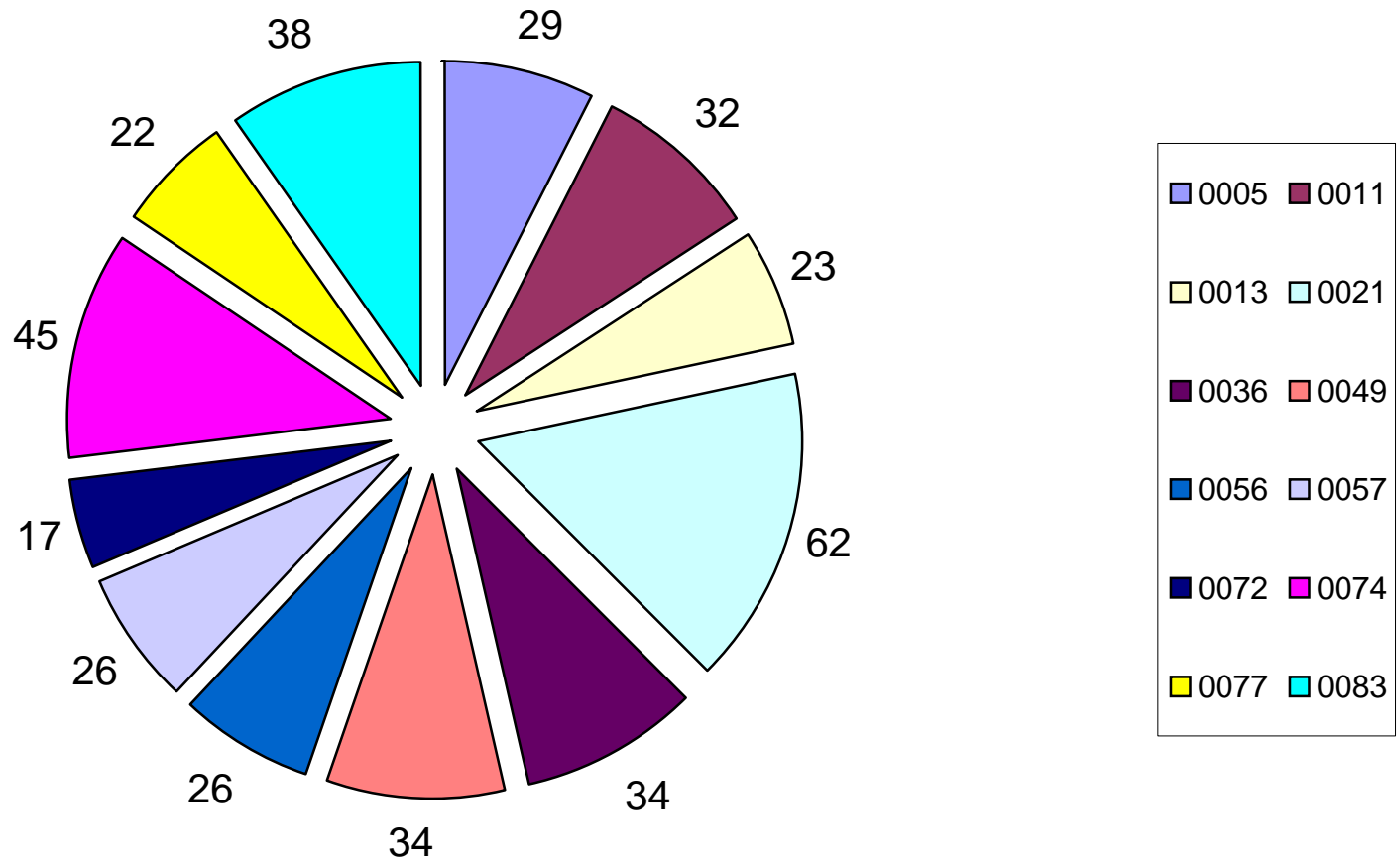

OCC Caseloads by Investigator as of 06/30/2009



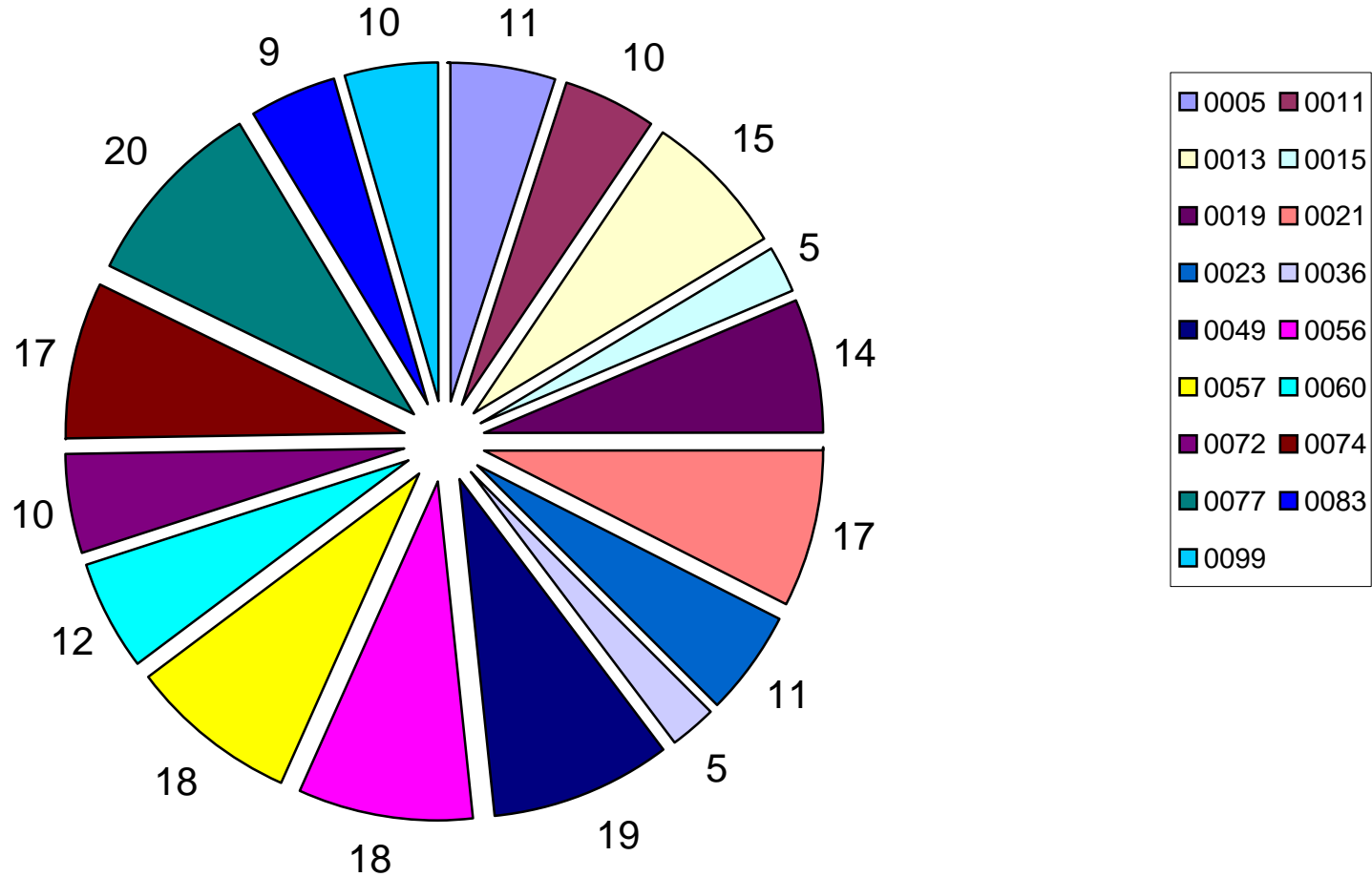

OCC Caseloads by Investigator as of 06/30/2008



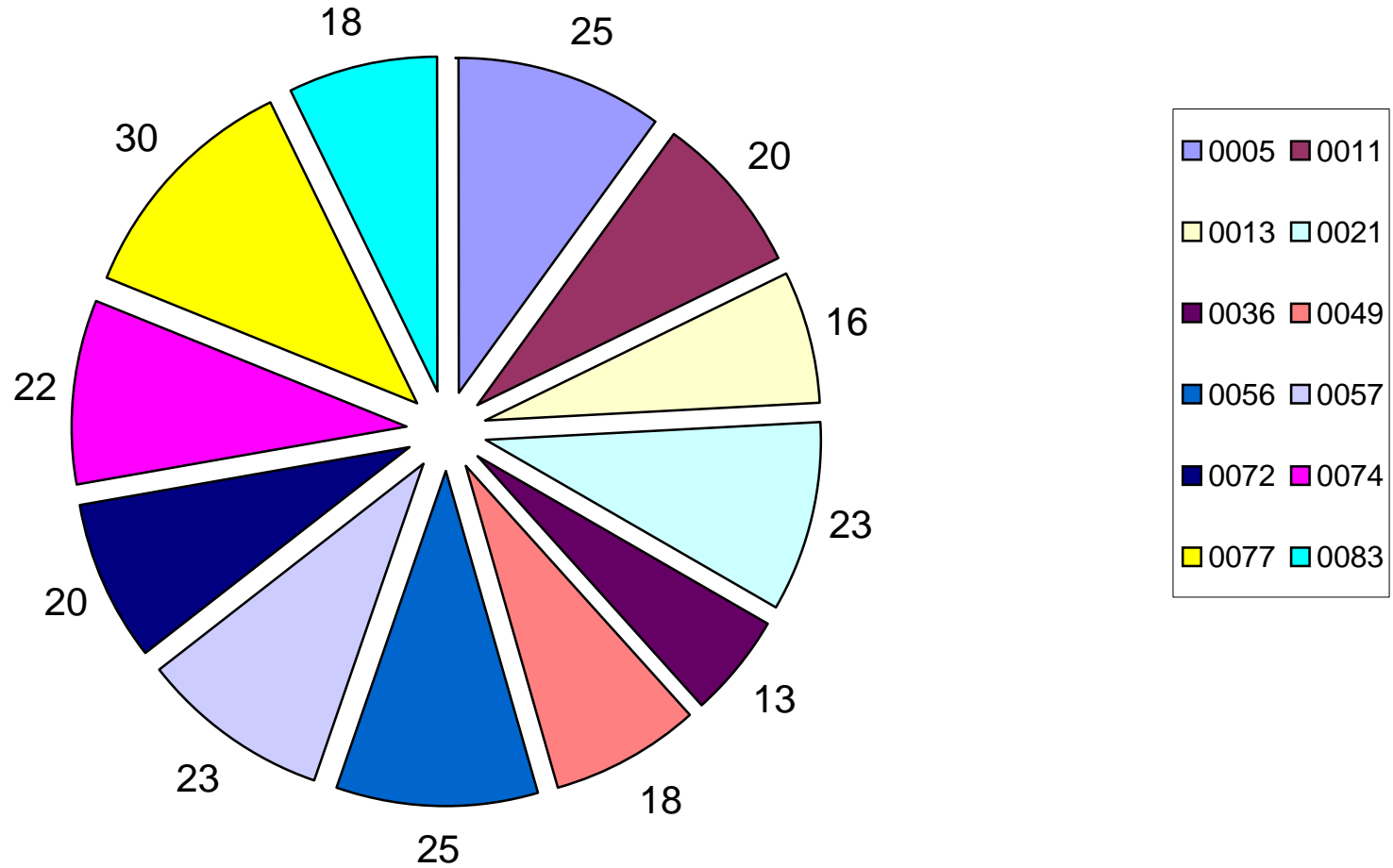

OCC Case Closures - Second Quarter 2009 by Investigator



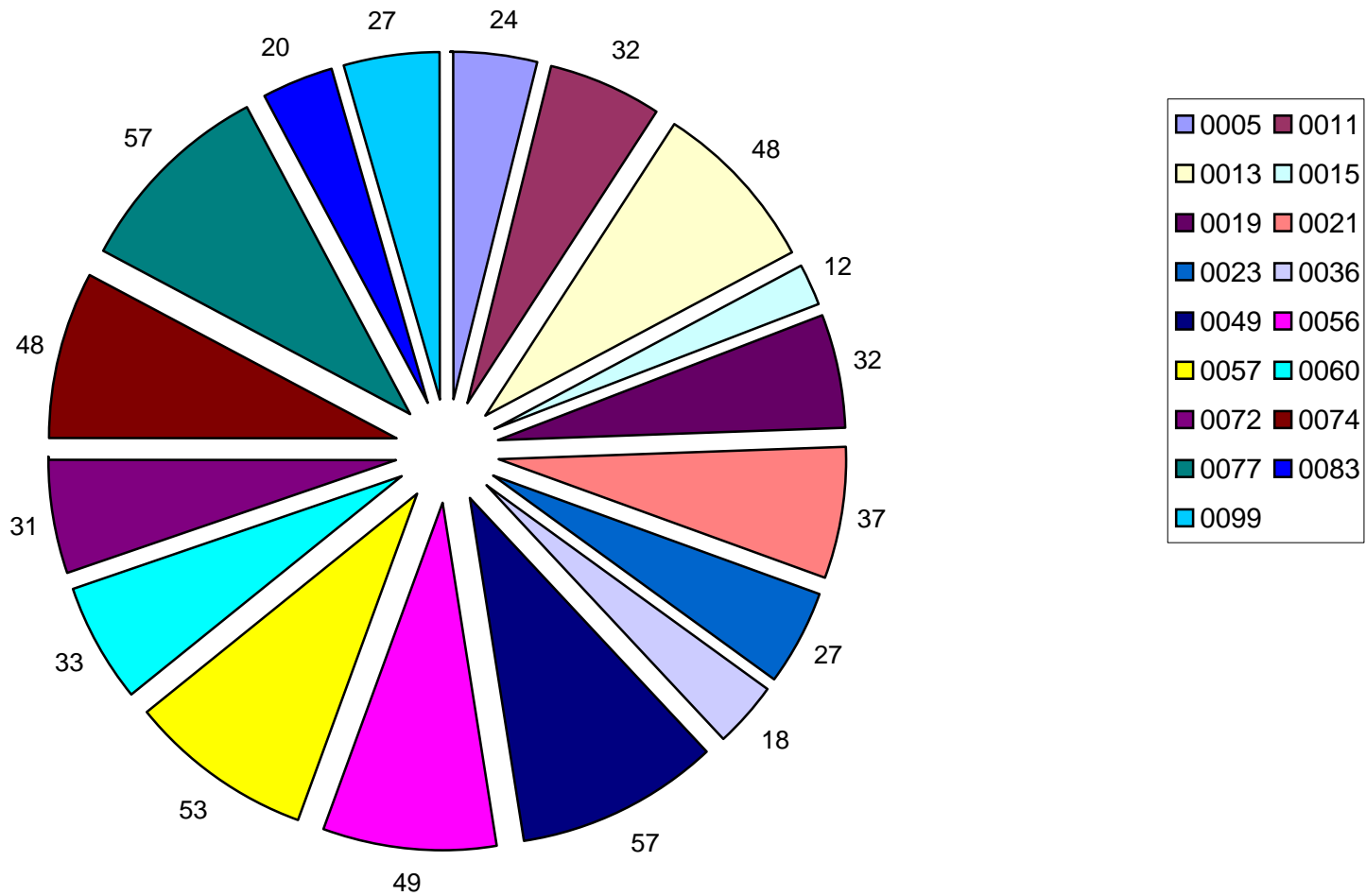

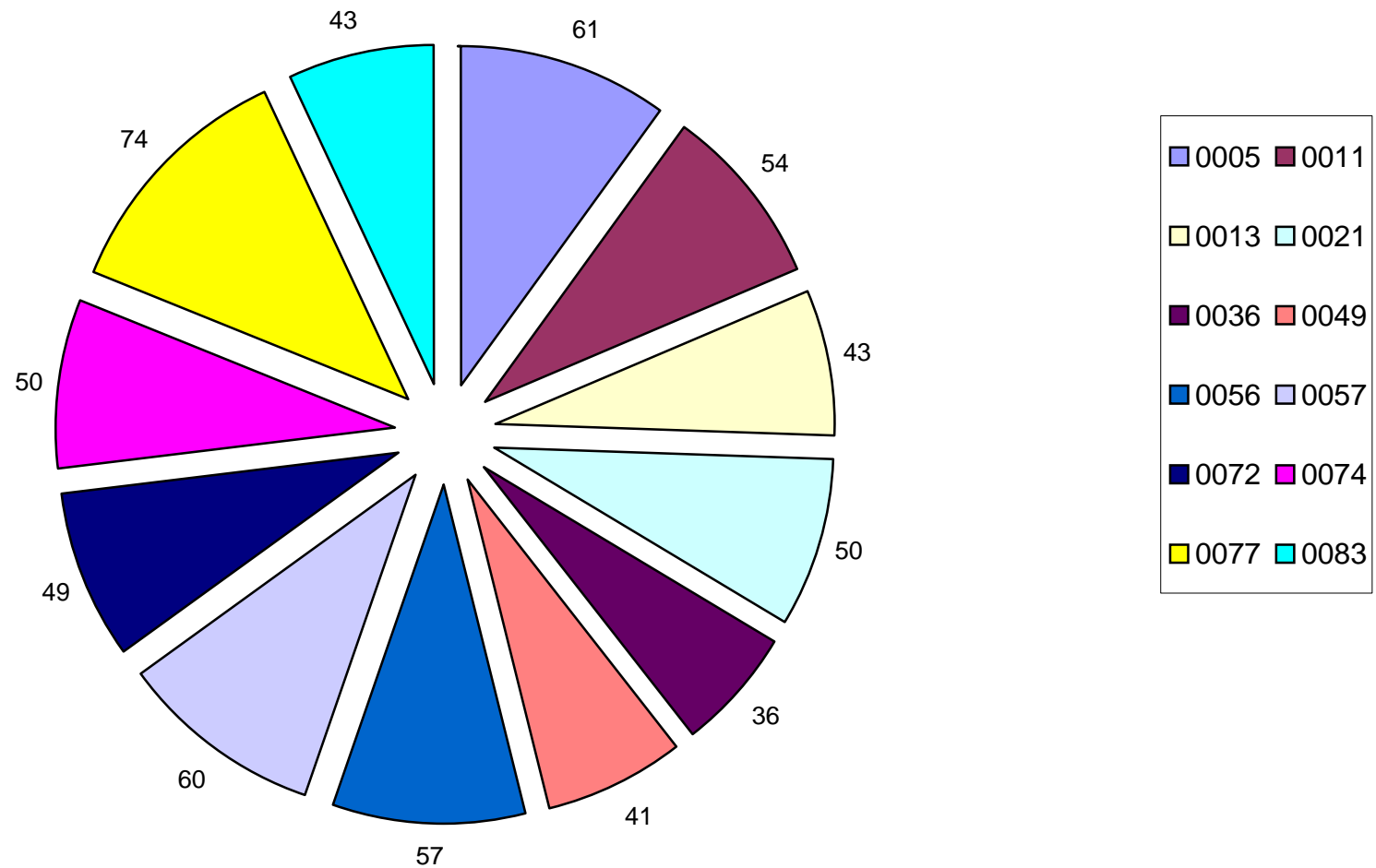
OCC Weighted Closures - Second Quarter 2009 by Investigator

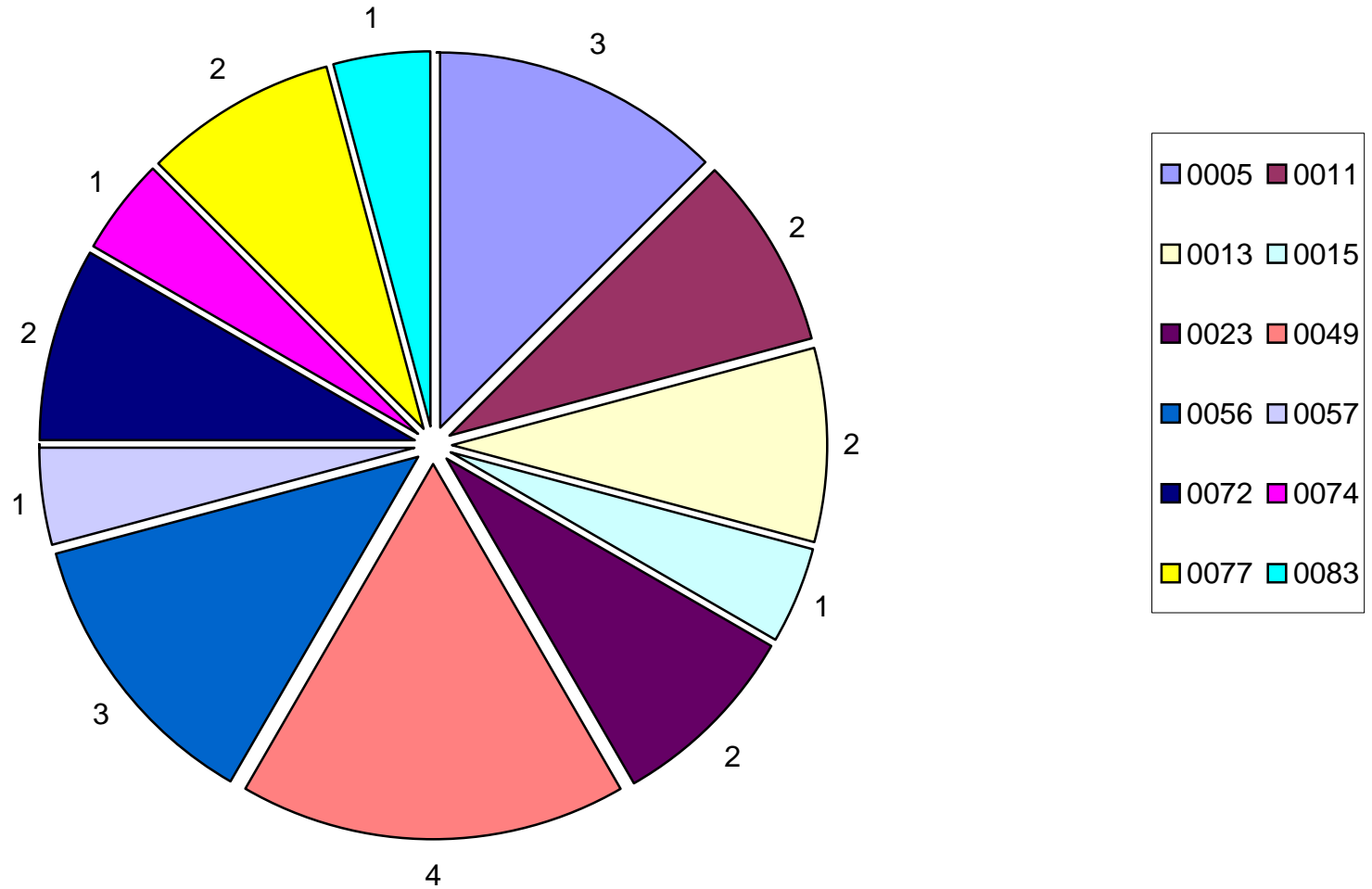
OCC Weighted Closures - Second Quarter 2008 by Investigator

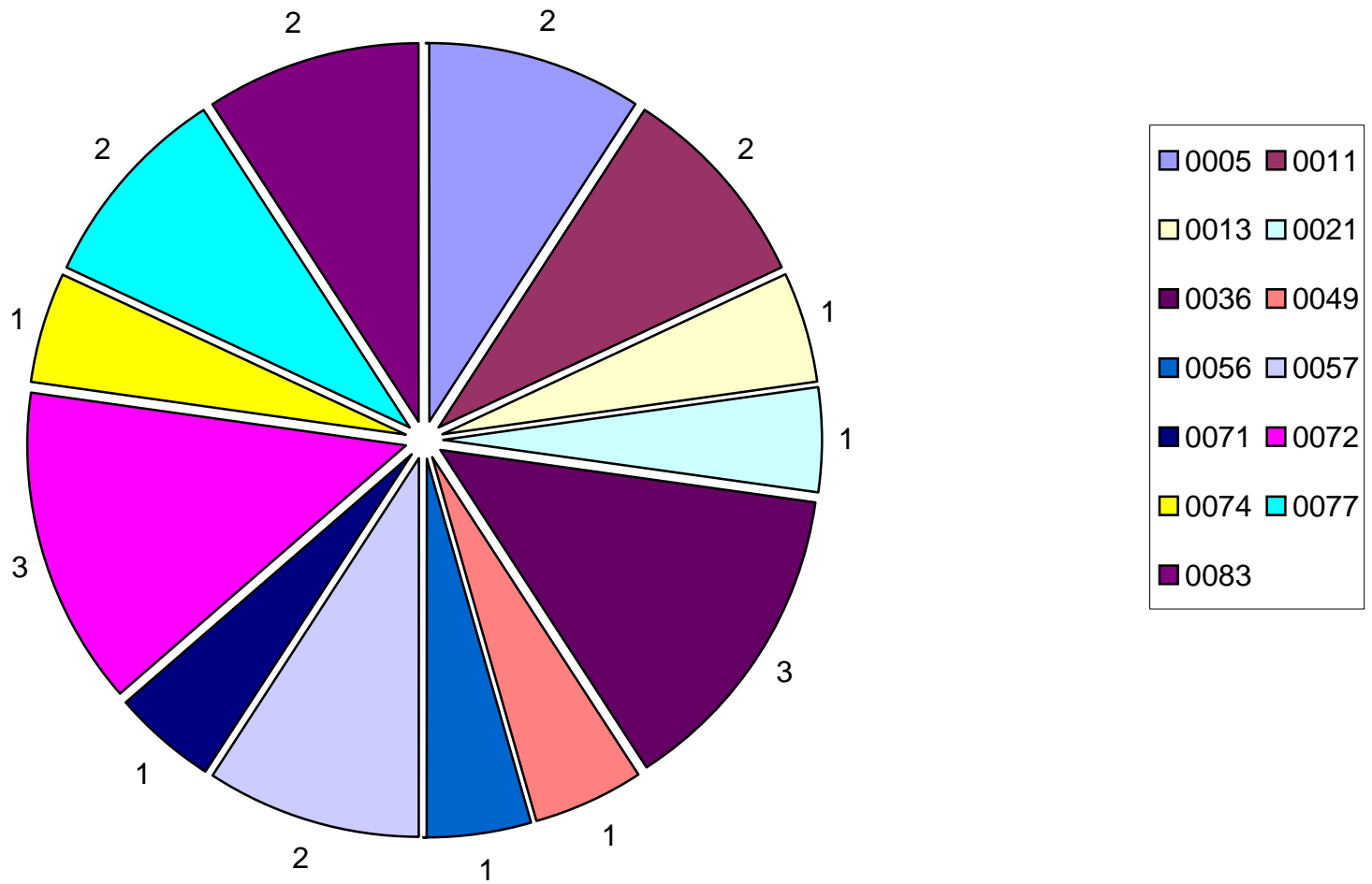
