Enclosed is the Office of Citizen Complaint's statistical report for the third quarter of 2007. The OCC had a busy third quarter, one marked by preparation for impending changes as well as continued dedication to its core mission of investigating civilian complaints in a fair, unbiased and effective manner.

ORGANIZATIONAL CHANGES

As of October 29, 2007, the OCC is located on the sixth and the seventh floors of:

The OCC spent much of August and September 2007 preparing for the move to 25 Van Ness. Under the leadership of Chief Investigator Charles Gallman and I.S. Business Analyst Chris Wisniewski, the agency worked with other city agencies, including Departments of Real Estate, Architecture and DTIS to configure the office space in a manner that will enhance the agency's productivity. In addition to planning for the physical move, the agency engaged in a community outreach effort to inform members of the community about the services the agency provides as well as about the impending change of address.

In another important change, as of November 26, 2007, Joyce Hicks, former Executive Director of Oakland's Citizens Police Review Board, will join the OCC as its new Director. We are grateful to the Police Commission, the Mayor and the Board of Supervisors for appointing someone with Ms. Hicks' demonstrated leadership in municipal governance and commitment to civilian oversight of law enforcement. Ms. Hicks has been in contact with agency managers, and we are working together to ensure a smooth transition.

INVESTIGATION OF CASES

As of the end of the third quarter 2007, the agency opened 646 new cases, and closed 701 cases. Both the number of new cases, as well as the number of cases closed, are higher than those at the end of the third quarter 2005 or 2006. The agency has closed 55 more cases than it opened, and is continuing to reduce the backlog of old cases built up over the past few years. In fact, at the end of the third quarter 2007, the OCC had closed 128 more cases than it did at a similar point in 2005.

This is a significant display of productivity, especially given the staffing issues faced by the agency. Currently, the agency is staffed with only 14 investigators, far short of the number recommended by the Controller's office after studying comparable caseloads at other agencies. In addition, the OCC's highly productive litigating attorney, Susan Leff, has taken a one-year parenting leave. Management has conducted preliminary advertising and interviewing of attorney applicants. However, with the appointment of the new director, the agency has delayed hiring to fill the attorney position as well as four investigator vacancies.

While the agency has continued closing cases at an accelerated rate, the insufficient staffing has had a negative impact on the time it takes to investigate a case to completion, and potentially on the rate of sustained findings of misconduct. For example, while 70 percent of OCC cases closed in the third quarter were investigated within six months, over half of the 17 cases sustained in that quarter took more than nine months to investigate. The rate of sustained cases, too, is down overall. In the first three quarters of 2007, 5.8% of cases were sustained, which is significantly lower than the agency's historical average, which hovers from eight to ten percent. Although the third quarter's sustained rate was slightly higher than the previous quarters, heavy investigator caseload – the unavoidable result of insufficient staffing – has been shown to negatively impact the rate of sustained findings.

STATUS OF CURRENT OCC CASES – THE 'KEANE' REPORT

The agency is dealing efficiently and effectively with its newer cases. As of the end of the third quarter, 92% of cases filed in 2006 were fully investigated and closed. Fifty three percent of the cases filed in 2007 have been closed. In addition, intakes are being expeditiously processed.

MEDIATION

The OCC is also making progress in increasing the numbers of cases mediated. Thanks to the efforts of the agency's new Mediation Coordinator, and our panel of talented pro bono mediators, the agency has mediated 30 cases in 2007, a pace exceeding any prior year. All of these cases were successfully mediated, meaning that both complainants and officers felt they were able to voice their concerns and have a frank discussion regarding the complaint. The mediation program is truly an educational tool for officers and complainants alike, and the OCC will continue to promote the program to the community. This past quarter, the Mediation Coordinator attended several conferences and meetings to promote the program among mediators and community members. As a result of this community education, in September, 26 new, incredibly diverse and qualified mediators joined the pro bono panel, which will allow the OCC to continue to increase its mediation efforts.

OUTREACH AND POLICY

Through our policy work on juvenile justice and language access issues, the OCC worked in coalition with representatives of numerous legal and community groups, such as the Asian Law Caucus, La Raza Legal Central, Youth Law Center, Asian Pacific Islander Legal Outreach, Chinese for Affirmative Action and Lawyers Committee for Civil Rights, to name a few.

In addition to its work investigating complaints, the OCC continued its efforts to inform members of the Department and community about the OCC's services and procedures. OCC representatives made presentations to Academy classes at the beginning and end of their training. In addition, OCC representatives staffed tables or made presentations at the Immigrant Rights Summit, National Lawyers Guild, NACOLE, Mujeres Unidas y Activas, Asian Pacific Islander Youth Advocacy Network, and PODER.

Attached to this report are six policy recommendations that arose from OCC case investigations. The recommendations include proposals on the following topics: Posting Department General Orders on the SFPD website; codifying existing procedure for tape-recording custodial interrogations; amending Department General Order 6.18 to mandate officers verify the validity of a warrant before making an arrest; expanding the Firearms Discharge Review Board's procedures to include review of extended range impact weapons; working with other agencies to create consistent rules regarding taxicab use of bus zones; and training officers regarding the correct vehicle code section for parking violations at wheelchair access ramps.

These recommendations have been researched by OCC investigative and policy staff and legal interns, and are being presented to the Police Commission and Police Department so that we may begin work on these issues. The Police Department has not yet had an opportunity to fully review or comment on these recommendations, but we look forward to collaborating with the Department and the community stakeholders on enhancing policing procedures.

In 2007, the OCC and the Police Department have forged a very productive and mutually respectful working relationship, that includes community outreach and consultation, on a wide range of policy issues. We are confident that this relationship will continue, and that in the coming months we will be presenting policies that will be cited as best practices for law enforcement agencies around the country.

In conclusion, it has been a pleasure and privilege to serve the agency as its interim director, and I thank the members of the Police Commission for the support and confidence that they have vested in me and other managers of this agency. Under Ms. Hicks' leadership, we shall continue to work to earn the community's trust in the OCC and the police disciplinary process.

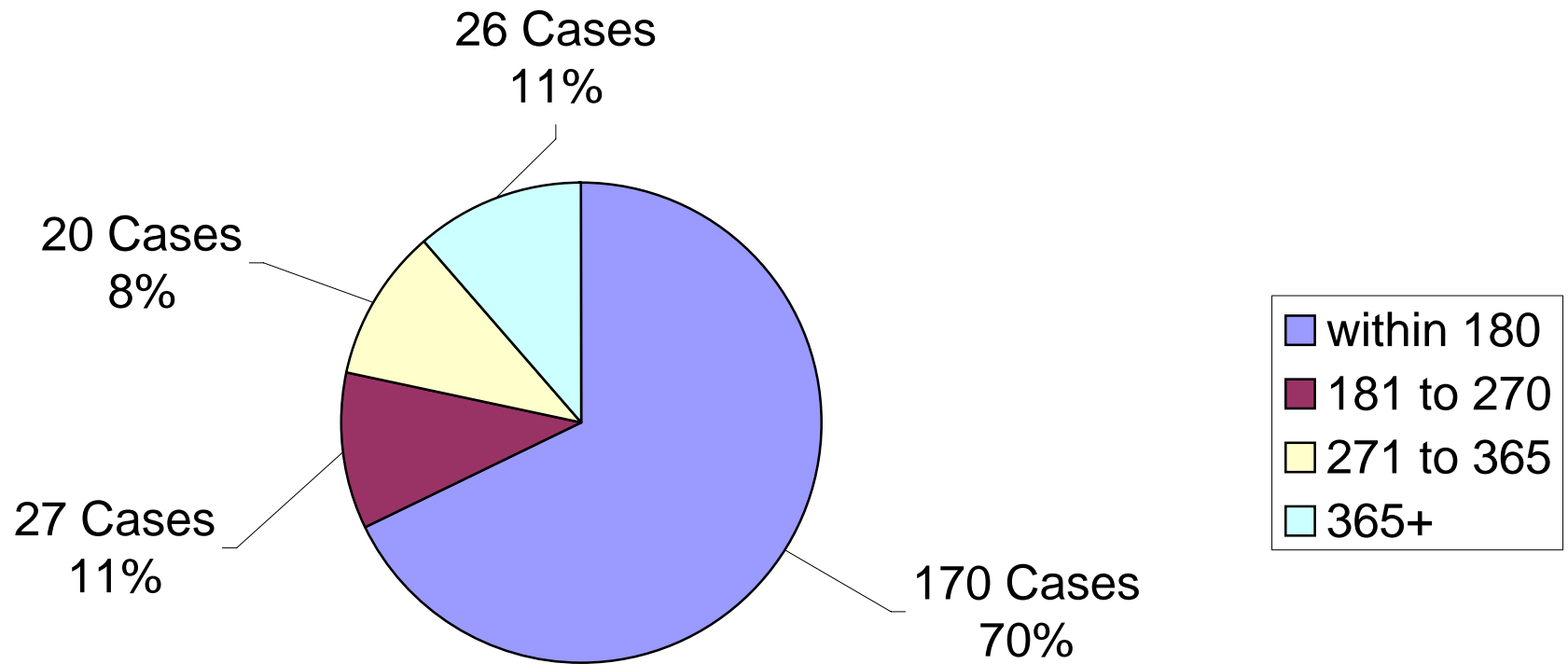

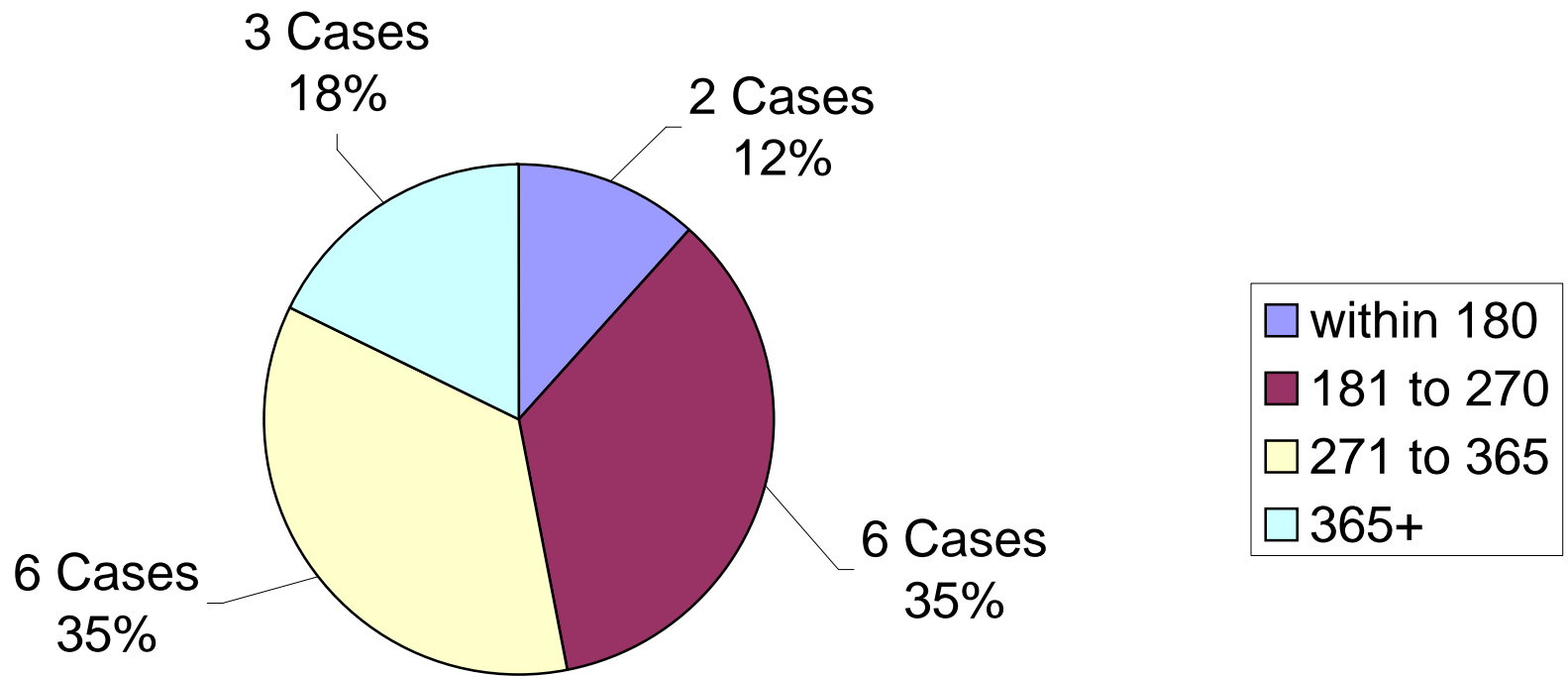

Days to Close - Cases Closed Third Quarter 2007

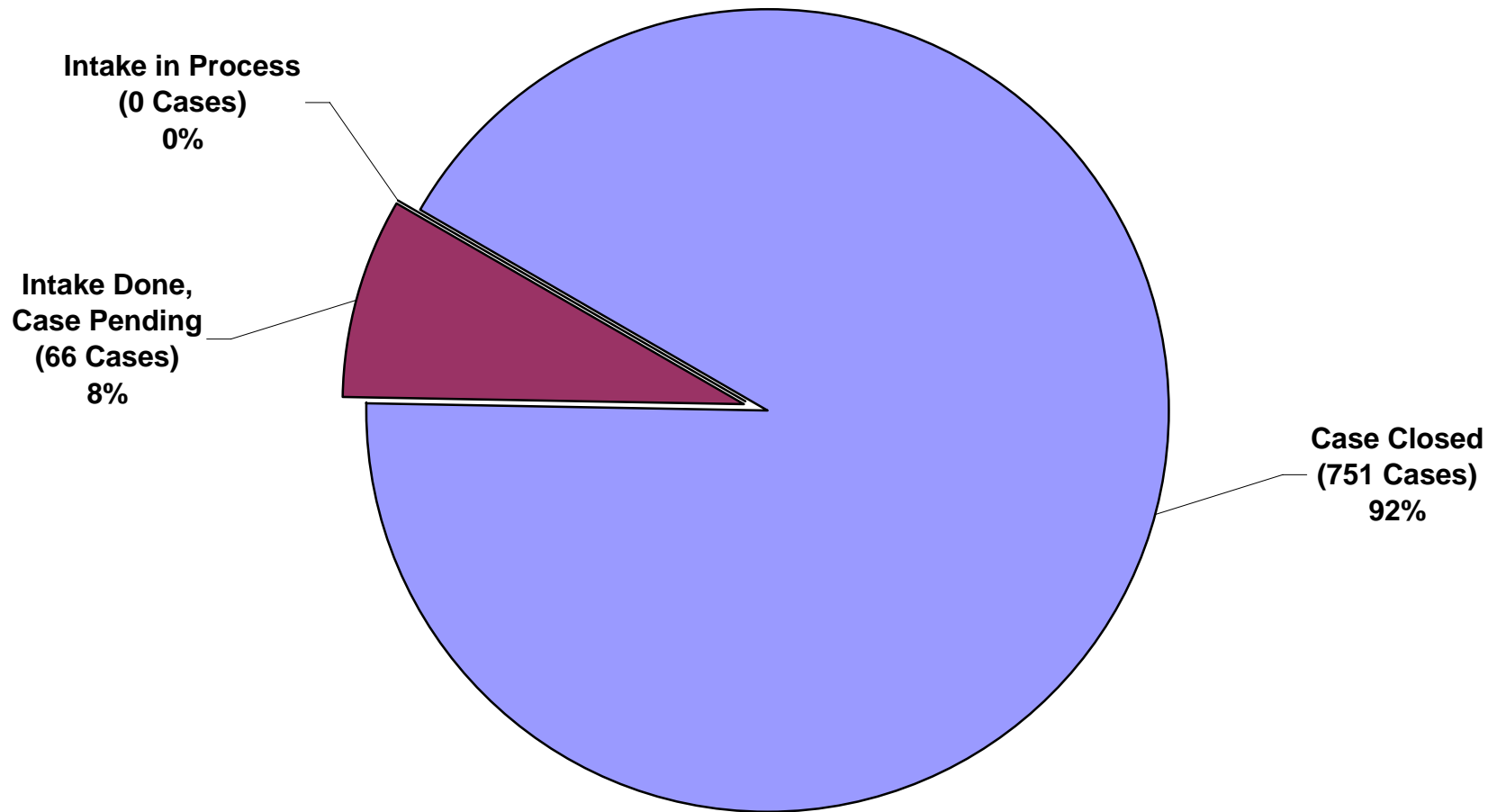


Days to Close - Cases Sustained Third Quarter 2007

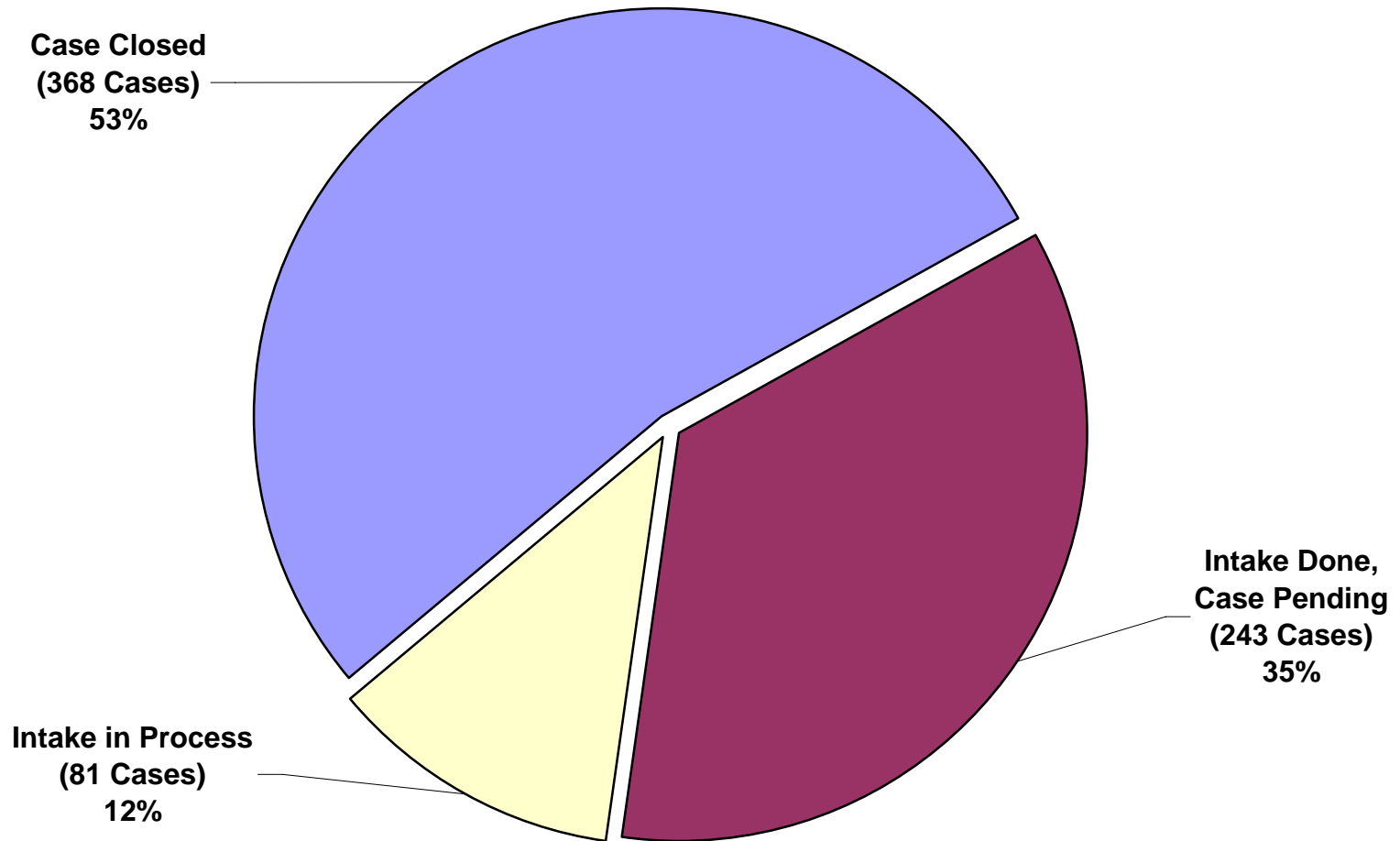

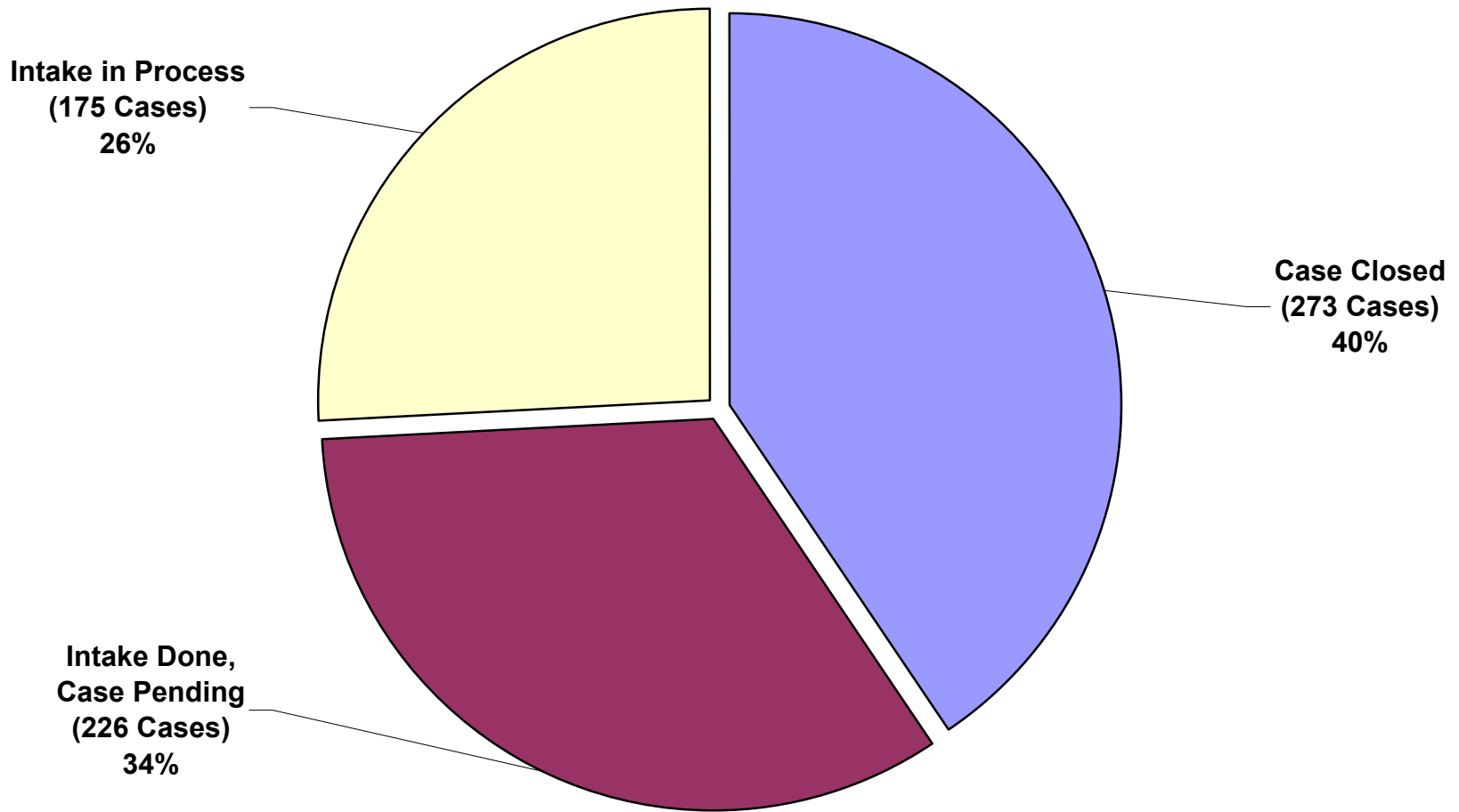
Status of OCC Cases - Year 2007

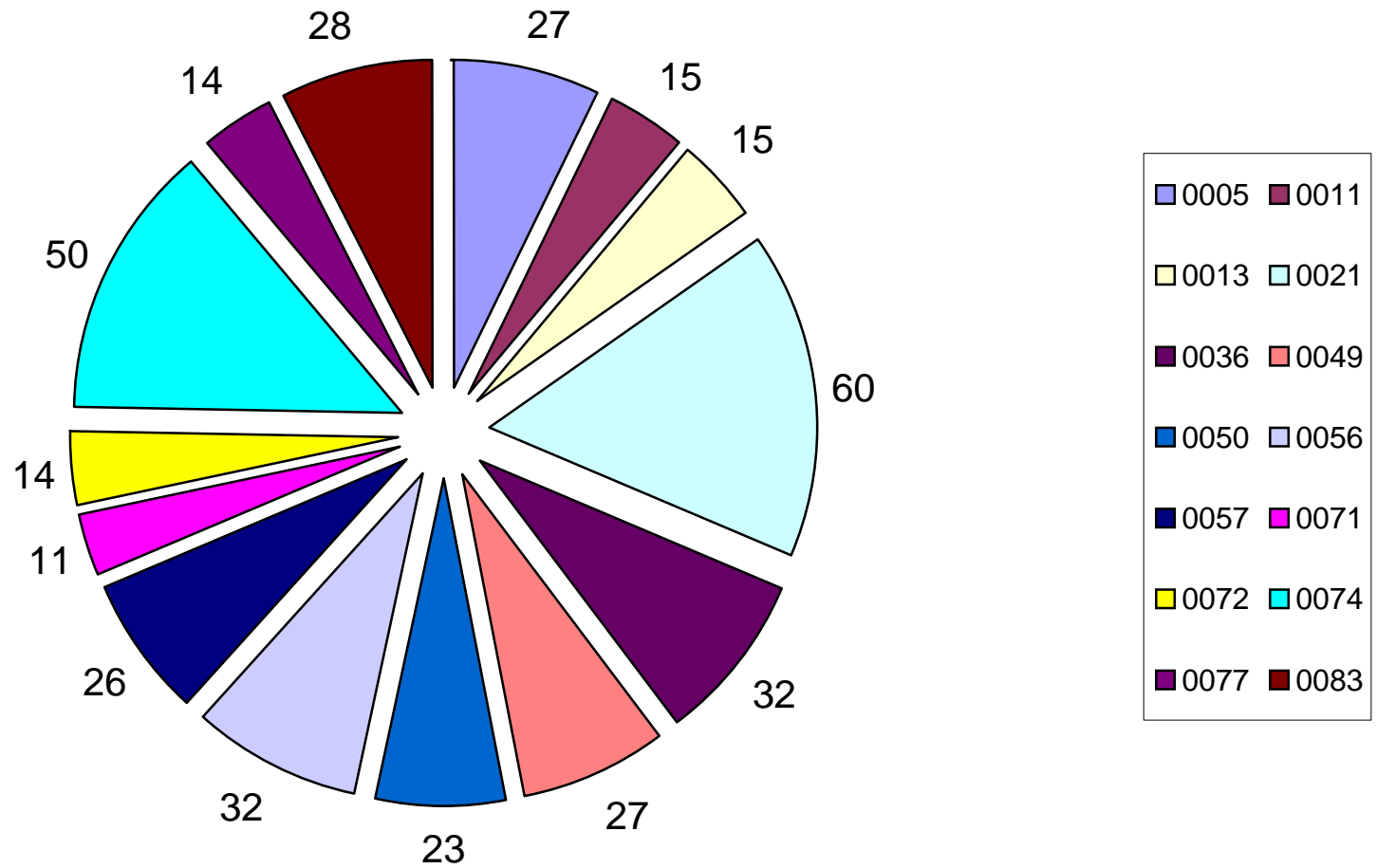

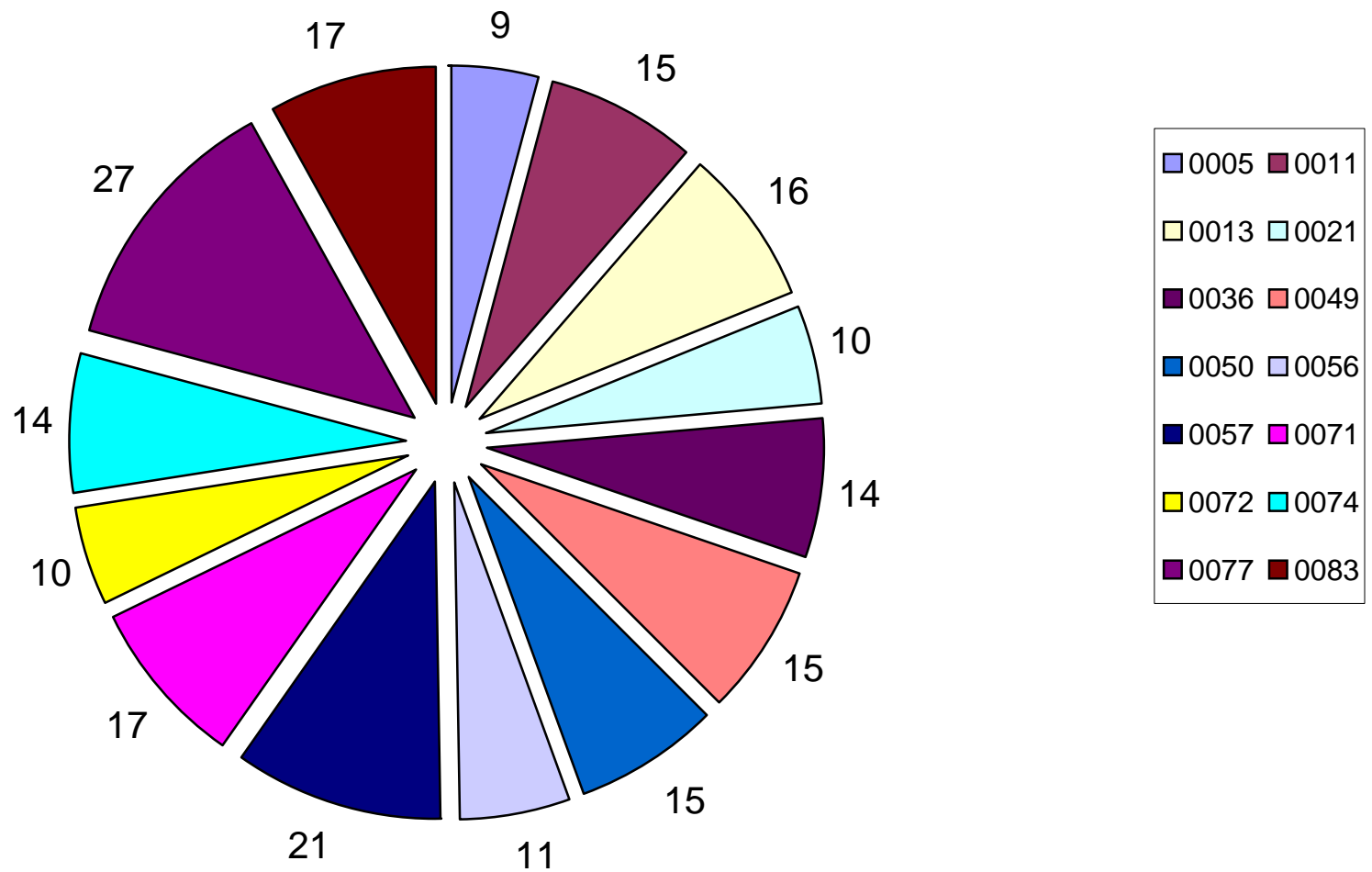

OCC Caseloads by Investigator as of 10/02/2007



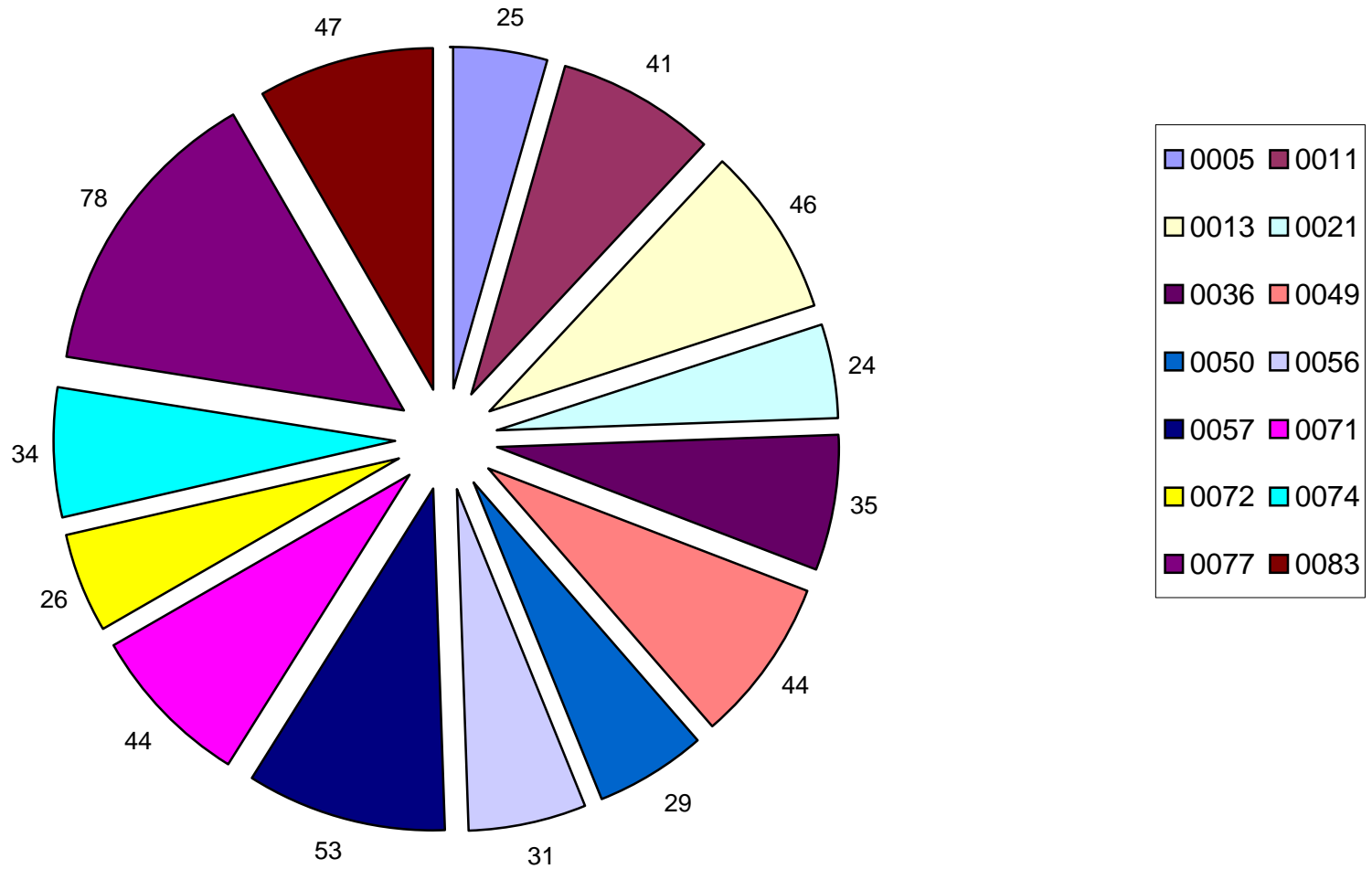

Average Case Closures by Number: 15 or 5 cases per month per investigator

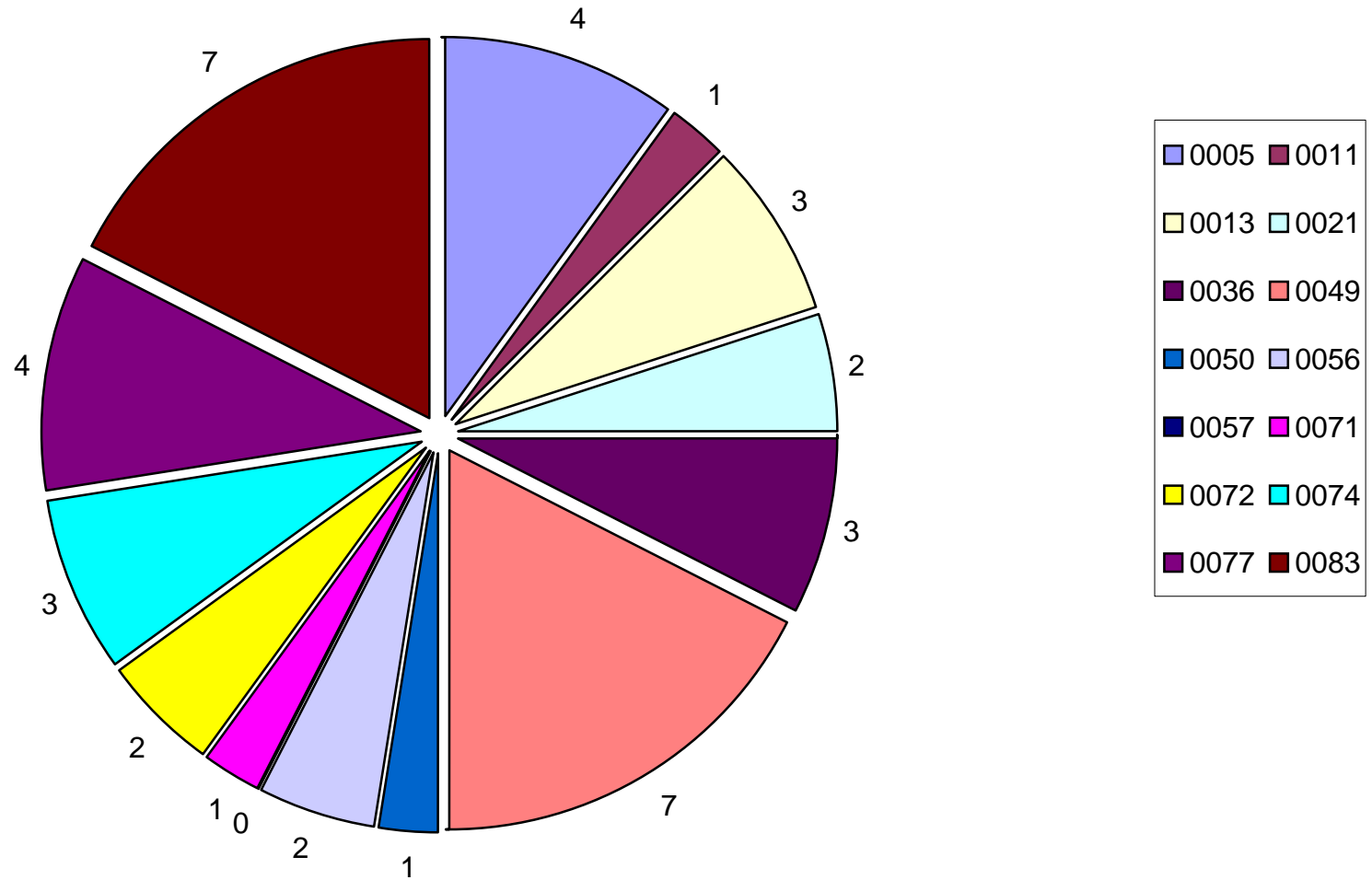
OCC Weighted Closures - Third Quarter 2007 by Investigator

Subject: Online Posting of San Francisco Police Department's General Orders

Recommendation: The Office of Citizen Complaints recommends that the SFPD electronically post its Department General Orders on its public website.

Background: The San Francisco Police Department sets forth its policies and procedures in Department General Orders (DGOs) and department bulletins. Currently SFPD's DGOs are available to the public via California Public Record Act and San Francisco Sunshine Ordinance requests (See California Government Code sections 6250-6276.48; San Francisco Administrative Code, Chapter 67.).

The Police Department frequently receives requests from the media, lawyers, community groups and members of the public for its DGOs. Community groups and individuals have voiced frustration to our agency that these orders are not available online. Several other police departments such as Los Angeles,¹ Oakland,² Seattle,³ Portland,⁴ Denver,⁵ Cincinnati,⁶ Colorado Springs,⁷ and Minneapolis⁸ post their department general orders online.

The Seattle Office of Professional Accountability (OPA) notes many tangible benefits from the Seattle Police Department's (SPD) posting of its orders online. The OPA reported that media and citizen inquiries into police conduct are better informed because the public and news outlets can learn how the department operates prior to contacting the OPA or SPD. OPA can direct citizens to the website for examination of relevant policies at their convenience, and community outreach is made more meaningful by the ability to reference the publicly available manual.⁹

The community and SFPD would both benefit by electronic access to SFPD's DGOs. Unnecessary costs, labor and paperwork associated with requests for DGOs would be greatly reduced. Providing access to these policies on the Department's public website would increase transparency by allowing residents to review SFPD policies


that affect their encounters with police. It would also foster better community relations by providing the public with information about the department's procedures. Additionally, online access would permit the Department to display its innovative policies in areas such as crowd control, prohibition against biased policing and language access.

In conclusion, the Office of Citizen Complaints recommends that the SFPD post its DGOs on its public website. This action would save the Department costs and labor associated with responding to individual requests for this information, enhance the transparency of the department, and assist in educating the public about department procedures.

Subject: Expand the Purview of the Firearm Discharge Review Board to Include Deaths and Serious Injuries Caused by Extended Range Impact Weapons

Recommendation: The Office of Citizen Complaints recommends that Department General Orders 8.11 and 3.10 be amended to permit the Firearm Discharge Review Board to review cases involving death and serious injuries caused by extended range impact weapons.

Background

SFPD officers responded to a call in which an individual with a history of mental illness had barricaded himself in his apartment. SFPD officers spent several hours attempting to negotiate with the individual who was throwing things out the window and intermittently hanging out the second story window on a sheet. At two different times SFPD officers discussed and attempted to use an extended range impact weapon (ERIW)¹ to take the individual into custody. During the second attempt, the ERIW did not fire properly. When the individual saw the ERIW, he ran to the window, climbed onto sheets he had hung outside the window and slipped and fell to his death. The investigation revealed that the two commanding officers at the scene had not received training on the ERIW.

Although they are not designed to kill and are safer than traditional firearms, ERIWs are capable of inflicting serious injury and death.² Injuries caused by ERIWs include broken bones, serious lacerations and puncture wounds.³ Furthermore, ERIWs are not as accurate as traditional firearms; the distance between the officer and a subject is inversely related to the accuracy of the beanbag projectile.⁴ This lack of precision can cause injuries

to the most vulnerable parts of a victim's body including the head, neck, pericardium and groin, areas that are more likely to cause serious injury or death.⁵

In addition to serious injuries, ERIWs can also be fatal. ERIWs may inflict fatal injuries when a beanbag projectile breaks a bone that in turn punctures a vital organ or the beanbag itself penetrates the skin and punctures the organ.⁶ Other fatalities have occurred when officers incorrectly loaded the ERIWs with real bullets instead of less than lethal ammunition because of the similarly marked lethal and nonlethal ammunition.⁷ According to Officer Rutherford, a member of the Butte County Sheriff's Department Special Incident Response Team, bean bag projectiles "...could have lethal capabilities at thirty feet, and are potentially lethal at up to fifty feet."⁸

Unlike firearm discharges, which are subject to a formal review under Department General Orders 8.11 and 3.10,⁹ cases involving the discharge of an extended range impact weapon are not subject to the same degree of scrutiny to determine whether the discharge was appropriate and consistent with department policy and to evaluate the need for any changes to existing policy and training.¹⁰ As in the instant case, ERIWs are frequently used in situations involving mentally ill individuals. Thus, it is even more imperative that ERIW cases be subject to a formal review process to evaluate the appropriateness and benefit of their use, especially because of the frequency with which they are used in situations involving mentally ill individuals. The Ninth Circuit recognizes that when evaluating the reasonableness of an officer's use of force, the mental capacity of the individual plays a significant role: "Even when an emotionally disturbed individual is 'acting out' and inviting officers to use deadly force to subdue him, the governmental interest in using such force is diminished by the fact that the officers are confronted, not with a criminal, but with a mentally ill person."¹¹ Police departments in Los Angeles and Portland recognize that ERIWs are not different than other firearms, especially because of their capability to inflict serious and fatal injuries. Thus, these law enforcement agencies subject ERIWs cases resulting in injury or death to the same review process they use for serious injuries or death caused by traditional firearms.

To better evaluate the effectiveness of ERIWs in incidents, especially because of their frequent use in situations involving mentally ill individuals, the OCC recommends that Department General Orders 8.11 and 3.10 be amended to include review of discharges by extended range impact weapons.



The Board reviews the administrative and criminal investigative reports about the incident, discusses the circumstances surrounding the shooting event and the response of the officer and provides a written summary of its findings to the Chief. The Chief reviews this report for concurrence. The Firearm Discharge Review Board's summary with the Chief's decision is provided to the Police Commission and the OCC and is a public record.

Subject: Protocol for Confirming the Validity of a Bench Warrant Before Making An Arrest

Recommendation: The Office of Citizen Complaints recommends that the San Francisco Police Department amend Department General Order 6.18 to require officers to verify the validity of a bench warrant before making an arrest and to work with the Sheriff's Central Warrant Bureau to develop a protocol for notifying SFPD members of rescinded warrants.

Background

At 4:51am, SFPD officers went to the complainant's apartment, woke her up and arrested her pursuant to a bench warrant.¹ Officers handcuffed her and took her outside her apartment building to be transported. Upon calling the Central Warrants Bureau to confirm the bench warrant, the officer learned that it had been rescinded the previous day. The officers subsequently released the complainant.

The bench warrant in question had been issued seven days prior to the arrest, had been recalled by the court the day prior to the arrest at approximately 2:00 pm, and removed from the Central Warrants Bureau computer system at approximately 7:45 pm, the night before the arrest. Despite the warrant having been removed from the computer system, the arresting officer had obtained a paper copy of the warrant at approximately 1:30 am on the morning of the arrest.

According to the Department's current procedure, when a court issues a bench warrant for arrest, the bench warrant is given to the Sheriff's Central Warrants Bureau for execution. The original warrant is filed within the Central Warrants Bureau. A copy of the warrant is placed in a tray for law enforcement officers to pick up and execute. When a warrant is recalled, sheriff department personnel pull the original warrant, stamp it "recalled," and send it back to the court. The Central Warrants Bureau does not track which warrants were taken for service and by whom. The Central Warrants Bureau does not have a system for rescinding the paper copy of the warrant from the tray where law enforcement officers (including SFPD members) pick them up for execution. The Central Warrants Bureau does not have a system for notifying officers after they have picked up a paper copy of a warrant that the warrant has since been rescinded. The paper copies of warrants in the tray are

¹ In early January 2007 the San Francisco Superior Court issued a warrant for complainant's arrest, commonly called a "bench warrant" when the complainant failed to appear in court for a drug diversion progress report relating to drug charges. (California Health and Safety Code sections 11350 and 11351.5.) The following day the complainant filed a request with the court to have the case calendared for appearance and withdrawal of the bench warrant. Complainant received a new court date for five days later. The complainant appeared in court five days later and the court recalled the bench warrant.

destroyed after seven days. SFPD officers are required to confirm the validity of a warrant before a defendant is **booked**.² Department General Order 6.18 establishes policies regarding warrant checks of citizens, and guidelines for the execution of infraction, misdemeanor and felony warrants.³ However, unlike other Bay Area jurisdictions, officers are not required to check the validity of the warrant before arresting an individual on the warrant.

Oakland and San Jose Police Departments' Warrant Verification Procedures

The Oakland Police Department requires the verification of a warrant **before** an individual's arrest. Oakland Police Department General Order E-6, Arrest Warrants, states in pertinent part, "The issuing authority or agency holding the warrant **must verify all warrant information**, including mobile computer information, **before arrests can be made pursuant to warrant charges.**" (Emphasis added.)


The San Jose Police Department also requires verification of the bench warrant **before an officer can arrest**. Superior Court bench warrants are sent to the Warrants Division. The Warrants Division has a "Beat File" which contains copies of bench warrants from which officers may pull warrants to pursue. However, officers must still personally receive verification directly from the Warrants Division before arresting a subject. To verify that a warrant is valid, an individual from the Warrants Division must have the original warrant in hand, and verify that the status of the warrant is active in the computer system. If a warrant is recalled, the file is pulled from the computer system, the hard copy is pulled and kept in a "recall file," and the copies in the Beat File are immediately pulled to ensure it is not mistaken for an active warrant.⁴

Conclusion

The OCC recommends that DGO 6.18 be amended to require officers to verify the validity of a bench warrant before making an arrest. The OCC also recommends that the Department work with the Sheriff's Central Warrants Bureau to establish a protocol that provides prompt notification of a warrant rescission to SFPD officers who have taken paper copies of warrants for service. Advance verification of bench warrants will not only prevent false arrests, but will also eliminate the waste of resources and unnecessary exposure to risk by officers pursuing rescinded warrants.



Subject: Electronic Recording of Custodial Interrogations

Recommendation: The Office of Citizen Complaints recommends that the San Francisco Police Department's standard practice of electronically recording custodial interrogations be codified in a Department General Order.

Background

The San Francisco Police Department's standard procedure is to electronically record custodial interrogations through audio or videotaping. While it is standard procedure, SFPD has no written rules instructing officers to electronically record custodial interrogations.¹ To preserve this critical evidence and ensure consistency throughout the Department, the OCC recommends that SFPD adopt a Department General Order that requires officers to electronically record custodial interrogations.

In July 2006 the California Commission on the Fair Administration of Justice² issued a report and recommendations on false confessions. To address the problem of wrongful convictions caused by false confessions, the Commission recommended that custodial interrogations be electronically recorded.³ In reviewing false confession data, the Commission pointed out that "research suggests that false confessions are

extracted from the most vulnerable suspects.” Of the 125 false confessions by suspects who were indisputably proven to be innocent, Professors Steven Drizin and Richard A. Leo found one-third of these suspects to be juveniles, another 22% were mentally disabled, and at least 10% were mentally ill.⁴

In recommending the electronic recording of custodial interrogations, the Commission pointed out several benefits to police departments. First, an objective and complete record of the interrogation is created when an interrogation is recorded.⁵ Second, the taping of interrogations will improve their quality because the recording will provide a higher level of scrutiny on the interrogation process thereby enhancing interrogation practices and deterring police misconduct.⁶ This is consistent with Contra Costa County Sheriff’s Office’s observation that, “[r]ecordings allow detectives to ‘later dissect the tapes for the words used and mannerisms of the suspect, and voice inflections. These are subtleties that may go unnoticed without the benefit of tape recording.’”⁷ Third, recording provides police protection from false claims of misconduct.⁸ Lastly, recording enables “...detectives, police managers, prosecutors, defense attorneys and judges...to more easily detect false confessions and more easily prevent their admission into evidence.”⁹

The Commission noted that because of these benefits, over 500 law enforcement agencies in the United States electronically record interrogations, including a substantial number in California.¹⁰ The Commission also emphasized that “[e]xperienced detectives from these departments report great satisfaction with the results of recorded interrogations, including but not limited to higher conviction rates, less time litigating unwarranted suppression motions, and fewer claims of police misconduct.”¹¹

Furthermore, the legal system as a whole benefits from the electronic recording of interrogations. Recording of interrogations preserves evidence, saves tax money and conserves court time. By preserving an objective, comprehensive record of the interrogation, a multitude of evidentiary disputes are eliminated. Additionally, plea agreements increase when guilty suspects are presented with a recording of their own admission. In a study conducted by the National Institute of Justice, police departments that electronically record interrogations reported an increase in the quality and quantity of evidence at trial.¹²

Finally, a Department General Order that requires electronic recording of interrogations would provide consistency in the treatment of all suspects. Recently enacted Department General Order 5.20 requires the tape recording of interrogations involving Limited English Proficient individuals. Proposed Department General Order 7.01 (soon to be presented to the Police Commission) includes a provision that requires the tape recording of interrogations involving juveniles. While research indicates that juveniles, the mentally ill and mentally disabled are particularly vulnerable suspects, the Commission points out that “even fully competent and rational persons may be victimized by coercive interrogation tactics.”¹³ Thus, the rationale for recording interrogations of juvenile and LEP suspects applies equally to all other suspects.



Subject: Alerting Officers to Use Correct Vehicle Code Section for Parking Violations At Wheelchair Access Ramps By Issuing a Department Bulletin, Providing Roll Call Training and Revising The Citation Form

Recommendation: The Office of Citizen Complaints recommends that the San Francisco Police Department:

1. Issue a Department Bulletin and provide roll call training that alert officers as to the correct Vehicle Code section to use when enforcing parking violations at wheelchair access ramps.
2. Revise the standard SFPD citation form to include the correct violation for parking at a wheelchair access ramp (VC 22500 (1)).

Background

An officer cited the complainant twice in one week at the intersection of Randolph and Ralston streets for violating Vehicle Code Section 22522, which states:

No person shall park a vehicle within three feet of any sidewalk access ramp constructed at, or adjacent to, a crosswalk or at any other location on a sidewalk so as to be accessible to and usable by the physically disabled, if the area adjoining the ramp **is designated by either a sign or red paint.** (Emphasis added.)

Although it was not possible to know the precise position of the complainant's vehicle, it is beyond dispute that the area adjoining the access ramp is not designated by either a sign or red paint. Therefore, the complainant did not violate Vehicle Code Section 22522. The parking citations were dismissed.

If the complainant had been blocking any part of the access ramp, the officer could have properly cited him for violating Vehicle Code Section 22500(1). Vehicle Code Section 22500 (1) states:

No person shall stop, park, or leave standing any vehicle whether attended or unattended...in front of or upon that portion of a curb that has been cut down, lowered, or constructed to provide wheelchair accessibility to the sidewalk.

The standard SFPD parking citation form currently lists only Vehicle Code Section 22522, and does not note the requirement of red paint or sign. Vehicle Code Section 22500(1) is not currently listed on the face of the standard SFPD citation form, despite the fact that the majority of wheelchair access ramps in the city are not marked with a sign or red paint.

In 2003, the Department of Parking and Traffic issued a training bulletin for its officers clarifying the difference between Vehicle Code 22500(1) and Vehicle Code 22522. The bulletin (No. 99-02) states, in pertinent part:

VC22500(1) – BLOCKING WHEELCHAIR RAMP
EFFECTIVE 01-01-03, VC22500(L) NO LONGER REQUIRES RED PAINT ON THE TIPS TO ENFORCE THE VIOLATION.

VC22522 – WITHIN THREE FT. OF RAMP
RED PAINT ON THE TIPS OF THE WHEELCHAIR RAMP IS REQUIRED TO ENFORCE VC22522.

In conclusion, the OCC recommends that the San Francisco Police Department issue a Department Bulletin and provide roll call training that alert officers as to the correct vehicle code section to use when enforcing parking violations at wheelchair access ramps.

The OCC also recommends that the standard citation form be revised to include the correct violation for parking at a wheelchair access ramp (VC 22500 (1)).

Subject: Taxicab Use of Bus Zones for Picking Up and/or Dropping Off of Passengers.

Recommendation: The Office of Citizen Complaints recommends that SFPD's Taxicab Detail, the Taxi Commission and the Municipal Transportation Agency meet with any other relevant stakeholders to establish a policy concerning taxicab use of bus zones for dropping off or picking up passengers.

Background

The Department of Parking and Traffic has a written policy that permits taxicabs to pick up or drop off passengers in the bus zones.¹ SFPD's Taxicab Detail has endorsed this practice of permitting taxicabs to pick up or drop off passengers in the bus zones.² According to DPT and SFPD's Taxicab Detail documents, this courtesy is permitted to encourage the use of public transportation. However, San Francisco Traffic Code Section 62A prohibits anyone, including taxis, from stopping in a bus zone.³

The Office of Citizen Complaints received a complaint from a taxicab driver who was ticketed for violating Traffic Code section 62A when the driver stopped in a bus zone at Fillmore and Union to drop off a passenger. The complainant provided documents from DPT and SFPD's Taxicab Detail that stated taxicab drivers were permitted to use bus zones to pick up and drop off passengers.

The Office of Citizen Complaints recommends that the Taxi Commission, the Municipal Transportation Agency⁴, and the Taxi Detail Department of the SFPD meet with any other relevant stakeholders to formulate a written policy concerning taxicab use of bus zones. This action would alleviate confusion among taxicab

The letter was a request for consideration to void a parking ticket that was issued to a taxicab for stopping for a short period of time in a bus zone.


