
Re: San Francisco Department of Police Accountability May 2021 Monthly Statistical Report


Summary of Complaints Received in May 2021

The Department of Police Accountability received **68** cases in **May 2021**, compared with **56** cases in the same period last year. The **May 2021** case total is **16%** higher the five-year average and **21%** higher than the previous year.

From January through May, the DPA received a total of **334** new cases, compared with the **321** cases filed during the same period in 2020. The May year to date case total represents a **4%** increase in new complaints over last year.
