Subject: Certification of RCV vote totals

Please require that the certification of RCV tally vote totals and their supporting detail be part of the election plan for this November's election. As an example, an adequate certification would satisfy:

1. For each RCV contest:

- a) The round-by-round, contest-level vote totals for all qualified candidates are certified and directly listed or included in a referenced attachment.
- b) The contest cast selection record file (a.k.a. ballot image file) is certified with a reference to a long-term URL on a departmental web site holding that file.
- 2. The certification letter and its attachments are published on a departmental web site so that the certification is as easy to find as any other final election results.
- 3. Any certified totals of first choices as marked are clearly identified as such.

This is in contrast to past certification practices, such as in 2014, that did not certify any RCV tallies. Instead, the certification treated RCV contests as if they were not RCV contests and only totals of first choices as marked were certified. Totals of first choices as marked completely ignore marked second and third choices and can grossly understate the number of votes a candidate ultimately receives in an RCV tally.

The past certification practices can be particularly misleading and confusing when the RCV winner, the candidate who receives the most votes in the RCV tally, is not the candidate who received the most total first choices as marked.

The certification letter for the November, 2014 election was not published on a departmental website where it could be easily found. For RCV contests, the certification fell well short of its claim of presenting a complete record of the tabulation of all votes recorded.

As a recent example, the 2014 contest for District 10 Supervisor required more than one round in the RCV tally in order to determine the winner. However the vote totals of the RCV tally were not certified. The totals that were certified were not identified as being only totals of first choices as marked. Malia Cohen was certified as receiving 7,141 votes, yet she received 7,176 votes in the first round of the RCV tally and won with 7,719 votes.

Totals of first choices as marked are only precursors to the real RCV vote totals in

the first round of an RCV tally. The first-round vote totals represent effective first choices, effective in the sense that they have been adjusted for skipped rankings, as required by charter section 13.102, subdivision (a). First-round vote totals represent the type of first choice referred to in that section's subdivision (c) and so are what the charter specifies for use in determining whether there is a first-round winner or which candidate(s) will be eliminated next.

As the nominal capstone to the election process, the certification of vote totals is an important work product of an election official and carries significant legal implications. San Francisco's past certification practices for RCV do not adequately fulfill the requirements of state law as properly applied to RCV, nor do they support a sufficient level of transparency and accountability necessary for trustworthy elections.

The election plan that has been submitted for your approval would allow these inadequate certification practices to continue without change.

The Elections Commission should no longer approve the continuation of these past certification practices. Instead, the Elections Commission should insist on improvements, such as those outlined above.
