# 2. General Public Comment

## Public Comment

- C. Jay Coles, Senior Policy Associate with Verified Voting expressed opposition to Blockchain voting and feels internet voting is high risk.
- Richard Tam of the Voting Rights Task Force expressed opposition to Blockchain Voting.
- Jim Soper, Co-Chair Voting Rights Task Force, opposed Blockchain Voting because it is illegal in California.
- Brent Turner expressed opposition to Blockchain Voting, expressed funding should be on Open Source Voting.
- David Jefferson stated his opposition to internet voting, discussed legality of it and that hackers would easily be able to access voter information.
- Barbara Simons expressed opposition regarding Blockchain Voting and questioned funding source for it.

# 3. Resolution on Continuation of Remote Elections Commission Meetings

Vice President (VP) Jung explained that this item is based on AB 361, which allows policy bodies to meet remotely. He asked to add to the resolved section the phrase "resolved, that SFEC, for itself and for all of its committee's including without limitation, BOPEC, finds as follows."

#### 6. Open Source Voting

Commissioner Jerdonek specified this item is an update on what has happened since the last meeting, and what was submitted in the packet on this item.

Director Arntz commented on the plan/proposal that VotingWorks submitted and meeting with President Bernholz, and Commissioner Jerdonek to discuss it. Director Arntz stated he was able to get a sense of what was being considered with the pilot program.

Commissioner Jerdonek reported he had a meeting with the Secretary of State's Office, organized by the President of the Board of Supervisors Shamann Walton and the President of the Board of Supervisors for San Mateo County, David Canepa.

Commissioners Mogi and Chappell had questions about the procedure and next steps on the Open Source Voting pilot. Deputy City Attorney Ana Flores explained the procedure and the need to wait for regulations issued by the Secretary of State (SoS) before moving further with a pilot.
