5. Remote Ballot Completion and Submission for People with Access and Functional Needs Project

A Request For Proposal (RFP) was issued on April 2021.

Guests in Attendance: Francis Zamora, Chief of Staff of Department of Emergency Management; Craig Dziedzic, General Manager of Bay Area UASI; Linda Gerull, Director of the Department of Technology; and Deborah Kaplan, Mayor's Office on Disability.

A statement about the Remote Ballots Project from the Department of Emergency Management and the Bay Area UASI Management Team was included in the agenda packet. The Commission discussed the project and the statement with the four guests. The project was changed not to include the design and development of any new technology, which is the part that contained the references to internet voting that the Commission was concerned about. The April 2021 RFP would be canceled, and equipment purchases would be made instead that are acceptable under current election regulations. Director Gerull also stated in response to a question that the identity and access management project would not continue in the future as a San Francisco only project either.
