#### 6. June 7, 2022 Consolidated Statewide Direct Primary

Director Arntz explained which portions of the Election Plan for this election are new. The plan is similar to the plan for the February and April elections.

The Commissioners discussed a number of questions with Director Arntz. He was asked:

- 1. Has there been any intimidation, harassment, or threat problems as with national trends, and would this type of behavior be captured in the incident report?
- 2. Can he explain the reference in the plan to the San Francisco Unified School District (SFUSD) needing security at some school locations?
- 3. Is the increase in vote-by-mail creating a need for more poll sites or affecting where they are located?
- 4. Is San Francisco a Voter's Choice Act jurisdiction?
- 5. Can the number of voting places be considered in re-precincts?
- 6. Can the comment in the plan about language access be explained? What was behind the Secretary of State revising the number of languages needed for San Francisco from four to five?
- 7. For what reasons do people go into City Hall to vote?
- 8. Are ballot-marking devices taken directly to people, if necessary?
- 9. Why do the drop boxes need to be cleaned, and is this a significant problem?
- 10. How does the waiting time app work for precinct polling places?

## **Public Comment**

Brent Turner commented on tabulating ballots.

David Pilpel expressed his support for the election plan that Director Arntz submitted.

Commissioner Dai moved to approve the plan for the June 7, 2022 Consolidated Statewide Direct Primary. Seconded by Commissioner Shapiro.

## 8. Open Source Voting

Commissioner Jerdonek reviewed the list of attachments in the agenda packet for this item. Director Arntz gave an update on this topic. They both reported updates on the actions being taken by the Secretary of State (SOS).

#### Speaker: Matt Roe, VotingWorks

Mr. Roe said there was a lack of clarity from the SOS Office around the requirements for the pilot program and what was considered a pilot program. He explained the status of the pilot and the pilot regulations.

President Bernholz asked Mr. Roe if he knew of any other jurisdictions planning on submitting a pilot program, and she commented on the regulations.

Commissioner Dai commented that Los Angeles County submitted documentation to the SOS in October 2021 for a pilot program. Mr. Roe noted that they do not use ranked-choice voting.

DCA Flores mentioned that the public has the option of providing feedback.

## **Public Comment**

Brent Turner highly recommended VotingWorks as an option for voting systems.

## 9. Dominion Voting Systems Contract Extension

#### 10. Redistricting Process Improvements

Commissioner Dai commented on the <u>discussion</u> document posted on the website for this item. In addition, she made recommendations based on her experience <u>as a California Citizens Redistricting Commissioner</u>.

Commissioner Jerdonek asked questions about the document and provided some recommendations.

Commissioner Shapiro recommended discussing this item once the final report is posted by the Redistricting Task Force (RTF) and spending time determining the process.

President Bernholz suggested obtaining more information on the overall redistricting process. She asked DCA Flores if the Elections Commission has the authority to put together an amendment. DCA Flores responded by saying the Elections Commission does not have the authority. Only the Board of Supervisors can put forth a Charter Amendment. This Commission may draft a letter, but not a Charter Amendment. The RTF is an independent body and responds to the citizens of the City of San Francisco. The topic could be discussed at a Budget and Oversight of Public Elections Committee (BOPEC) meeting or another sub-committee or task force created.

President Bernholz recommended that Commissioners Dai and Shapiro work on a sixmonth public education plan to review San Francisco's redistricting processes and learn about best practices from experts. Then the Elections Commission could solicit input from the public and recommend reforms that might take the form of a Charter Amendment. Commissioners Dai and Shapiro agreed to develop a work plan for the full Commission to review at the next meeting.

#### **Public Comment**

David Pilpel reported that Tuesday, May 24, 2022, is the deadline for introduction of charter amendments to the Board of Supervisors for the November election.

Lauren Girardin of the San Francisco League of Women Voters is happy to provide any history of the task force since they attended all RTF meetings.

Steven Hill, a San Francisco resident, commented on his experience with the process and made suggestions to explore more options.

## 11. Director's Report

Commissioner Shapiro asked if there is any transparency on details around Racial Equity. Director Arntz explained the channels through which information is obtained.
