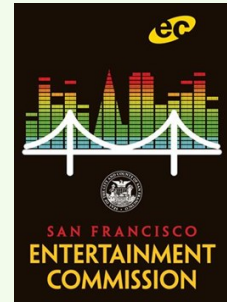

Bottled Water Ban...now includes "Packaged" Water

Starting October 1, 2016, no person may sell or distribute bottled water at an indoor or outdoor event held on City property, including a City street or park.

Starting March 1, 2017, this rule includes all "packaged water," which is defined as "drinking water in a sealed box, bag, can, glass bottle, rigid plastic bottle or other container."

Exceptions to the ban include:

- ◆ Sale or distribution of bottled/packaged water to participants in a participant athletic event
- ◆ An event that is sponsored by a not-for-profit organization and that has over 250,000 attendees or participants.

Food/Bev Vendors: New Hand Washing Station Requirements

Each hand washing station for food and beverage vendors (a.k.a. Temporary Food Facilities) is now required to have warm water (100 degrees F) in a 5-gallon insulated water dispenser.

Reminder: Important Public Health **Deadlines** for Temporary Event Permits ...

- ◆ 14 Days or More Prior to Event: All completed applications and fees must be received by Dept. of Public Health (DPH).
- ◆ 13 - 8 Days Prior to Event: All completed applications will be assessed a 50% late fee from DPH.
- ◆ 7 Days or Less Prior to Event: Applications will be denied by DPH and no food or beverage service shall be allowed.

Beverage Dispensers with Carbon Dioxide (CO₂)

Every event with beverage dispensers with *more than 100 lbs of CO₂* (combined total) in the event space now requires a Fire Permit and an Inspection on-site from the Fire Department.

Need-to-Know: Your Street Clean-Up Plan & Barricades

All Temporary Street Closure applications must include the following info:

- ♦ Street Clean-Up Plan – include a detailed description of the event sponsor's plans to handle waste disposal and recycling: description of who, what, how, when, and where
- ♦ The contact person, company name, phone and email of any company you are using for clean-up (e.g., Recology, event greener, etc.)
- ♦ Company name and contact info of any private vendor providing street barricades for the event

Reminder for Barricades:

All road closures require metal barricades (6.5 ft or 8 ft). After sundown, A-frame barricades with flashers illuminated are required to be placed next to the metal barricades.
