At the LAFCO hearing held September 12, 2008, staff presented two position descriptions for LAFCO staff members to assist with the development and implementation of the CCA Program. After reviewing these position descriptions, the Commission requested that staff work with the SFPUC and bring additional information back to the Commission at its next hearing.

Based on the Commission's direction, staff presented revised position descriptions for the proposed staff members and additional information regarding LAFCO's authority to hire additional staff to assist with CCA Program development and implementation at the October 24, 2008, Commission hearing.

In December, 2008, SF LAFCO was contacted by the Budget Analyst's Office for additional information on the proposed CCA positions. This item will be reviewed by the Government Audit and Oversight Committee at its next hearing. Unfortunately, there is not yet a Government Audit and Oversight Committee hearing on calendar for 2009.

Staff recommends that the Commission direct the Executive Officer to move forward with hiring CCA staff if the Government Audit and Oversight Committee and the Board of Supervisors authorize the addition of the two positions. The Executive Officer will work with the SFPUC to ensure that any new CCA staff will complement the staff recently hired by the SFPUC, and will not duplicate the work being performed at the SFPUC.

The Executive Officer will exercise her discretion, and will only fill the authorized positions at such time as it is necessary. The Executive Officer wants to ensure that any additional CCA staff will add value to the ongoing CCA effort, and increase the efficiency of the Program.

At this time, the Executive Officer expects that the addition of CCA staff will result in a reduction of legal costs, as many of the Executive Officer's CCA duties will be transferred to the new CCA staff.
