Item 5: Authorization to Extend Two LAFCo Staff Positions:

Senior Program Officer 9775

Community Development Assistant 9770 (Discussion and Possible Action Item)

<u>Background:</u> At your hearing on April 27, 2012, staff requested that the Commission extend the term of employment for the two positions referenced above through June 30, 2012. At your April meeting the Commission approved the extension of these two positions by motion. Rather than taking this action by motion, staff should have requested that the Commission approve a resolution reflecting this action. Therefore, the proposed resolution attached hereto approves the extension of the staff terms, as requested, and authorizes the Interim Executive Officer to request, in coordination with the SFPUC and the CCSF, the extension of the terms.

As staff explained during the April meeting, in January 2009, LAFCo authorized the interim Executive Director to move forward with hiring two staff members to work on CCA matters, a Senior Community Development Specialist, and a Community Development Assistant. This authorization was contingent on authorization of these two positions by the Government Audit and Oversight Committee and the Board of Supervisors.

In March 2009, the Board of Supervisors for the City and County of San Francisco passed Ordinance No. 141-08, amending the annual salary ordinance to include two additional staff positions for SF LAFCO. In April 2009, the SFPUC and SF LAFCo entered into an MOU to transfer funds from SFPUC to SF LAFCo.

As a result, Jason Fried, the Senior Community Development Specialist was hired in August 2009. His term is set to expire in August 2012. We have sufficient funding from the SFPUC MOU to continue the funding of the position for an additional fiscal year to end June 30, 2012. The second staff position, the Community

Development Assistant, is not currently filled, and it is not intended to be filled at this time. However, the Commission may determine to fill the position at a future date, and sufficient funds are available to fund this position through Fiscal Year 2012/2013.

Recommendation: Staff recommends that the Commission approve the proposed resolution to extend the time for the appointment of the two CCA staff members through June 30, 2013, and authorizing the Interim Executive Officer to request, in coordination with the SFPUC and the CCSF, the extension of these terms.

The duties and responsibilities of the two staff members will be continue to be assigned by the Interim Executive Officer and the Commission, and will not necessarily be limited to Clean Power SF related tasks.

18	and a Senior Program Officer if the Government Audit and Oversight Committee and the
19	Board of Supervisors authorized the addition of the two positions;
20	WHEREAS, in March 2009, the Board of Supervisors for the City and County of San
21	Francisco passed Ordinance No. 141-08, amending the annual salary ordinance to include
22	two additional staff positions for SF LAFCO to assist with the development and
23	implementation of the CCA program; and
24	WHEREAS, while these positions were initially established as short-term positions,
25	given the current status of the CCA program, the Interim Executive Director has

1	recommended a one-year extension of both positions through June 30, 2013, utilizing the					
2	funding currently available.					
3	THEREFORE BE IT RESOLVED, that the Local Agency Formation Commission of the					
4	City and County of San Francisco hereby extends the term of these two positions, and
