3. Community Choice Aggregation (CCA) Activities Report

A. Status update on CleanPowerSF Program

Michael Hyams, CCA Director (San Francisco Public Utilities Commission (SF PUC)), informed the Commission that the CleanPowerSF Program is now operational and began serving customers on May 1, 2016. He also provided current enrollment statistics and an overview of next steps for the Program.

Charles Sheehan, Acting Communications Director (SF PUC), provided an overview of the national CNBC news story that he worked with the Mayor's Office on regarding San Francisco's clean energy goals, which specifically highlighted the CleanPowerSF Program. He also provided an update on the outreach and marketing activities for the Program.

Jason Fried, Executive Officer (LAFCo), provided additional information on outreach and marketing activities that he will be participating in during upcoming events. He also provided an update on the analysis done regarding the jobs that have been or will be created for the Program.

B. Status update on proceedings at the California Public Utilities Commission (CPUC)

Director Hyams indicated the SF PUC continues to monitor the proceedings at the CPUC, including whether any activities will affect costs for the CleanPowerSF Program. The SF PUC continues to work with all other local CCAs on these issues.

Public Comment: Jed Holtzman; recommended staff monitor online information regarding the Program and provided suggestions on phasing.

Officer Fried provided a brief overview of the Report and the minor changes made from the "Draft" to the "Final" versions.
