#### 1. Call to Order and Roll Call

#### B. Status Update on Proceedings at the California Public Utilities Commission

The Commissioners opened up the discussion by thanking SFPUC and LAFCo staffs and other Commissioners for all their efforts, hard work and progress with the CleanPowerSF program.

Nancy Miller, Interim Executive Officer, LAFCo, recognized both the SFPUC and LAFCo staffs for their efforts on getting program approvals, along with the Commission for their

combined years of service. Ms. Miller indicated that a Joint Meeting of LAFCo and SFPUC is being coordinated, per the Commission's direction, for an October date to be determined.

Barbara Hale, SFPUC, gave an update of the program changes now that the Board of Supervisors' approvals are done, along with what focuses and goals have been identified. Ms. Hale reviewed the next steps for SFPUC staff, including the progress of the program's contracts and outreach efforts. At the October 9<sup>th</sup> SFPUC meeting, the SFPUC will be awarding the marketing contract.
