# **Regular Meeting**

**Present:** Commissioners Cynthia Crews-Pollock, Sandra Lee Fewer, Matt Haney, and Gordon Mar

The San Francisco Local Agency Formation Commission (SF LAFCo) met remotely in regular session on Friday, May 15, 2020, with Chair Sandra Lee Fewer presiding.

Chair Fewer called the meeting to order at 10:04 a.m.

### 1. Call to Order and Roll Call

On the call of the roll, Chair Fewer, Vice Chair Crews-Pollock, Commissioners Haney and Mar were noted present.

## 2. Approval of the LAFCo Minutes from the April 17, 2020, Regular Meeting

## 3. Consideration and Approval of the Proposed LAFCo Budget for Fiscal Year 2020-2021

Bryan Goebel, Executive Officer (LAFCo), provided an overview of the proposed budget for fiscal year 2020-2021, including two proposed budget options, the General Fund balance, history and mission, special studies authority and fundraising, funding sources, proposed work plan with increased resources, CleanPowerSF work plan, CCA work order balance,

Supervisor Fewer, seconded by Supervisor Haney, moved to APPROVE the Proposed Fiscal Year 2020-2021 Budget Option 1 in the amount of \$783,691 with a recommendation that any increases in the LAFCO budget are contingent upon receiving an increase of funds in the City and County of San Francisco budget. # 7. Presentation and Discussion on the LAFCo Report Assessing Bank Accountability in San Francisco during the COVID-19 Pandemic

Cara Yi, Coro Fellow in Public Affairs, LAFCo Research Associate, presented a power point presentation and provided an overview of the research done and her findings on the report, "Assessing Bank Accountability: The COVID-19 Community 'Stress Test," including banks and the banking system, the CARES Act, accessibility of available relief, and recommendations.

An updated MOU may not be required, but they will keep the Commission updated on the progress.

Individuals and entities that influence or attempt to influence local legislative or administrative action may be required by the San Francisco Lobbyist Ordinance [SF Campaign & Governmental Conduct Code, Section 2.100] to register and report lobbying activity. Under Campaign and Governmental Conduct Code, Section 1.127, no person or entity with a financial interest in a land use matter pending before the Board of Appeals, Board of Supervisors, Building Inspection Commission, Commission on Community Investment and Infrastructure, Historic Preservation Commission, Planning Commission, Port Commission, or the Treasure Island Development Authority Board of Directors, may make a campaign contribution to a member of the Board of Supervisors, the Mayor, the City Attorney, or a candidate for any of those offices, from the date the land use matter commenced until 12 months after the board or commission has made a final decision, or any appeal to another City agency from that decision has been resolved.
