Regular Meeting

The San Francisco Local Agency Formation Commission (SF LAFCo) met in person in regular session, and provided public comment through teleconferencing, on Friday, November 17, 2023, with Vice Chair Fielder presiding.

Vice Chair Fielder called the meeting to order at 10:05 a.m.

1. Call to Order and Roll Call

On the call of the roll, Vice Chair Fielder, and Commissioners Dean Preston and Hope Williams were noted present.

A quorum was present.

2. Approval of the LAFCo Minutes from the September 15, 2023, Regular Meeting

Vice Chair Fielder inquired whether any Commissioner had any corrections to the minutes. There were no corrections.

Public Comment: None.

Commissioner Preston, seconded by Commissioner Williams, moved to APPROVE the minutes of the September 15, 2023, Regular Meeting of the San Francisco Local Agency Formation Commission. The motion carried by the following vote:

3. Midtown Park Apartments Municipal Housing Management Study Updates

Fernando Marti, LAFCo Consultant, provided a power point presentation on the Midtown Park Apartments community visioning process and needs assessment, including the community engagement process, the conditions assessment report, the final report, and the first resident-wide meeting.

Public Comment:

Vice Chair Fielder requested Item Nos. 4 and 5 be called together.

4. CleanPowerSF Updates

A) CleanPowerSF Activities

Michael Hyams, CCA Director (San Francisco Public Utilities Commission), provided a power point presentation with an update on the CleanPowerSF Program including enrollment and service statistics, California Community Power, and Green Power Program recognition.

B) LAFCo Updates on CleanPowerSF Activities

Jeremy Pollock, Executive Officer (LAFCo), provided opening remarks.

Khalid Samarrae, Police Analyst (LAFCo), provided a power point presentation with updates on CleanPowerSF, including the Greenhouse Gas Reduction Fund (GGRF), GGRF letters of support, the Building Operations Task Force, SF Green Bank and Climate Action Plan, and next steps for SF Green Bank.

Public Comment: Thierry Fill; shared concerns regarding clean power and the power used to create it.

There was no action taken.

5. Purchase Order Approval – Arup North America, Ltd. – Battery Energy Storage Systems Study - Not-to-exceed \$75,000

Jeremy Pollock, Executive Officer (LAFCo), provided a power point presentation on the Purchase Order approval, including the Battery Energy Storage Systems Study, and recommended the Commission authorize the Purchase Order.

Michael Hyams, CCA Director (San Francisco Public Utilities Commission), expressed support for the proposed study and provided additional information.

Public Comment: Thierry Fill; expressed the need to recycle in a clean way.

Commissioner Fielder, seconded by Commissioner Williams, moved to APPROVE and authorize the Executive Officer to execute a Purchase Order to Arup North America,

Ltd. for an amount not-to-exceed \$75,000 to conduct the Battery Energy Storage Systems Study in substantially the form of the scope of work attached with any minor non-substantive revisions agreed to by the General Counsel. The motion carried by the following vote:
