Regular Meeting

Present: Commissioners Hillary Ronen (Chair), Dean Preston, Isaac Sevier, and Shanti Singh

The San Francisco Local Agency Formation Commission (SF LAFCo) met in person in regular session, and provided public comment through teleconferencing, on Friday, September 20, 2024, with Chair Ronen presiding.

Chair Ronen called the meeting to order at 10:02 a.m.

1. Call to Order and Roll Call

On the call of the roll, Commissioners Preston, Ronen, Sevier and Singh were noted present.

Vice Chair Williams was noted not present.

2. Approval of the LAFCo Minutes from the July 19, 2024, Regular Meeting

Chair Ronen inquired whether any Commissioner had any corrections to the minutes. There were no corrections.

3. Final LAFCo Study for CleanPowerSF on Battery Energy Storage Systems

Jeremy Pollock, Executive Officer (LAFCo), provided brief opening remarks and background information on the study.

Mike Lepisto and Cole Roberts (Arup International) provided a presentation on the LAFCo Study for CleanPowerSF on Battery Energy Storage Systems, including an introduction of their team, battery technology comparison, state and local codes for Group R-3 occupancies (1-2 residential buildings), the San Francisco Fire Department Administrative Bulletin 5.12, permitting and Solar APP+, other sections of the study, and recommendations.

Fernando Marti, LAFCo Consultant, provided a presentation on the Midtown Park Apartments, including the community engagement process, community goals, resident control principles, ownership options, physical conditions assessment, final community recommendations, building renovations, relocation and return, operating finances, ownership transition, and next steps.
