#### **Program Description:**

### Internship Description:

The SF LAFCo CleanPowerSF intern will work closely with the Executive Officer to monitor all aspects of CleanPowerSF. This will be a unique opportunity to get steeped in local and state renewable energy issues, working with the SFPUC, San Francisco Board of Supervisors, and regional and state legislators. Under close supervision and guidance, interns will help craft policy positions on local, regional and state legislation related to energy issues and community choice energy programs. The intern will also assist in special studies related to CleanPowerSF, including local buildout of renewable energy projects. The ideal candidate will be organized, self-motivated and an excellent communicator with good writing skills and a passion for renewable energy issues. Interns will work at San Francisco City Hall and report to the SF LAFCo Executive Officer. We are looking for someone to start in January, but are flexible about the date.

SF LAFCo encourages women, minorities and persons with disabilities to apply. Applicants will be considered regardless of their sex, race, age, religion, color, national origin, ancestry, physical disability, mental disability, medical condition (associated with cancer, a history of cancer, or genetic characteristics), HIV/AIDS status, genetic information, marital status, sexual orientation, gender, gender identity, gender expression, military and veteran status, or any other protected category under the law.
