3 **Resolution commending Supervisor John Avalos for his distinguished service as a**  
4 **member of the San Francisco Local Agency Formation Commission.**

6 WHEREAS, Supervisor John Avalos was appointed as a member of the San Francisco  
7 Local Agency Formation Commission (LAFCo) on February 24, 2009 as an alternate  
8 member, and reappointed for a regular seat on December 15, 2009 and again in 2014; and

9 WHEREAS, Supervisor John Avalos has served as Chair of LAFCo for four  
10 consecutive years from 2013-2016 and served as Vice-Chair in 2012; and

11 WHEREAS, Supervisor John Avalos has embraced LAFCo as a forum for exploring  
12 numerous special studies in the areas of Community Choice Aggregation, San Francisco  
13 voting systems and processes, refuse operations, undergrounding of utility wires, and  
14 expansion of the fiber network; and

15 WHEREAS, Supervisor John Avalos was instrumental in the studies and development  
16 of the Implementation Plan for Community Choice Aggregation, several market research  
17 projects, and several reports to help San Francisco better understand how to properly  
18 establish a Community Choice Aggregation program; and

19 WHEREAS, Supervisor John Avalos was Chair of the Commission when the City's  
20 Community Choice Aggregation program was launch in San Francisco; and

21 WHEREAS, Supervisor John Avalos has faithfully served the Commission by  
22 participating in hearings to bring forward issues for consideration by the Board of Supervisors  
23 and the Commission, including hearings on renewable energy, wind, solar, tidal power, as  
24 well as other renewable energy sources; now, therefore, be it
