3 **Resolution commending Supervisor David Campos for his distinguished service as a**
4 **member of the San Francisco Local Agency Formation Commission.**

6 WHEREAS, Supervisor David Campos was appointed as a member of the San
7 Francisco Local Agency Formation Commission (LAFCo) on January 6, 2009, and
8 reappointed for two more terms in 2011 and 2015; and

9 WHEREAS, Supervisor David Campos has served as Chair of LAFCo for two
10 consecutive years from 2011-2012, along with being Vice-Chair in 2010; and

11 WHEREAS, Supervisor David Campos is the longest serving Commissioner appointed
12 by the City and County of San Francisco to serve on the San Francisco Local Agency
13 Formation Commission to date; and

14 WHEREAS, Supervisor David Campos has embraced LAFCo as a forum for exploring
15 numerous special studies in the areas of Community Choice Aggregation, San Francisco
16 voting systems and processes, refuse operations, undergrounding of utility wires, and
17 expansion of the fiber network; and

18 WHEREAS, Supervisor David Campos was instrumental in the studies and
19 development of the Implementation Plan for Community Choice Aggregation, several market
20 research projects, and several reports to help San Francisco better understand how to
21 properly establish a Community Choice Aggregation program; and

22 WHEREAS, Supervisor David Campos was Chair when the SFPUC General Manager
23 agreed to support the launch of the CCA program; and

24 WHEREAS, Supervisor David Campos has faithfully served the Commission by
25 participating in hearings to bring forward issues for consideration by the Board of Supervisors

1 and the Commission, including hearings on renewable energy, wind, solar, tidal power, as
2 well as other renewable energy sources; now, therefore, be it

3 RESOLVED, That the members of the San Francisco Local Agency Formation
4 Commission, do hereby gratefully recognize the distinguished contributions that
5 Commissioner Supervisor David Campos has made to the welfare of this community, and
6 express their great appreciation and best wishes for success in his future endeavors.
