3 **Resolution commending Supervisor Eric Mar for his distinguished service as a**  
4 **member of the San Francisco Local Agency Formation Commission.**

6 WHEREAS, Supervisor Eric Mar was appointed as a member of the San Francisco  
7 Local Agency Formation Commission (LAFCo) on February 24, 2009, and reappointed as an  
8 alternate three times on December 19, 2009, January 24, 2012, February 25, 2014 and  
9 reappointed to a regular seat on April 7, 2015; and

10 WHEREAS, Supervisor Eric Mar has embraced LAFCo as a forum for exploring  
11 numerous special studies in the areas of Community Choice Aggregation, San Francisco  
12 voting systems and processes, refuse operations, undergrounding of utility wires, and  
13 expansion of the fiber network; and

14 WHEREAS, Supervisor Eric Mar was instrumental in the studies and development of  
15 the Implementation Plan for Community Choice Aggregation, several market research  
16 projects, and several reports to help San Francisco better understand how to properly  
17 establish a Community Choice Aggregation program; and

18 WHEREAS, Supervisor Eric Mar is the only LAFCo member to serve in three different  
19 seats on the Commission, along with being the only member to leave LAFCo and then return  
20 to the Commission; and

21 WHEREAS, Supervisor Eric Mar has faithfully served the Commission by participating  
22 in hearings to bring forward issues for consideration by the Board of Supervisors and the  
23 Commission, including hearings on renewable energy, wind, solar, tidal power, as well as  
24 other renewable energy sources; now, therefore, be it

2 Commission, do hereby gratefully recognize the distinguished contributions that  
3 Commissioner Supervisor Eric Mar has made to the welfare of this community, and express  
4 their great appreciation and best wishes for success in his future endeavors.


