Chief Fong updated the Commission regarding National Night Out on August 1st.

Chief Fong stated she wanted to address the two items that came up during public comment. Chief Fong stated that Sgt. Gittens is still working on a number of press passes and that he is still working on those press passes. Secondly, in regards to the Sullivan family, Chief Fong stated that a second letter was sent to the legal counsel and since that letter, the Department have not received any response from that legal counsel.

Commissioner Veronese commended the Chief and the Committee who organized Officer Birco's services. Commissioner Veronese stated that just because a lawsuit is filed he does not think that information should be cut off to the family. Commissioner Veronese also stated that Ace Washington would be a great asset in getting information to the communities and would like an explanation as to why he does not have his press pass.

Commissioner Sparks thanked the Chief and the Department for the services for Officer Birco. Commissioner Sparks asked about the process for press passes and asked how it can be expedited. Commissioner Sparks also asked about the Sullivan matter and asked how comments and/or opinions get out to the media or to the public. Chief Fong stated that she does not know how opinions and comments get to the media. Commissioner Sparks also asked what information were made available to the Sullivan and the Lefiti family. Chief Fong stated that she can't speak as to the Sullivan matter but in the Lefiti case, the incident report, the completed crime scene log, the CAD has been released. There was a request for a Commission DVD and that was made and provided to the family. A request for the medical examiner's report was requested and the wife of Mr. Lefiti was referred to the Medical Examiner's Office and they are having direct conversation. The Lefiti family also requested for Department general orders and those were provided to them.

Commissioner Campos thanked the Chief and the Department for the services for Officer Birco. Commissioner Campos also asked if additional resources and/or services can be provided to members at the Bayview Station. Chief Fong stated that as early as the evening of the incident, the Crisis Incident Response Team were out at not only Bayview but other stations because a lot of officers responded to the incident. Since then, there has been a number of debriefings held at the station. The Chief also stated that the Department is providing support to the Birco Family through the Department's Chaplin and the Department's Behavioral Unit.

Commissioner Campos also stated that he is surprised that the press pass issue has not been resolved and asked the Chief for some kind of resolution.

Commissioner DeJesus also talked about the press pass issue and the Sullivan matter.

Commissioner Marshall also asked about the press pass issue. Commissioner Marshall also talked about an incident in the Western Addition. Chief Fong stated that there was an incident and officers responded to the scene and paramedics were summoned to the scene as well and there were those who made it difficult for the officers, the fire fighters, and the paramedics to do what they have to do.

PUBLIC COMMENT

Unidentified stated that there is huge mistrust between the community and the Department and stated that community outreach should be ongoing.

Ace Washington discussed concerns regarding distrust of the community and discussed concerns regarding statements made by Captain Dillon.

As a Sullivan's brother discussed concerns regarding mistrust by the community.
