Chief Fong announced that the budget will be presented to the Board in the next two weeks and Deputy Chief Parra will give an update on the Department's recruitment drive. Chief Fong introduced Captain Keohane to present the update on the proposed revisions to DGO 3.19, "Early Intervention System."

Captain Keohane presented the update on the proposed revisions to Department General Order 3.19, "Early Intervention System." The command staff has reviewed the draft of the order and have made specific recommendations. The POA also addressed some concerns. To move forward, the POA have established a committee and the Department has also established a committee to meet with the POA. Captain Keohane explained that the purpose of the order is to identify the extremely small number of officers that cause a great majority of problems within an organization.

Commissioner Sparks asked about the early intervention report and stated that she has not seen the report and why is the DGO not being followed. Director Allen stated that morning reports are sent to the Captains weekly and he stated that the quarterly report for the beginning of the year is completed and will submit that along with the morning reports.

Commissioner Veronese asked about the committees. Captain Keohane stated that there will be a committee from the POA make up of officers of different ranks and the management committee by the police department. The committees will discuss the purpose of the early intervention system and develop specific indicators for the implementation of the order. The OCC will be involved because they have many of the records that is needed to build upon.

Deputy Chief Parra reported on the Department's recruitment drive. He stated that over 1900 applications have been received and the Examination Unit is presently processing those applications. The written exam is scheduled for July 12, 2005.

Commissioner Sparks congratulated Chief Parra for a very successful drive.

Commissioner Orr-Smith asked about recruitment in the Bayview, Hayes Valley etc. Chief Parra stated that he has a list of over 90 events and will forward the list to the Commissioner.

Commissioner Veronese asked for the demographics on this list. Deputy Chief Parra stated he will get it to the Commission as soon as possible.

Commissioner Chan was excused at this time.
