Chief Fong introduced Deputy Chief Parra to present the First Quarter 2006 OID Report and Deputy Chief Pengel to present the City Controller's Report on Police Staffing Needs at San Francisco International Airport.

Deputy Chief Parra presented the First Quarter 2006 Officer-Involved Discharges Report.

Commissioner Sparks asked for a brief report on where the Department is at relative to officer-involved shooting investigations as compared to the schedule that Captain Keohane has given periodically. Captain Keohane stated that he has just presented the material to update the list to the commanding officer of MCD and the Commission will receive it shortly. Captain Keohane stated that in August of 2004, there were 26 cases where the Department was behind. Out of those 26, Captain Keohane believes that the Department have completely closed those books. The only OIS case that are open to date are those where the Department has not received the material from either the Coroner or the District Attorney in order to close the case. Captain Keohane stated there are three OIS where the commanding officer of the Homicide Detail has come and reported to the Commission that the cases are still open. The MCD investigators have completed those three investigations except for the materials needed from the Homicide Detail to close those cases. Captain Keohane stated those investigations will be closed within two weeks.

Deputy Chief Pengel presented Controller's Office Report on Police Staffing Needs at San Francisco International Airport. Chief Pengel stated that there are seven findings and 15 recommendations.

Commissioner Sparks asked how does SFPD determine the priorities of where officers are needed relative to being a world class airport as opposed to possibly putting more officers on homicide prevention and who makes those decisions and how are those decisions made. Chief Pengel stated that it is a matter of joint discussion and ultimately will be the decision of the Chief.
