Chief Gascón reported on recent crime statistics: 9 percent reduction in part 1 crimes year to date. For the last 4-week reporting period: 7 percent increase in violent crimes, 521 versus 558 for this reporting period; 16 percent reduction in property crimes, 2721 versus 2295; total part 1 crime, 12 percent reduction for the four-week reporting period.

The Chief also reported that he will be attending the bi-annual Major City Chief's Conference, the PERF Semi-annual Meeting as a member of the Board, and the International Association of Chiefs of Police Meeting. He will be travelling on Friday and back on Wednesday next week.

The Chief also talked about the Kennedy School of Executive Sessions and stated that the paper he worked on will be presented in January at Harvard University and will forward the information to the Commission.

Commissioner DeJesus attended the first half of the Community Police Advisory Board meeting and stated how she was impressed by how it was put together.

Commissioner Kingsley attended the second half of the meeting and stated how impressed she was in how the groups came together and recommended doing outreach to the different groups to get feedback to the Commission.

Chief Gascón presented the Purple Heart Award Certificate to the family of Officer Charles W. King who died in the line of duty on June 7, 1931, great grandfather of Sergeant Jack Hart.
