PUBLIC COMMENT

Mr. John Crew, ACLU, addressed the Commission to correct some information that was given the Commission last week in regards to SFPD's participation in the Joint Terrorism Task Force. Mr. Crew stated that the statement by the Chief in regards to the Portland Resolution is incorrect. He went on to provide a copy of the resolution and a copy of a press release dated 4/28/11. Chief Suhr stated that his information came from Portland and will get clarification.

Ace Washington discussed profiling within the community and officers taking DNA swabs on the street and went on to discuss concerns regarding false arrests.

Shadam Mitchell discussed concerns about being falsely arrested and concerns about his rights not being read to him and about being in custody for five days without being informed of charges against him.

Mr. Harrison discussed concerns about the homicide investigation of his brother Charles Harrison.

Debray Carpenter discussed being arrested after being on TV criticizing the police and being held in custody for four days and stated that he is continually harassed by police officers in the Bayview.

Ms. Dubal, Asian Law Caucus, talked about the joint terrorism task force and how the community is pushing for a next step and that they will be discussion this issue with the Board of Supervisors.

Emile Lawrence discussed the OCC's 2nd Quarter report and stated that the report is not clear about officer's behavior.

Clyde discussed concerns about recent incidents involving the police.
