PUBLIC COMMENT

Jesse Brown, Mission resident, discussed concerns regarding rise in violence in the Mission and asked that there be zero tolerance on guns.

Sally, Latino Steering Committee, discussed concerns regarding gang injunctions, SROs being off on Fridays, and stated that police officers need to be respectful.

Joseph Logana discussed concerns regarding actions by police and asked that cameras be installed in patrol cars.

Connie Webber, Mission resident, commended the officers of the Mission and stated that the gang injunctions should continue and asked for more public safety cameras.

Steve Adams, President of Merchants of Upper Market and the Castro, commended the officers of the Mission and commended the Robbery Apprehension Unit.

James Salinas discussed concerns regarding staffing in the Mission.

Commissioner Sparks commended Captain Tacchini for a comprehensive report.

CAPTAIN STEPHEN TACCHINI, COMMANDING OFFICER OF MISSION STATION, TO ADDRESS THE COMMISSION ON POLICE ACTIVITIES IN THE MISSION DISTRICT

Captain Tacchini addressed the Commission and the community on police activities in the Mission District.

Deputy Chief Cashman addressed the issue of specialized help to assist the officers of Mission Station. Chief Cashman referred to the study done by Dr. Anthony Moraga which stated that two percent of San Francisco's geography is dangerous and that 45 to 50 percent of the violent crime is in two percent of the geography. Chief Cashman stated that they came up with a zone strategy in which five zones have been identified: Tenderloin, Western Addition, Mission District, Bayview Hunter's Point, and Visitation Valley. High number of specialized unit officers will be deployed to the different zones.

Deputy Chief Cashman also addressed the issue of increase in sexual assaults. Chief Cashman stated that there has been an increase in sexual assaults as there is an increase in activities in nightclubs. Chief Cashman stated that to combat that the Department has come up with the nightclub violence reduction strategy where there are officers at nightclubs at closing hours to insure that everybody gets out safely.

Commissioner Campos asked about the proper level of staffing for the Captain to do what needs to be done. Chief Cashman explained that the Department augments district staffing with specialized unit staffing support. Commissioner Campos asked that the issue of staffing be looked at to determine if additional officers are needed to be assigned to the Mission given the increase in violence in the district.

Commissioner Mazzucco asked about gang-related crimes and asked how many certified gangs are in the Mission District. Captain Tacchini called Sgt. McDonald to address the question about gangs. Sgt. McDonald stated that there are 12 for the Nortenios and 4 for the Sorenios.

Commissioner Sparks asked the Captain to expand his outreach for his newsletter. She also asked that maybe the subcommittee on violent crime can meet in the Mission for their next meeting.

Commissioner Mazzucco would like a follow up report on percentage of crimes that are gang-related in the Mission.

PUBLIC COMMENT

Luna Gills Wile, SF Safe, stated that there are 50 neighborhood group watch in the neighborhood and provided information regarding the SF Safe Program.

Eric Arguello discussed concerns regarding gang problems in the Mission.

Rita Alviar discussed concerns regarding gangs and thanked Supervisor Ammiano and the officers of Mission for their work and asked that the next meeting be held somewhere where there is parking so that more parents can attend

Fred Sharpis, Treat 1000, discussed concerns regarding homicides on his block and asked for more staffing for the Mission District and asked for outreach from the Department after an incident happens.

Unidentified discussed concerns regarding racial profiling and discussed concerns regarding officers targeting him.

Peggy Mango discussed concerns regarding staffing and homicides in the Mission and asked for bigger changes in the Mission.

Edward, restaurant owner, asked the Department to tell the community what the community can do to help with the violence.

Jim Salinas thanked Commissioners Campos and DeJesus and Chief Fong for their work with the community and discussed concerns that no one from the Department has talked to the two women who have witnessed an incident.

Supervisor Ammiano addressed the Commission and asked when the Commission will meet regarding the sanctuary city ordinance.
