2006 HOMICIDE AND CRIME TRENDS OVERVIEW

Deputy Chief Tabak presented the 2006 homicide and crime trends overview.

Lieutenant John Loftus talked about the responsibilities of the Robbery Detail.

Lieutenant Leroy Lindo talked about the responsibilities of the General Work Detail.

Lieutenant Tom Buckley talked about the responsibilities of the Burglary/Fencing Unit.

Lieutenant Mike Biel talked about the responsibilities of the Auto Detail Unit.

Commissioner Veronese asked about felony arrests and why the number is down. Chief Tabak explained that it is due to staffing. Commissioner Veronese asked if the Department is looking at any other tools in going after specific targets. Chief Tabak stated that what the Department looks at is narcotics because it usually is the cause of the violence.

Commissioner Campos stated that the issue of the criminal justice system failing the City and County of San Francisco is a very complicated issue and one that can be discussed for days. Commissioner Campos stated that as a member of the SF Commission, he would like to focus on the Department and not go beyond the jurisdiction of the Commission. He asked about the reduction of the homicide rates and asked about the strategies. Chief Tabak explained that the key to the strategy is to focus on those individuals who have a high proportionality in committing crimes. He stated that narcotics is the red flag because where you have narcotics, you have guns, and when you have guns, you have homicides. Chief Tabak explained strategies used by the Department.

Commissioner Campos asked for the numbers of arrests and how it compare to other jurisdictions in terms of homicides.

Commissioner Campos asked if foot patrols will make a difference. Chief Tabak stated that any kind of patrol presence is a deterrence to crime. Chief Tabak also stated that the District Attorney's Office and the Department has an excellent relationship. Commissioner Lee asked about statistics nationally and working with CBOs. Chief Tabak stated that yes the Department does keep track of the stats and a presentation on domestic violence will be presented to the Commission in a few weeks. Commissioner Lee asked about crimes against youth. Chief Tabak stated that crimes in schools is reported by the school but outside of that environment, it is from the parents or the neighbors.

Commissioner DeJesus asked about data on recidivist crimes and stats on out-of-town arrests and how many are African-Americans. Chief Tabak stated that the Department response to behavior but he will try to come up with some data in regards to that.

Commissioner DeJesus stated that in the previous presentation, Chief Tabak had talked about the parents and the community's faults and with this presentation, the topic is the criminal justice system. Chief Tabak explained that everyone can do better and that everyone has room for improvement.

Commissioner Marshall asked about out-of-town arrests. Chief Tabak stated that the Department works with the San Mateo County and the Santa Clara County in dealing with gang issues, 290 registration and sexual registrant issue. Commissioner Marshall thanked the Chief for his presentation.

Commissioner Sparks asked about un-preventable homicides. Chief Tabak stated that there is almost an equal amount of those types of homicides in 2004, 2005, and 2006. Commissioner Sparks asked for some context to the homicide statistics as to how many shootings and how many violent crimes so that the Commission can get a clear picture.

Commissioner Sparks asked what kind of communications does the Department has with the courts and the judges. Chief Tabak stated that there's an ongoing relationship with the courts and the District Attorney. Commissioner Sparks asked how the judges would react to the statistics and what their involvement is in the process and in fixing the problem. Chief Tabak stated that the first step would be to get the courts and the public defender involved and get the felony cases moving forward. Chief Tabak also explained that meetings with city agencies regarding what the city can do to prevent violence is on going.

Commissioner Campos stated that he thinks it is important that the Department provides information and overview like this one to the public so that the people know that arrests are being made and that they are being made based on conduct and not based on racial characteristics.

Commissioner Marshall commended Deputy Chief Tabak for his presentation.

Chief Fong also announced that the sergeant's list has been posted and that the Department is kicking off its lateral hiring program and talked about the city employees' hiring program.
