# STATUS REPORT ON PREPARATION OF THE FY 07-08 DEPARTMENT BUDGET

Deputy Chief Keohane introduced Mr. Ken Bukowski, CFO Fiscal Division.

Mr. Bukowski presented the status report regarding the Department Budget for fiscal year 2007/2008 and also gave the Commission a timeline for development of the 2007/2008 Department budget.

Commissioner Sparks asked for a report as to where the Department is at relative to the budget. Mr. Bukowski stated that they are in the process now in preparing the information for the six-month report and will be meeting with the Controller's office on the 16<sup>th</sup>. He stated that after that spreadsheet is created he will include it in the next budget presentation.

Commissioner Sparks also talked about the supplemental which was reserved by the Board and asked that in the next variance analysis, if the status of that supplemental can be included.

Commissioner Campos asked about the POA negotiations. Ms. Villagomez stated that planning process have began consistent with the Charter requirements. She stated that she will be participating in the negotiations and along with the review of issues through the Mayor's Office, through the Employee Relations Division and in conjunction with the policy directives that are reviewed with the Chief, Ms. Villagomez stated that she'd be happy to come back and review what those issues are as they proceed with the process.

Commissioner Campos also asked about the Commission budget. Mr. Bukowski asked that if there are certain funding levels or positions that were desired for the 06/07 budget that weren't fully funded, please forward the information to him to be included in the initial budget presentation or revisit that as part of the discussion when the whole budget is considered on January 24<sup>th</sup>. Commissioner Campos asked that this item be included in the process. Commissioner Campos talked about resources for cultural sensitivity training, language access, and resources to implement the foot patrol ordinance.

Commissioner Sparks talked about transferring the Taxi Detail to the Taxi Commission. Commissioners Sparks also talked about the Blue Ribbon Panel budget and asked if the cost for that study will be included in the budget. Commissioner Sparks also would like a discreet budget for the Commission with all the various items in it. Commissioner Sparks also talked about budget for a hearing officer. Commissioner Sparks also talked about video coverage of the end of the month meetings.
