Assistant Chief Lynch, for Chief Fong, highlighted significant policing efforts by Department members in the last week.

Captain Denis O'Leary, Ingleside Station, presented the response to the report by the subcommittee on Violent Crimes.

Commissioner Marshall would like the Department's response available to the Visitacion Valley community. Captain O'Leary stated that he attends meeting at Visitacion Valley and makes it a point to have information available to the community. He also stated that he has spoken to some of the individuals who had expressed concerns from that particular meeting.

Commissioner Sparks suggested that Captain O'Leary put out a special newsletter with just the Department's response in regards to the subcommittee's meeting on Violent Crime which took place in the Visitacion Valley on November 1, 2007. Captain O'Leary stated that it will be on the web tomorrow and he will also bring a copy of the letter to the community meeting.

Commissioner Sparks also suggested that the POA post the same letter on their website so as to let the members know what is happening between the Department and the community.

Commander John Murphy presented the report on implementation of recommendations of the Foot Patrol Study.

Commissioner Sparks stated that the legislation by Supervisor Mirkirimi has certain criteria and she asked if the Department is staying within the spirit of the legislation. Commander Murphy stated that the community wants beat officers and the Department is trying to improve on what is mandated.

Commander Campos asked what is the timing as far as the implementation plan. Commander Murphy stated that he's hoping it will be done by the end of June.

Commissioner Mazzucco stated that while the Department is working with the implementation of the plan, there has been a substantial increase in beat officers and that there has been an 86 percent increase.

Commissioner Sparks asked that an update on this matter be given on the last meeting of the Commission in June.

Sergeant Joe McFadden presented the update on the status of open OIS investigations.

Commissioner Sparks stated that there should be a line in defining old cases to the more current cases. Sergeant McFadden stated that cases after 2006 comes under DGO 8.11.

Assistant Chief Lynch stated that there was an article in the newspaper in regards to the Early Intervention System. He stated the Department would like to present an update to the Commission.

Commissioner Campos would like a presentation in regards to Safety in Muni.

DISCUSSION AND POSSIBLE ACTION TO ADOPT A RESOLUTION THAT ESTABLISHES PROCEDURES FOR INVESTIGATING ALLEGATIONS OF POLICE MISCONDUCT CONTAINED IN CIVIL SUITS AND CLAIMS

Commissioner Sparks explained that the Commission will not be adopting a resolution but will adopt policies and procedures for investigating civil claims.

Director Jerry Tidwell, Risk Management, talked about procedures for investigating allegations of police misconduct contained in civil suits and claims.

Commissioner DeJesus expressed concerns regarding the procedure and that it doesn't address the concerns of the Commission that when a serious allegation is made, the Department should take a look as to what happened.

Commissioner Sparks gave a brief background as to how this item came about.

Director Tidwell stated that additional language will be added to the procedure, which states: "If the claimant not wish to file a complaint, the Department shall undertake or conduct a preliminary assessment into the incident." Commissioner Sparks asks that the language which states, "It is the policy of the Police Commission to direct the Chief of Police that" be added to the beginning of that statement.

Mr. John Tennant, POA Attorney, discussed concerns and stated that all the preempt is not needed when Section 96.7 of the Administrative Code that requires the City Attorney to send the OCC's brochure and information to the civil claimant.
