DISCUSSION AND POSSIBLE ACTION TO ADOPT A RESOLUTION IN SUPPORT OF THE BOARD OF SUPERVISORS' RESOLUTION URGING THE ATTORNEY GENERAL TO CLARIFY HOW PENAL CODE 3003 AND THE TRANSIENT PROVISION IN PENAL CODE 290 APPLY TO JESSICA'S LAW (PROPOSITION 83)

Lieutenant Dan Leydon, Sexual Assault Detail, gave a brief presentation regarding the Department's practice on 290 registration.

Commissioner Veronese explained the reason for his resolution.

Commissioner Campos discussed concerns about penalizing the status of people without necessarily looking at actions and stated that he will be voting against this resolution because he stated that there are better ways, as a Commission, can promote the safety of children.

Commissioner Mazzucco explained that if somebody is convicted of sexual assault, this is the only crime, where they can go to prison and once their time is expired to go to prison, they can be re-incarcerated if the professionals feel that these individuals are no longer able to be out into society because there is a strong recognition that sexual offenders do re-offend and they are a threat to the society. Commissioner Mazzucco also stated that even the Federal Court has recognized the need to strongly supervise sexual offenders or 290 registrants and stated that the 9th Circuit Court of Appeals ruled, based upon the evidence they had before them, that a registered sex offender from the Federal System can be placed on a lifetime of supervision. Commissioner Mazzucco stated that the Commission should urge the California Department of Corrections not to give the advise to tell these people being released from State Prison that they should register as transients because they can't give people loophole to avoid what's already in the court system.

Commissioner Lee stated that she does not see the need for this resolution but she does see the need for the Police Department to work with other folks because, just by a resolution from San Francisco, she does not see how a State Department is going to completely turn its policy.

Lieutenant Leydon stated that of the two options, the Department would prefer to have somebody in a residence because it is easier and better for the Department to monitor them for them compliance than telling them to be homeless.

Commissioner DeJesus stated that there is some confusion as to who is going to put the restrictions. Chief Fong stated that the GPS are for high risks offenders. Commissioner DeJesus clarified that what the Commission is doing is telling the Parole Division to take away the loophole, comply with the law and make them register.

Commissioner Sparks asked if everyone who is in violation of Jessica's Law arrested because they are living within confines or is that part of the law ignored so that the Department knows where they are living. Lieutenant Leydon stated that arrest will be made if somebody is not in compliance with Jessica's Law and the Department is working with parole and figure out what options are going to be and what course they are going to take.

Inspector Poelstra, Sex Offenders Unit, explained that the problem with Jessica's Law is there is no punishment for it. When the law was adopted, there is no section for the police to arrest somebody for violating Jessica's Law. When the law was written, there is no penalty. What they did is parole has made a condition of parole for everybody who is paroled after November 8, 2006, that if they come out of parole, Jessica's Law would apply and parolees are served with a notification saying that this is a condition of your parole.

Commissioner Sparks asked, absent the resolution, what would be the intent of the Department relative to (a) people who were living within the jurisdiction that have registered and in violation of Jessica's law or (b) people who registered as transients, what would be the Department's intent as far as tracking these people and enforcing or not enforcing Jessica's Law. Lieutenant Leydon stated that the Department would fall back to the 290 of the Penal Code which is compliance checks. Inspector Poelstra stated that there are about 130 people that are registered transients prior to this and it's always been

available to sex registrants to register as transients and if they are registered transients, they have to come in every 30 days. Unfortunately, the transient registrants are generally the ones that are in and out of custody for numerous petty theft crimes, et cetera, so they do come in and out of compliance regularly.

Commissioner Veronese explained that there is a lot of rewording in the resolution that is just a restatement of the law. He explained that the Commission is not saying to the Department to go arrest people because they are in violation of Jessica's Law. The Commission is letting the Courts deal with Jessica's Law. He stated that what the Commission is saying, because of the new CDC policy, people are registering as transients that are not transients and the Department wants to know where they are living. He explained that if that is not enforced, the city will become a sanctuary in the State of California for 290 registrants wanting to hide from their registration.

Commissioner Campos stated that the place to address this issue should be Sacramento who can look at this issue and find a way that looks at the issue, not only for San Francisco, but for the entire State. Commissioner Campos also stated that he would like to hear from the California Department of Corrections and would like to know if there are policy considerations that they took into account in making their decision. Commissioner Campos stated that he would rather wait and get more information before taking any action.

Commissioner Lee moved that this item be tabled until more information is available. Commissioner Lee moved that it be tabled and revisited in two weeks. Second by Commissioner DeJesus.

Commissioner DeJesus stated that she needs for information to make an informed decision.

Commissioner Marshall supports that it be tabled.

PUBLIC COMMENT

Meesha Irizarry discussed concerns of not having rehabilitation for these individuals.

Inspector Lee, Sex Crimes, stated that the current laws on the books are good enough and that the officers on the streets will locate and apprehend these people.

Unidentified discussed concerns.

Commissioner Sparks stated that she would like this item back on the agenda for December 5th and to have a representative from the CDC present, and get a written clarification from the Department as to what their intent would be as far as going forward and as far as enforcement of Jessica's Law as written.

Motion by Commissioner Lee to table this item until December 5th. Second by Commissioner Veronese.

Alex Rosenthal, Citizens for Halloween, stated that her organization would like to have a safe and fun event and discussed concerns in closing Muni and Bart stations. She also discussed concerns regarding threats made to Bart about closing.

Mark Dryer commended the Commission and the Department for taking care of the Castro community on Halloween night.

Hank Wilson stated that he had made a request about Halloween data from 2000 to 2006 and stated that he made a formal Sunshine request to have data by December. He also talked about liability coverage.

Gary Virginia, Castro resident, thanked the Commission and the Department for having a public hearing. He stated that he has 11 questions to submit to the Commission and the Department. He also discussed concerns regarding threats by the Fire Department and Police Department to businesses in staying open on Halloween night.

Bill Wilson, Harvey Milk Academy, discussed concerns regarding teachers parking on the Castro and concerns about having their cars towed and perhaps there is a way to identify those who have to legitimately stay until 3 p.m. He also commended Sergeant Chuck Lambert for his actions.

Matthew Grandley discussed concerns regarding intimidation by police going into businesses about closing for Halloween.

Commissioner Campos thanked Patrol Specials officers for their help on Halloween night.

Deputy Chief Shinn stated the Muni stations were closed one hour earlier which was a joint decision by the stakeholders. Chief Shinn also addressed concerns about threats to Bart and stated that there was absolutely no treats made to Bart. Chief Shinn also stated that the Department will work earlier for next year's planning and will have the community involved. Chief Shinn also stated that no threats were made to businesses. Chief Shinn thanked the officers that were out there and thanked Captain Goldberg and his crew for all the work they've done.

Commissioner Sparks thanked Captain Goldberg and the Department for doing an excellent job and commended the coordination between the different city agencies. Commissioner Sparks also thanked Supervisor Dufty and the Mayor's Office for coming to the Commissioner hearing and doing a presentation. Commissioner Sparks stated that it is her hope to have Halloween next year since it falls on a Friday. Commissioner Sparks also thanked Mr. David Parry for his work and commended the community for getting involved.

Commissioner Sparks also requested an investigation on allegations of threats to businesses about closing Halloween night and asked Chief Fong to follow up on that.
