Chief Fong highlighted some of the good work of the men and women of SFPD.

Chief Fong also reported on the Violent Crime Summit she attended in Chicago. Commissioner Marshall stated that he found the topic of shot spotters and safety cameras very interesting.

Chief Fong also talked about the resignation of the Director of the Housing Authority. Chief Fong stated that the Mayor has asked her to be part of the team in terms of public safety.

Chief Fong talked about Halloween and stated that she would like to have Deputy Chief Shinn give a brief update. Commissioner Sparks stated that the Commission will have a separate agenda item for next week's meeting.

Chief Fong also addressed concerns regarding notes by the subcommittee and Chief Fong stated that the Department is preparing a document that addresses some of the concerns. Chief Fong recommended that maybe, for the next meeting, after the meeting, the Commission, the Chief, and the Captain of the district could sit down and go over some of the concerns of the community and then come up with a response.

Commissioner DeJesus stated that both Commissioner Marshall and herself had called Captain Pardini and stated that during the subcommittee meeting, they took notes of exactly what the community has said about the Department and that they had talked to Captain Pardini and the Captain has stated that there were some misinformation. Commissioner DeJesus stated that the focus is what the community thinks about their officers. Commissioner DeJesus stated that it was the first subcommittee meeting and that maybe next time they will meet with the District Captain to let him/her know the concerns of the community. Commissioner DeJesus stated that the memo reflects the community's concerns and not what this Commission thinks about the Department or does the Commission endorses those things.

Commissioner Marshall explained that this was a meeting of the subcommittee on violent crime and that was what people had to say.

Chief Fong stated that Department will prepare a response and follow up with Commissioners Marshall and DeJesus.

Deputy Chief Keohane presented the 3<sup>rd</sup> Quarter 2007 Firearm Discharge Review Board Report.

Sergeant Joseph McFadden presented the Officer-Involved Shooting Investigation Status Summary.

Lieutenant Murphy, Homicide Detail, gave a brief update on OIS 07-01

and 07-02.

Commissioner DeJesus asked about SRO Training. Chief Fong stated that two names of individuals were forwarded to Captain Corriea for him to coordinate how it could best be brought into the Academy curriculum.

Commissioner Sparks stated that it will be calendared for the first meeting in November. Commissioner Sparks also asked about the new policy for homeless. Chief Fong stated that program has not started but currently, the Department has outreach officers as well as foot patrol officers in areas where there may be a number of homeless community. They are provided resource sheets. It is also the policy to call either the Health Department or Human Services agency to send out outreach workers to assist people because in many cases someone who is homeless isn't necessarily violating the law.

Commissioner Sparks asked if this new program primarily targeted for homeless people that are in plain view of the tourist and the convention people or is it actually a broader program to actually help the homeless that are out on the streets. Chief Fong stated that this is an area that was highlighted within the meeting. However, Chief Fong stated, that it doesn't mean that the Department will stop all the other services and the outreach in the other areas.

Commissioner Sparks asked if this is a long-term plan or short-term plan. Deputy Chief Shinn explained that as the hot teams, the Department of Public Health and the Department of Human Services Agency, are able to get people into services, that is the goal. Chief Shinn stated that as people move, the teams literally move with them.

Commissioner Sparks asked about the homicide rate. Chief Fong stated that the number, year-to-date, is above the full year of last year. She stated that the Department is seeing a lot of different trends in homicides where it is spontaneous; it's people who don't know one another; or it is the drug-related incidents; or family violence. Chief Fong stated the Department will continue to do a number of things that it believes will help prevent those homicides.

#### OCC DIRECTOR'S REPORT

#### a. Review of Recent Activities

Ms. Jean Field, Interim OCC Director, talked about the recent NACOLE conference. Ms. Field also talked about the scheduled office move of the OCC. The move is scheduled for October 15<sup>th</sup>.

Commissioner Marshall asked Ms. Field to recommend someone from the conference to talk to the Commission about police oversight and ideas.

Commissioner DeJesus stated that she did meet with Captain Pardini and that notes will be typed up and a presentation will be made regarding comments that the Captain has and information provided. Commissioner DeJesus also discussed the article by Gary Delagnes in the POA Newspaper.

Commissioner Marshall stated that he would like an explanation from Mr. Delagnes and that he would be happy to meet with Mr. Delagnes personally and that he would be happy to talk to the entire POA.

Commissioner Mazzucco suggested that this be used as an opportunity to open the lines of communication between the Commission and the POA to discussed these issues and that he would love to meet with the POA and its membership.

Commissioner Sparks stated that she would like to continue to keep the dialogue open and stated that she has met with the Chief of a regular basis and have tried to meet with Ms. Field on a regular basis and she's met with the Director of the ACLU on a regular basis and that she has made the same offer to Mr. Delagnes and so far they have had one meeting. Commissioner Sparks stated that she is hoping that Mr. Delagnes will take this opportunity to take up her invitation once again to meet with him on a regular basis so that issues can be resolved in a manner that is productive rather than a manner that is potentially harmful to the relationship between the Commission and the POA and also the community.

Commissioner Sparks stated that her concern is that the Commission is somewhat at a disadvantage because the POA Journal is only a one way communication and the Commission doesn't have a similar venue from which they can communicate to the officers as well, either on a proactive basis or in this case a reactive basis. Commissioner Sparks, therefore, asked the Chief to do within 30 days is to install bulletin boards at every district stations and every bureau so that the Commission can publish letters and announcements directly to the rank and file so they can hear words directly from the Commission as opposed to as being either filtered through the POA Journal or conversations with any one individual.

Commissioner Sparks stated that she would ask Mr. Delagnes, if possible, whether or not the POA could actually arrange a Commission meeting at a time and place where it can be noticed as an official Commission meeting with the only agenda item asking officers to address the Commission directly so that their concerns can be heard directly.
