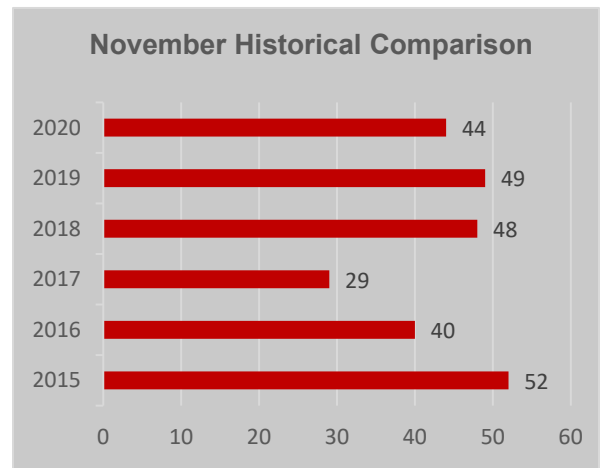

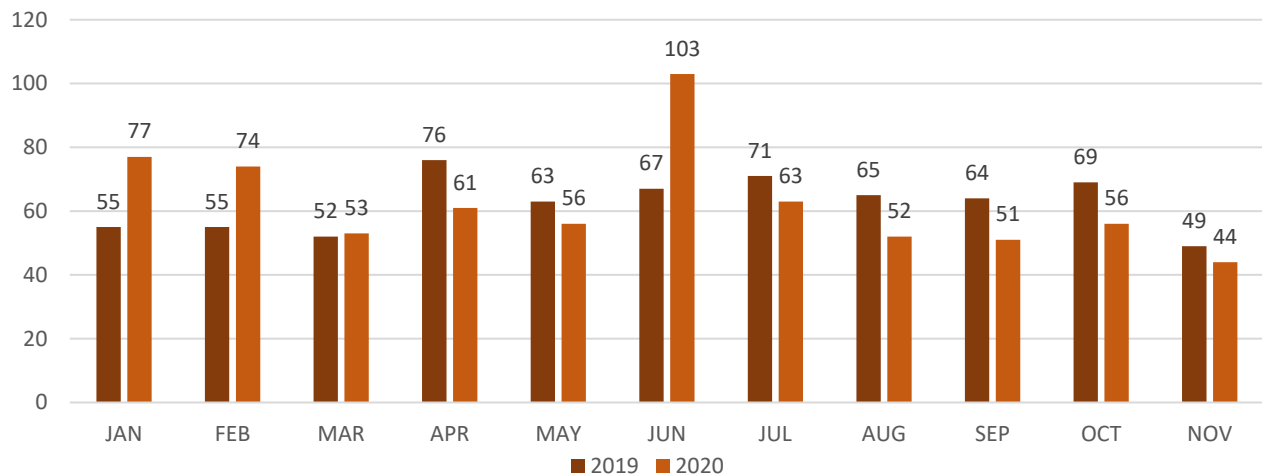
Summary of Complaints Received in November 2020

The Department of Police Accountability received **44** cases in **November 2020**, compared with **49** cases in the same period last year. The **November 2020** case total is **2%** higher than the five-year average and **10%** decrease than the previous year.

From January through **November**, the DPA received a total of **729** new cases, compared with the **713** cases filed during the same period in 2019. The **November** year to date case total represents a **2%** increase in new complaints over last year.

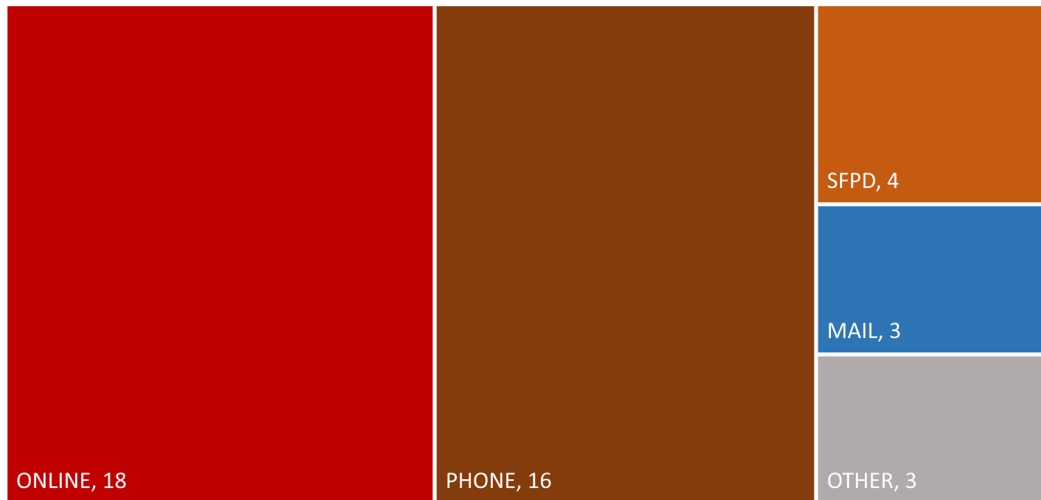


Year to Date Monthly Comparison of Cases Received
