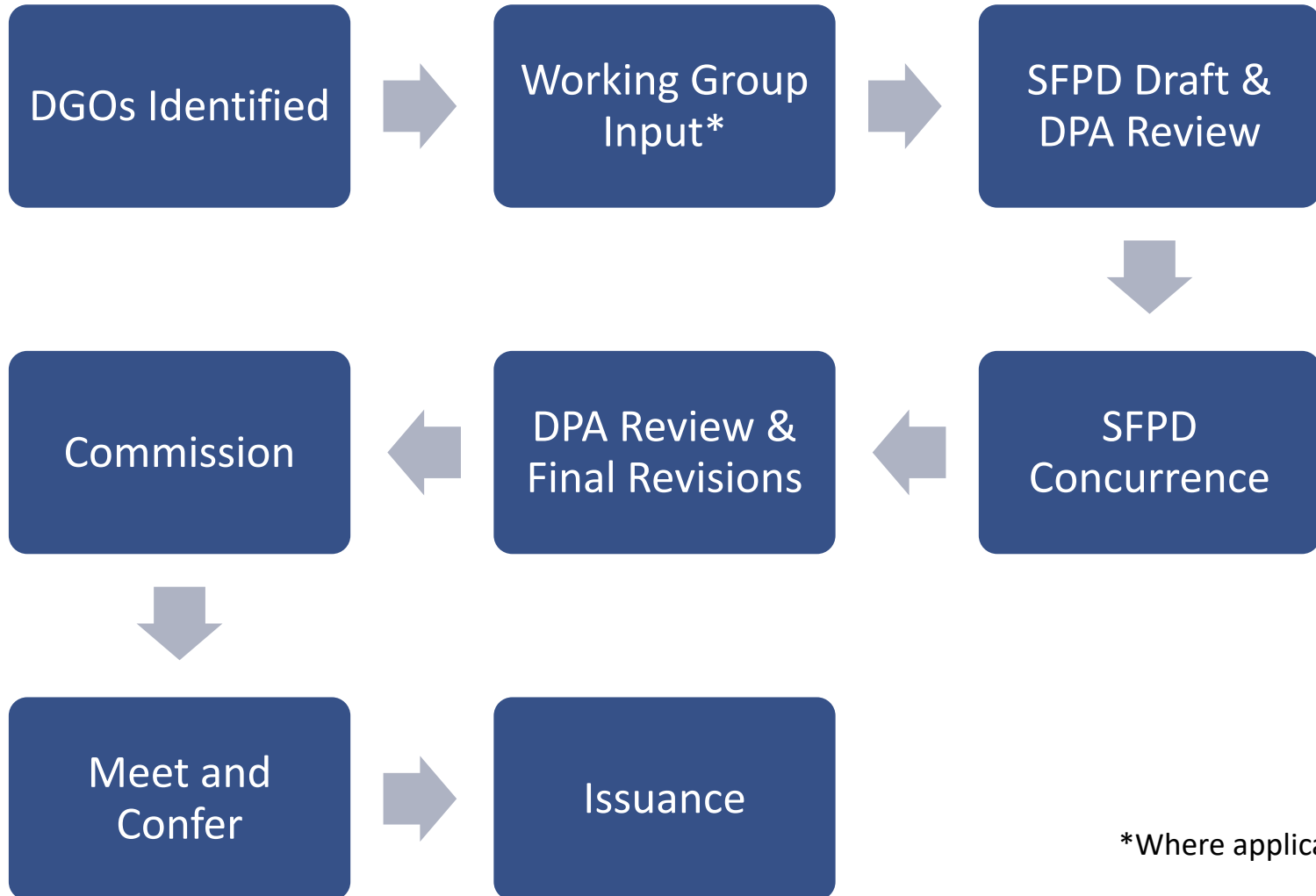

The subsequent refusal and lack of cooperation by the private person does not relieve a member from completing an incident report under DGO 5.04 II 8.	Incorporated, closed.
