
Re: San Francisco Department of Police Accountability June 2021 Monthly Statistical Report


Summary of Complaints Received in June 2021

The Department of Police Accountability received **58** cases in **June 2021**, compared with **103** cases in the same period last year. The **June 2021** case total is **11% lower** the five-year average and **44% lower** than the previous year.

From January through June, the DPA received a total of **397** new cases, compared with the **421** cases filed during the same period in 2020. The June year to date case total represents a **6% decrease** in new complaints over last year.




Year to Date Monthly Comparison of Cases Received

00046652-21	6/1/2021	Officers arrested the complainant on an outstanding warrant.
00046654-21	6/1/2021	The complaint raises matters not rationally within the Department of Police Accountability's jurisdiction.
00046655-21	6/1/2021	Officers did not cite a driver parked on a sidewalk.
00046687-21	6/2/2021	An officer refused to meet with him in person to investigate threats made by a neighbor and was biased against him based on his disability.
00046691-21	6/3/2021	Officers failed to respond promptly to a person in distress.
00046692-21	6/3/2021	Officers arrested the complainant without cause, failed to take required action, and made inappropriate comments.
00046695-21	6/3/2021	An officer made inappropriate comments.
00046696-21	6/3/2021	An officer failed to prepare a police report and harassed and improperly searched the complainant.
00046700-21	6/4/2021	An officer failed to take required action.
00046699-21	6/4/2021	The complainant has attempted to file a report or speak to officers at police stations, but has not received a response.
00046705-21	6/5/2021	Officers failed to arrest a person brought to an emergency room who had been driving under the influence.
00046708-21	6/7/2021	The complaint raises matters not within the Department of Police Accountability's jurisdiction.
00046709-21	6/7/2021	The Special Victims Unit has failed to properly investigate the complainant's case.
00046713-21	6/8/2021	A Muni fare inspector issued a citation without cause.
00046715-21	6/8/2021	Officers mistook the complainant's car as a vehicle involved in a crime. Officers pointed guns at the complainant and her family, used profanity, grabbed her, and entered her residence without a warrant.
00046716-21	6/8/2021	Officers arrived at the complainant's home and held him at gunpoint. The complainant was taken for a psychological evaluation because of a fraudulent 911 call.
00046745-21	6/9/2021	Officers arrested the complainant without cause, failed to take required action, and made inappropriate comments.
00046750-21	6/9/2021	The complaint raises matters not within the Department of Police Accountability's jurisdiction.
00046752-21	6/9/2021	Officers were rude, dismissive, and failed to take required action.
00046757-21	6/9/2021	Officers were rude and refused to provide their information or the nature of the contact. Officers detained the complainant and her sons at gun point, searched her, and did not comply with COVID health guidelines.
00046755-21	6/10/2021	The complainant was told that there were no available officers to attend to his call; the complainant waited over an hour for police response.
00046770-21	6/11/2021	An officer pointed a knife at the complainant and threatened to arrest him. The officer also removed the registration tag from the company vehicle the complainant was driving.
00046774-21	6/11/2021	Officers displayed unbecoming conduct, made inappropriate comments, and failed to provide their star numbers.
00046778-21	6/13/2021	An officer was hostile and had a menacing and transphobic attitude toward the complainant.
00046792-21	6/14/2021	Officers failed to respond to the complainant's call regarding a person laying and blocking his garage door.
00046799-21	6/14/2021	Officers shot the complainant's son in the leg with a beanbag gun.
00046801-21	6/14/2021	An officer told the complainant that no crime had occurred when his phone was stolen.
00046872-21	6/15/2021	The complaint raises matters not rationally within Department of Police Accountability's jurisdiction.
00046861-21	6/16/2021	Officers seized the complainant's vehicle and refuse to release it.

00046862-21	6/16/2021	Officers refused to listen to the complainant, told him to leave, and laughed and belittled him. The complainant then called 911 to report the incident, and the operator also exhibited rude behavior.
00046869-21	6/16/2021	An officer made inappropriate comments during a phone call, and another officer did not provide the complainant with a letter or follow through with the terms of a Mediation agreement.
00046939-21	6/16/2021	Crime evidence collection devices were moved without public input.
00046874-21	6/17/2021	Officers responded to a scene in which one party accused the other party of brandishing a knife. However, the officers did not arrest the accused individual possibly because of racial bias.
00046900-21	6/18/2021	An officer did not respond to the complainant's inquiry into the status of her daughter's case, the victim, or properly investigate the case.
00046905-21	6/18/2021	The complainant alleges that individuals are blocking the road by doing fireworks.
00046937-21	6/21/2021	The complaint raises matters not within Department of Police Accountability's jurisdiction.
00046941-21	6/22/2021	The complainant called the non-emergency number and requested a police escort to his girlfriend's house to retrieve his personal belongings. Two officers accompanied him, and upon reaching his girlfriend's house, the officers told
00046942-21	6/22/2021	An officer told the complainant's male African American friend who was sitting in a park to leave, and that he did not belong in the area.
00046974-21	6/23/2021	A dispatcher was unhelpful and continued to tell the complainant to call 911 instead.
00046975-21	6/23/2021	An officer drove a police car while using a cell phone.
00046977-21	6/24/2021	A complainant alleges they were a target of harassment and threats.
00046978-21	6/24/2021	A Public Service Aid would not take a report.
00046980-21	6/24/2021	An officer harassed the complainant.
00046982-21	6/24/2021	An officer seized property without a warrant, intimidated the complainant, and failed to comply with social distancing.
00047054-21	6/24/2021	Officers made fun of the complainant.
00046988-21	6/25/2021	The complainant raises matters outside the Department of Police Accountability's jurisdiction.
00047000-21	6/28/2021	Officers detained the complainant as a suspect after he was in a vehicle collision and used unnecessary force.
00047001-21	6/28/2021	Officers detained the complainant without cause.
00047002-21	6/28/2021	A dispatcher terminated the call before the complainant could finish providing details about an incident.
00047004-21	6/28/2021	An officer failed to properly investigate BART fare evasion.
00047005-21	6/28/2021	An officer failed to respond to an emergency call in a timely manner, and then failed to take required action.
00047009-21	6/28/2021	Officers failed to investigate and make an arrest.
00047010-21	6/28/2021	Officers were rude and one officer was racist.
00047013-21	6/29/2021	Officers failed to respond to the complainant's call for service.
00047014-21	6/29/2021	Officers left the scene without notifying the complainant.
00047048-21	6/30/2021	Officers failed to respond to the scene.
00047051-21	6/30/2021	Officers failed to take a report and investigate.
00047052-21	6/30/2021	An officer witnessed another officer abuse his authority on the road.
