## **Uniform Inspections and Associated Form (SFPD 587)**

The purpose of this bulletin is to update members on the department's uniform inspection policy and introduce a new form, *Uniform Inspection Form*, SFPD 587.

This form was created to standardize the inspection process with the goal of ensuring that uniformed employees are readily identifiable to the public through the proper use and wear of department uniforms. Uniforms are to be worn in compliance with the specifications set forth in DGO 10.01, *Uniform and Equipment Classes*.

Supervisors shall perform periodic (at least once a month) inspections of their personnel to ensure the proper "Uniform of the Day" is worn and conforms to DGO 10.01. Uniforms and equipment shall be maintained in a serviceable condition and shall be ready at all times for immediate use. Uniforms shall be neat, clean and professionally pressed. All inspections will be documented on the attached Uniform Inspection Form (UIF) and retained at the respective station for two years, in accordance with the department's record destruction schedule.

Employees shall familiarize themselves with specific uniform guidelines detailed in DGO 10.01 to ensure that the proper "Uniform of the Day" and other department authorized uniform and equipment is present and functioning.

Members of the Staff Inspection Unit (SIU) will utilize the UIF to conduct random uniform inspections at District Stations as directed by the Chief of Police or designee. Members of the SIU shall review UIF's retained at District Stations at the time of these inspections.
