Coro's Exploring Leadership Youth Fellows Participants



The Coro Foundation was founded in 1942 by W. Donald Fletcher and Van Duyn Dodge, who were working on a political campaign in San Francisco and had deep discussions about effecting change through the cultivation of new generations of leaders. Over the coming decades, Coro Northern California have developed youth, women, emerging leaders, and neighborhood leadership academies. This summer, the Exploring Leadership Youth Program is training 24 bright and motivated Bay Area High School students to be active citizens and leaders in our community. Their focus is on studying the logic of a community, specifically what makes San Francisco's Excelsior District "tick." Jasmine, Lavender, Yunseo, Shreya, and Owen all visited with Capt. Hart, Ofc. Phillips, Ofc. Hauscarriague, and Ofc. Brandt for a 90-minute discussion on youth, police, and community relations in the Excelsior District, Ingleside Station, the SFPD, and across the profession nationwide. One student said, "I had a negative connotation with the police and even feared them, ...(this) put me in a different perspective—one of the realest interviews I had ever."

We are grateful for Coro's work, especially Clifford Yee the Director of Diversity and Inclusion Training who made this wonderful connection between participants and Ingleside Station. Congratulations to all the participants for working hard this summer to further their growth and development into future leaders.

Operation Kaboom

Why: To efficiently and effectively knockout those locations where illegal fireworks are ignited throughout the Ingleside District, so that we maintain peace, calm, and the quiet enjoyment of life for adults, children, and pets.

What: July 4th is prime time in the Ingleside Police District for illegal fireworks to be ignited between the hours of 5PM and 2AM. While 911 is the main number for emergencies in progress, including fires, serious injuries, and other criminal offenses, the non-emergency number, (415) 553-0123, had been the primary source of communication regarding fireworks complaints. This number has been inundated with calls regarding the sound of fireworks, making it harder for residents to contact police (and generate an effective response) when there is specific information regarding suspects and locations that are causing the biggest fireworks disturbances.

How: Emergency Dial: 911

 Non-Emergency Dial: (415) 553-0123

Operation Kaboom Dial: (415) 404-4052 when you can see and describe the suspect(s) at a certain location where illegal fireworks are being ignited. An SFPD PSA (Police Service Aide) will be staffing the line. Be prepared to provide the exact location and description of the subjects. The Operation Kaboom Task Force (OKTF) will have a small group of officers who will respond to specifically abate, admonish, and even arrest if the circumstance warrant. The OKTF may be delayed due to the volume of calls and may be needed if a shooting, riot, or other situation requiring an emergency police response occurs that takes precedence.

DMV Reminds Drivers of New Laws Taking Effect July 1

Sacramento – The Department of Motor Vehicles (DMV) reminds Californians about three laws designed to improve traffic safety that take effect July 1.

Private Carriers of Passengers ([SB 19, Hill](#)): This law transfers regulatory authority over the [Private Carrier of Passengers Program](#) from the California Public Utilities Commission to the DMV. A private carrier offers not-for-hire transportation services. Examples include a church bus and an employee shuttle. The DMV and the California Highway Patrol (CHP) will administer this program jointly. The DMV is responsible for issuing certificates for intrastate authority and verifying proof of liability insurance, while CHP regulates compliance and the safe operation of the vehicles. The purpose of the Private Carrier of Passengers program is to ensure that private carriers transporting passengers in California are operating in a safe manner and maintain adequate insurance coverage.


Buses and Seatbelts ([SB 20, Hill](#)): This law requires passengers in a bus equipped with seat belts to be properly restrained. Children between the ages of 8 and 15 traveling on a bus must wear a seat belt or be in an appropriate restraint that meets federal safety standards. A violation is punishable by a fine. Traveling by bus is overall a safe mode of transportation. The DMV is supportive of efforts to increase traffic safety, and this law contributes to reducing highway deaths and injuries as a result of large bus crashes by requiring the use of seatbelts on motor coaches and large buses, and requiring bus operators to inform passengers of the seatbelt requirement.

Driving Under the Influence (DUI) Passenger for Hire ([AB 2687, Achadjian](#)): This law prohibits a driver with a blood alcohol concentration (BAC) of 0.04 percent or more from transporting a passenger for hire. This lowers the legal limit from 0.08 to the same BAC standard for commercial drivers. The DMV wants to ensure the public understands drivers of passengers for hire will be held to a higher standard of safety while transporting people. The DMV will suspend a person's driver license if a conviction is added to their record. Commercial driver license holders will receive a disqualification.
