- **7. Resolution in support of Page Street Bikeway Improvement Pilot program** (*Resolution*) *JennChan*: The Page Street Bikeway Improvement Pilot program will be going for a vote before the SFMTA Board on November 19, 2019. The 18-month pilot is a much needed project that has been 4 + years in the making, and has strong support from Supervisor Brown. It also includes a protected downhill bike lane, reduced vehicle traffic and conflicts (prohibiting left-turns & westbound through-traffic at Octavia), and support for transit reliability on Haight Street.
- **8.** Reconsideration of CalTrain Bike Car Layout for Electric Trains (*Resolution*) *Shirley Johnson:* In yet another iteration of design by the Joint Powers Board, the layout continues to allow unacceptably minimal space for travelers to be able to sit within sight range of their bicycles, promoting bike theft and component theft. This resolution identifies the issue and possible mitigation.
