### **Public Comments -**

- Member of public: want to see minutes posted on the meetings.
- Jay Bane, D1 resident, before that was D5 resident for 20 years. Family of multi-modal transportation. Rides Muni, Jump bikes and drives daily. Docking stations seem to have a design that creates a lot of push back on the Ford Go bike station. D2 does seem to like Jump bikes and other dockless bike shares. A lot of time he sees bikes near Ocean beach and they run out of battery, need to have support in outer neighborhoods. Jump bikes extended geofencing to Outside Lands, there's ways to trial these sorts of electronic geofencing moving, for example on Sunday Streets days. D1 & D4 seem to be bikeshare deserts. Once they do get expanded out there, will need to be able to scale out the rebalancing.

SFPD is prioritizing safety as well Will get back to Kristin re data on dooring. California Street is Winston Parson's project to increase bike safety to add daylighting and infrastructure.</li> <li>D2: Not much to report. In the presidio a proposal to redo a historic base and is also a recreational route, the proposal has a lot of jobs attached to it, important to get a lot of traffic views on there to make sure the area remains bikeable.</li> <li>D3: Absent</li> <li>D4: Absent</li> <li>D5: Met with D5 office, SFMTA, SFBC and Jason Henderson. Discussed Page street improvements and I generated a crowdsourced list of quick fixes that can be implemented in D5. Areas include Webster traffic calming and possibly looking at ways to improve Hugo to/from Kezar. D5 office has a small amount of money available for fixes if necessary.</li> <li>D6: Polk street scape project is completed, looking forward to more improvements. Danielle Harris and team have had success with geofencing and events (like Outside Lands), also ongoing conversations with Chase Center and ORacle Park</li> </ul> </li> <li>Q: Do taxi drivers have same geofencing? <ul> <li>A: don't have info on that, but likely SFMTA has more of a say of where taxis can drop off/pick up</li> </ul> </li> <li>Q: Does SFMTA have any position on how electric scooters use public bike racks? <ul> <li>A: There's been a push to get more bike racks faster, but no additional resources yet to do so. They are also are asking the companies to add infrastructure since they are using SFMTA.</li> </ul> </li> <li>Q: Why is the expansion been slow for bike share to Richmond and Sunset neighborhoods? <ul> <li>A: A swe are move away from the central commercial areas, where it's easier to put in bike racks. Residential neighborhoods it's been more intense discussions. Will connect D1 with outreach people.</li> </ul> </li> </ul>

	<ul> <li>Howard Williams: Re the misuse of bike racks by the scooters: have seen bike racks completely taken over by scooters, have to lock around the scooter. Uber driver took pic of him accidentally knocking down a scooter that wasn't locked up. Feels that the city needs to be more accommodating to not corporate interests.</li> <li>Chair question: Do the racks that we use now also seen as scooter (and not only bike racks). It seems to D8 that the corporate sponsors of scooters should be responsible for building infrastructure.</li> <li>Comment: we are all allies here in that scooters and bikes both are car free transportation solutions, we need to figure out how to get along.</li> </ul>

## 7. Bike lanes with insufficient distance from parked cars (Resolution) Bert Hill

- Jennifer Chan: Project that SFMTA was working on to build a dataset of this information, but need to follow up with how far he got on that dataset.
- Chairman: First choice is to take out the parking. Second choice is to remove bike lanes in the door zone.
- D2 & D8: Want to talk about improving bike lanes that address the door zone we need to make the infrastructure more obvious.
- We will put this resolution off until next month.
- Howard Williams public comment: like other bike messengers was skeptical about bike lanes in the beginning, notices that they keep moving cars away from him while he is riding his bike. Dooring is less of a threat to him than moving bike lanes. Don't want to lose the bike lanes we have, please improve them.

## 8. SFPD Police Bicycle Traffic Enforcement in Urban Core (Resolution) Bert Hill:

- Will need to put it off until next month, police rep is not here.
- See if he can get a group consensus, an application for a grant for office for public safety to get a certain number of police on electric bicycles. Also shows the public/SFPD that bicycles are not an inferior method of transportation.
- Over a dozen cities do this already as part of traffic enforcement.
